#### RACE COMMENTS

#### Race 1 CENTRALINES MAIDEN 2100

**MALFURION** (H Schofer) - Slow away. Lay out under pressure over the concluding stages.

BRIAR (J Kamaruddin) - Began awkwardly.

**THE MAMMOTH** (W Kennedy) - Over-raced when being restrained to take cover passing the winning post on the first occasion.

**UNFASTEN** (K Hercock) - Performed below market expectations. When questioned rider advised the mare had little left in the run home after being taken on through the middle stages when leading and was not suited to today's track conditions.

**J Riddell** (WILEWINK) - Admitted a charge in that he struck his mount WILEWINK 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

#### Race 2 FARMERS TRANSPOR/HATUMA LIME 3YO MAIDEN 1300

**BELLANO** (L Allpress) - Slow away. Lay in under pressure over the concluding stages. When questioned into performance of BELLANO, rider could offer no excuse.

MR BULLY TEA (W Kennedy) - Slow away.

**KEENASABEAN** (V Colgan) - Restrained from a wide draw. Improved on to heels, having to be steadied near the 800 metres.

**SAGACIOUS** (A Goindasamy) - Raced greenly in the home straight.

**Co-Trainers S&K Alexander** were issued with a warning for presenting their runner ASTERIAL in unnotified gear (prerace ear covers).

**J Riddell** – Fined \$200 under the Minor Infringement Schedule after failing to make the required weight for ROCKBURN, being replaced by D Turner.

#### Race 3 BAYLEYS/BEST TRAVEL MAIDEN 1400

**ASPERITAS** (J Kamaruddin) - Charged the gates and after being removed from its barrier to undergo pre-race veterinary examination was cleared to start. When questioned into performance rider advised the gelding had failed to handle today's track conditions.

**GRAEME JOHN** (K Asano) - Slow away. Raced wide for the majority of the event.

**CHANCE** (D Turner) - Slow away. When questioned into performance rider advised the gelding had failed to handle today's track conditions.

**ROADSTER** (J Riddell) - Raced wide in the early stages.

**RAVENNA ROSE** (M Hudson) - Raced greenly through the early stages of the home straight and then held up until inside the final 100 metres.

**PERFECT POSY** (L Douglas) - Held up entering the home straight.

ASTRON (C Grylls) - Held up in the home straight until inside the final 150 metres.

**RED QUEST** (W Pinn) - Raced greenly entering the home straight, bumping VICTORIAN CHARM.

VICTORIAN CHARM (V Colgan) - Bumped on home turn.

## Race 4 AWASSI HANDICAP 1200

**DIMAGGIO** (V Colgan) - Hampered at the start when runners either side shifted ground.

**PERFECTSISTER** (A Goindasamy) - Slow away. Improved on to heels having to be steadied passing the 700 metres. Held up throughout the home straight going to the line without being fully tested.

**THE STONEY ONE** (L Sutherland) - Over-raced through the early and middle stages. Held up early in home straight, gaining clear racing room passing the 200 metres.

BRITISH ROYALTY (S O'Malley) - Lost the near front plate during the running.

#### Race 5 GROUND WORKS PLUS LTD CHB CUP 1200

**GEEZAS GEORGE** (L Kauri) - Underwent and passed a pre-race veterinary examination after losing a plate and suffering minor abrasions enroute to the course.

**CADEAU** (C Grylls) - Began awkwardly, bumping ROCONONO.

**ROCONONO** (V Colgan) - Bumped at the start. Performed below market expectations. When questioned rider could offer no excuse.

**NO TIME TO JAZZ** (K Hercock) - Rider reported she felt there was something amiss with the mare. A post-race veterinary examination did not reveal any obvious abnormality.

MAISON ROXANNE (L Sutherland) - Lost the off-front plate during the running.

**M Hudson** – Fined \$100 under the Minor Infringement Schedule after failing to make the required weight for HYDROEXPRESS, being replaced by C Barnes.

Track downgraded to Heavy 8 following Race 5 following a heavy shower.

## Race 6 CHB RAM BREEDERS MAIDEN 1600

SHE'S PATSY (S O'Malley) - Slow away. Over-raced, having to be steadied passing the 1200 metres.

**LADY HIKA** (W Kennedy) - Began awkwardly then over-raced, having to be steadied shortly after the start. Rider reported the mare had hung throughout.

ZACKERY (H Schofer) - Over-raced, having to be steadied passing the 1200 metres.

SECRET FALLS (M Hudson) - Over-raced having to be steadied passing the 900 metres.

THE BELVOIR (J Ridell) - Held up rounding the home turn.

**MOONLIGHT HUSTLER** (K Hercock) - Raced wide without cover throughout. Lay inwards having to be straightened passing the 200 metres.

**SCRIPT** (L Sutherland) - Raced four wide without cover throughout.

**C'MON EILEEN** (T Taiaroa) - Lay inwards under pressure over the concluding stages.

**TIDAL FORCE** (V Colgan) - When questioned into performance rider advised the gelding had failed to handle today's track conditions.

## Race 7 AFFCO NZ LTD WAIPUKURAU CUP 1600

**LILY LAGUNA** (S O'Malley) - Slow to begin. When questioned into the improved performance of LILY LAGUNA, Trainer J Bary had no explanation, and the win was unexpected.

**FARRENC** (K Hercock) - Over-raced shortly after the start when being restrained to take cover. Continued to over-race through the middle stages.

**SCUTAR** (M Hudson) - Over-raced briefly passing the 1400 metres.

**BLISSFUL BELLE** (W Kennedy) - Raced wide without cover throughout. Shifted in near the 200 metres hampering ONE DREAM ONE SOUL.

**ONE DREAM ONE SOUL** (A Mudhoo) - Awkwardly placed to the inside of BLISSFUL BELLE (W Kennedy) which shifted in slightly near the 200 metres, having to be steadied.

**W Kennedy** (BLISSFUL BELLE) - Issued with a warning after permitting BLISSFUL BELLE to shift inwards slightly when not sufficiently clear of ONE DREAM ONE SOUL which was steadied near the 200 metres.

# Race 8 CR GRACE LTD HANDICAP 1600

**RED 'N' SURF** (C Barnes) - Slow away.

**HESACITIBOY** (A Mudhoo) - Raced wide throughout. Lay in under pressure over the concluding stages.

**RIP WHEELER** (J Riddell) - Performed below market expectations. When questioned rider advised the gelding had not handled today's track conditions and lay in under pressure in the final straight. Underwent a post-race veterinary examination did not reveal any obvious abnormality.

**T Taiaroa** (CANUCIA) - Admitted a charge in that she struck her mount CANUCIA 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing today, 13 November, until the conclusion of racing on Thursday, 24 November, 7 national riding days.

**W Pinn** - Stood down following Race 8 (unwell) and is required to provide a medical clearance prior to riding next.

# Race 9 THANKS MICHAEL ORMSBY-JOHN FRIZZELL-PETER EVANS OPEN 1600

**TELLALL** (V Colgan) - Late scratching at 3.03pm due to downgrade in track conditions.

**PLATINUM INVADOR** (L Allpress) - Very slow away (3L). Held up entering the home straight, having to change ground inwards across heels to obtain clear racing room passing the 250 metres.

HUNTA PENCE (H Schofer) - Over-raced briefly shortly after the start.

**TAMAHINE** (K Asano) - Raced four wide without cover throughout.

KELLY COE (C Grylls) - Raced three wide through the middle stages.

**LANGKAWI** (S McKay) - Lay out rounding the final bend. When questioned into performance rider advised the gelding had failed to handle today's track conditions.

#### Race 10 WAIPUKURAU TRAINERS OPEN 1200

**SERGIO** – C Grylls replaced W Pinn (injured).

PULL NO PUNCHES (L Allpress) - Hampered at the start when runners either side shifted ground.

LOVE FOR ALL (K Hercock) - Began awkwardly.

CAVALLO VELOCE (S McKay) - Began awkwardly.

**KAPINOS** (T Taiaroa) - Rider reported she felt there was something amiss with the gelding over the latter stages of the event. A post-race veterinary examination revealed lameness in the left front leg with a veterinary clearance being required prior to racing again.
