### RACE COMMENTS

#### Race 1 CLASSIC BUILDERS MAIDEN 1950

**TEXT REGRETS** (W Pinn) - Became fractious in its barrier and was removed to undergo a veterinary examination before being late scratched at 12:07 p.m. Connections were advised that the gelding would be required to trial to the satisfaction of Stewards prior to racing next.

**BUBBAJOCK** (W Kennedy) - Slow to begin then crowded shortly after losing ground.

**UHTRED** (B Rogerson) - Knuckled on jumping away.

**SHADOW BOXER** (K Asano) - Made the bend near the 1450 metres awkwardly forcing DAYDREAM BELIEVER wider. also hampered as a result was BRICKIE'S MOJO. Raced greenly when placed under pressure in the final straight.

**DAYDREAM BELIEVER** (M Hashizume) – Forced wider passing the 1400 metres then was obliged to race wide without cover until near the 1000 metres.

**BRICKIE'S MOJO** (S Spratt) – Hampered passing the 1450 metres. Raced wide without cover for the majority of the race.

**WHISKY MAC** (J Riddell) - Raced keenly for a distance passing the 1450 metres.

**TAVIVIKI** (M Kareem) - Held up until near the 100 metres.

**J Doyle** (BUCCHERI) - Spoken to with regards to his whip action in a manner which raised the rider's arm above shoulder height.

**J Doyle** (BUCCHERI) - Admitted a charge in that he struck his mount seven times prior to the 100 metre mark with the Adjudicator imposing a fine of \$250.

<b>Race 2</b>	<b>WAITOMO FUELS 1400</b>

**SAGAN** (W Kennedy) - Began awkwardly.

**LANDRY** (J Riddell) – Raced three wide without cover throughout.

**CHARLOTTE AMALIE** (L Satherley) - Over-raced through the early and middle stages.

**JIMMY KIRK** (M Hashizume) - Commenced to give ground passing the 600 metres. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**COLLATERAL DAMAGE** (V Colgan) - When questioned regarding the performance the rider advised that the colt had failed to handle today's track conditions.

<b>Race 3</b>	<b>RYDGES ROTORUA MAIDEN 1230</b>

**ROC ON HOME** (E Bragg) - Slow to begin. Raced greenly in the early and middle stages.

**EXCELLERINA** (C Grylls) - Began awkwardly.

**PAUL DAVID** (C Zackey) - Crowded shortly after the start having to be steadied.

**HUGS** (T Thornton) – Raced wide throughout.

**MISTER ROSHAN** (W Pinn) – Raced three wide without cover throughout.

**LUCIENNE** (J Kamaruddin) - Steadied when placed in restricted room approaching the 200 metres when runners either side shifted ground slightly.

<b>Race 4</b>	<b>ATKINSON AND DONALDSON PLUMBERS MAIDEN 1560</b>

**GOLDEN KIWI** (J Doyle) - Began awkwardly losing ground.

**MR FANTASTIC** (V Colgan) – Over-raced in the early stages.

**HOLY ORANGE** (A Lawson-Carroll) - Raced keenly in the middle stages.

**OVER THE MOON** (E Bragg) - Raced wide throughout.

**LOOSE CHOICE** (S Spratt) - Raced wide without cover throughout. Steadied when placed in restricted room passing the 500 metres.

**VEE ROD** (W Pinn) - Lay out when placed under pressure in the final straight with the rider having to straighten his mount over the concluding stages.

**LOUISIANA MAN** (J Riddell) - When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**A Lawson-Carroll** (HOLY ORANGE) - Issued with a warning after permitting his mount to shift outwards when not sufficiently clear of LOOSE CHOICE which had to be steadied when placed in restricted room passing the 500 metres. When assessing the incident, video footage proved inconclusive.

<b>Race 5</b>	<b>ROTORUA ITM MAIDEN 1560</b>

**CONFIDENTIAL** (T Davies) - Slow to begin.

**MAGICAL ROAD** (M Hashizume) - Raced wide without cover throughout. Came together with HUTSON approaching the 100 metres when both runners shifted ground.

**HUTSON** (B Rogerson) - Had to be restrained approaching the 1200 metres. Came together with MAGICAL ROAD approaching the 100 metres when both runners shifted ground.

**B Rogerson** (HUTSON) - Reminded of her obligations in that she must ride her mounts out fully to the end of the race when circumstances permit her to do so.

<b>Race 6</b>	<b>CAMPBELL INFRASTRUCTURE 1560</b>

**BOOMER** (W Kennedy) - Had to be steadied shortly after the start when VADAMOS STAR jumped inwards and FLIGHT PLAN jumped outwards, which resulted in BOOMER losing ground.

**VADAMOS STAR** (C Zackey) – Raced greenly when placed under pressure in the final straight.

**CHAMPAGNES ON ME** (V Colgan) - When questioned regarding the performance the rider advised that after racing keenly throughout the mare had failed to respond when placed under pressure, adding that in his opinion CHAMPAGNES ON ME had failed to handle today's track conditions.

<b>Race 7</b>	<b>ISCL MAIDEN 1230</b>

**AGHANIM** (R Elliot) – Began awkwardly then restrained in the early stages. Dictated wider entering the final straight.

**THE WOMAN KING** (T Newman) - Began awkwardly. Crowded having to be checked passing the 200 metres.

**MARUSYA** (C Lammas) – Raced wide without cover throughout.

**CHOPPER REED** (J Riddell) - Had some difficulty obtaining clear running passing the 300 metres.

**ELUSIVE NATION** (J Doyle) - Shifted outwards when placed under pressure passing the 150 metres.

**C Lammas** (MATUSYA) - Admitted a charge of careless riding in that he angled his mount outwards when not sufficiently clear of AGHANIM which was forced outwards crowding THE WOMAN KING which had to be checked passing the 200 metres. After considering submissions the Adjudicator imposed a suspension of C Lammas' licence to ride in races from the conclusion of racing on Thursday 24 November up to and including racing on Thursday 1 December, 5 national riding days.

**Race 8** | **LANCE LAWSON MAIDEN 1400**

**THELASTINVINCIBLE** (E Bragg) - Restrained shortly after the start. Raced wide through the middle stages.

**WILLIAM** (C Lammas) - Over-raced in the early and middle stages.

**MISAPPROPRIATE** (S Spratt) - Raced wide without cover in the early stages. Improved onto heels passing the 400 metres having to be steadied.

**ALBY PARK** (T Thornton) - Raced keenly through the middle stages.

**TOE TAPPING** (B Rogerson) – Over-raced in the middle stages.

**Race 9** | **NZB INSURANCE PEARL SERIES MAIDEN RACE 1400**

**RUSSIAN SATIRE** (W Pinn) - Connections were advised that a warning would be placed against the filly's barrier manners.

**STRANGE LOVE** (S McKay) - Began awkwardly losing ground. Lay in when placed under pressure in the final straight with the rider being unable to fully ride the mare out over the concluding stages.

**FRANNI CACCINI** (M Sanson) - Slow to begin.

**COM SI COM SA** (T Abel) – Raced wide without cover in the early stages.

**ANNIE** (T Thornton) – Over-raced in the early stages. When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**CADA CAMINO** (B Rogerson) – Raced wide throughout.

**Race 10** | **HAVE YOUR FUNCTION AT "ARAWA PARK" MAIDEN 1400**

**TIZ LOUIE** (C Zackey) - Began awkwardly. Raced keenly in the early and middle stages.

**KIVA HAN** (R Beemud) – Over-raced through the early and middle stages. When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

**ZAKAYA** (J Kamaruddin) – Over-raced in the early stages. Lay out when placed under pressure over the concluding stages.

**LUCKY SIMON** (C Barnes) - When questioned regarding the performance the rider advised that the gelding had been disappointing. Underwent a post-race veterinary examination which did not reveal any abnormality.

**KINDRA GIRL** (M Cropp) - Had to shift inwards after improving onto heels passing the 50 metres.

Following the running of this race connections of the 3<sup>rd</sup> placed runner KINDRA GIRL viewed Stewards footage before electing not to proceed with a protest.
