RACE COMMENTS				
Race 1	NOT LONG TO GO NOW UNTIL THE BIGGEST (2215m)			
KITTY POWER (B May) - Crowded leaving the barriers when PANDDE jumped inwards.				

REDGUM (W Papier) - Got its head up when being restrained in the early stages.

SUTHERLAND (K Mudhoo) - Over raced in the early to middle stages on a slow tempo. Crowded and had to be restrained passing the 75 metres.

PETE THE DRIVER (R Mudhoo) - Lay out throughout the running and made the bend near the 800 metres awkwardly, shifting wider on the track. Trainer K Tyler advised Stewards that he would be getting the gelding assessed on return to the home stable and would not be returning to the racetrack until he was entirely satisfied with the horse.

W Papier (REDGUM) - Issued with a warning for allowing REDGUM to shift ground outwards under pressure crowding SUTHERLAND which had to be steadied passing the 75 metres. In taking this course of action Stewards took into account some contributing movement from KITTY POWER which shifted inwards under pressure.

Race 2

SOCIAL RACE DAY THAT SOUTHLAND EXPERIENCES (1200m)

J Gordon (RIPNROLL) – Admitted a charge under Rule 616(4) in that she presented this gelding without the notified visor blinkers and was fined \$50 under the Minor Infringement Schedule.

M House (LINCOLN HILLS) – Issued with a warning for presenting this gelding without the notified blinkers.

RIPNROLL (K Mudhoo) - Slow away.

CLASSIC DIVA (K Williams) - Slow away. Held up throughout the run home and went to the line untested by its rider.

LINCOLN HILLS (C Johnson) - Raced wide without cover throughout. Crowded near the 150 metres when tiring and gave ground over the concluding stages to finish in a distant last placing. Stewards spoke with rider C Johnson regarding his apparent lack of vigour with Mr Johnson advising that the gelding had been under pressure prior to the home turn after having to race wide throughout and he felt he was a beaten runner at that point. Stewards reminded Mr Johnson of his obligation to ensure he rides his mounts in a manner that does not leave him open to question. A post-race Veterinary examination revealed no obvious abnormalities.

FIERY RED (L Callaway) - Held up rounding the final bend and in the run home only gaining clear racing room inside the final 75 metres.

HENRY HUBBER (D Montes de Oca) - Lay inwards under pressure passing the 150 metres crowding inside runners. D Montes de Oca was advised he must straighten his mounts sooner than he did on this occasion.

FATHER LENIHAN (J Laking) - Briefly placed in restricted room passing the 150 metres.

Race 3 CHRISTMAS AT THE RACES @ ASCOT PARK – DEC 10 MDN (1200m)

J Burrows (ON MY SHOULDERS) - Admitted a charge under Rule 616(2) in that she presented this gelding to race in ear covers which were not notified and was fined \$100 under the Minor Infringement Schedule.

FIRE 'N REIGN (L Callaway) - Slow away.

SACRED DAME (R Mudhoo) - Jumped away awkwardly losing ground.

PROBELLA (D Montes de Oca) - Raced three wide without cover and made the bend near the 800 metres awkwardly, running wide hampering POPPIES BOY. D Montes de Oca was spoken to advisedly and reminded of his obligations to ride his mounts out fully to the finish when there is a chance of finishing in a higher placing.

WILLIS (C Johnson) - Over raced in the middle stages. Shifted inwards in the run home making contact with CLARK KENT on at least two occasions.

POPPIES BOY (K Mudhoo) - Raced wide without cover being further hampered when forced over extra ground passing the 800 metres.

CLARK KENT (T Moseley) - Raced in restricted room to the inside of WILLIS for much of the final straight making contact with that runner on at least two occasions. Prior to the authorisation of dividends rider T Moseley viewed Stewards films before electing not to proceed with a Protest.

C Johnson (WILLIS) - Issued with a warning for allowing WILLIS to shift inwards in the run home contacting CLARK KENT on two occasions.

Race 4

24 DAYS TO GO – THINGS TO REMEMBER (1200m)

CROP (S Toolooa) - Escaped riderless for some distance before being caught. Declared a late scratching by order of Stewards at 2.47pm. Due to this incident there was a delay to the start of this race.

GLADROY (K Williams) - Blundered leaving the barriers.

PLAY THE FIELD (G Jogoo) - Blundered leaving the barriers.

THE BOOGEYMAN (C Johnson) - Jumped away awkwardly.

ADIKTIV PASSION (T Moseley) - Jumped away awkwardly losing ground. Had some difficulty obtaining clear running early in the run home until shifting ground inwards near the 175 metres. Crowded in the shadows of the post.

WAIMATE BILL (K Kalychurun) - Slow away.

SACRED KITTY (K Selvan) - Raced wide throughout.

OUR CLARRY (Y Atchamah) - Inclined to shift ground outwards in the run home and then shifted inwards over the concluding stages crowding inside runners. Y Atchamah was advised to exercise greater care when shifting ground and straighten his mounts sooner than he did on this occasion.

HE'S MI BROTHER (L Callaway) - Crowded and had to steady in the shadows of the post.

Race 5 T-REX RACE REGISTRATION CLOSES NOV 30 MDN (1400m)

NIPPY THE HIPPY (S Toolooa) - Raced wide in the early stages when being ridden forward to reach the lead and shift to a position closer to the running rail near the 700 metres. Lay out badly on the final bend, shifting wider on the track crowding outside runners. Connections were advised that the mare was stood down to barrier trial to the Stewards satisfaction prior to racing next. When questioned regarding his tactics rider advised that he had been instructed to lead, so after initially being slow to leave the barriers he pressed forward in an attempt to make the lead, then after being trapped wide racing into the first bend he believed it was in the horse's best interest to continue on to the lead and attempt to give it some respite once in front. Trainer S Gye advised NIPPY THE HIPPY would no longer be persevered with as a racing proposition from her stable.

THE DUDE (D Montes de Oca) - Lay out rounding the final bend. Inclined to shift ground throughout the final straight and had to be shifted out passing the 100 metres when briefly held up. D Montes de Oca was spoken to advisedly regarding his use of the whip for one strike when he raised his arm marginally above shoulder height.

MOROCCO MISS (R Mudhoo) - Placed in restricted room passing the 300 metres and had to be severely restrained when tiring after becoming awkwardly placed when inside runners had been dictated outwards and when being restrained, clipped a heel and blundered briefly having to be further restrained.

RIVIERA ROSE (T Moseley) - Finished in a distant last placing. Rider reported that the mare had been under pressure passing the 500 metres however failed to respond to his riding and had been very disappointing. Trainer G Eade advised RIVIERA ROSE would no longer be persevered with as a racing proposition from his stable.

WILLIAM JOHN (G Jogoo) - Dictated wider on the home bend.

Race 6 MASSIVE FASHIONS IN THE FIELD HANDICAP (1600m)

SO MUCH MOUR (Y Atchamah) - Underwent a pre-race Veterinary inspection after being kicked behind the barriers and was cleared to race. Over raced in the early stages. Held up rounding the final bend.

THE GROWLER (T Moseley) - Slow away with the rider reporting the gelding had been slightly disappointing however added it was not entirely suited by the mixed tempo of today's race.

CASTLE ON THE HILL (W Papier) - Over raced in the early stages and raced wide without cover throughout.

TAKE THE DEEL (G Jogoo) - Over raced in the early to middle stages before being allowed to improve forward passing the 800 metres.

Race 7 GREAT LIVE BANDS & DJ'S IN 3 DIFFERENT AREAS MDN (1600m)

THE LAST THYME (K Williams) - Escaped riderless for a short distance before being caught. Underwent a pre-race Veterinary inspection and was cleared to start.

REINEDELARIVIERE (K Mudhoo) - Slow away. Began to over race shortly after the start and near the 1400 metres improved quickly on to the heels of SHAKIB, clipping a heel and blundering. Continued to over race through the early stages.

WHILE YOU'RE THERE (T Moseley) - Raced wide in the early stages before improving forward to sit outside the leader.

LAST TRY (D Montes de Oca) - Raced wide without cover for the majority of the event.

Race 8 SEE YA THERE – DON'T BE LATE (1600m)

GERRY JOYCE (K Selvan) - Slow away. Steadied when improving on to heels near the 1000 metres.

GABBY DIAZ (Y Atchamah) - Slow away. Improved wide from the 800 metres.

LEAVE IT TO ME (G Jogoo) - Crowded shortly after the start losing ground.

GINTYS GIRL (L Callaway) - Raced wide without cover through the early to middle stages.

LA OPCION (D Montes de Oca) - Raced wide without cover from the 800 metres.

COUNTRY BOY (S Muniandy) - Lost the off-fore racing plate during the running.
