GENERAL

R Elliot advised on race morning that he would not be attending the meeting as he was unwell and is now required to provide a medical clearance prior to riding next.

EL VENCEDOR (W Pinn) – Stable Foreman R Mildon advised Stewards the stable was satisfied with the post-race condition of the gelding, and it is the stables intention to continue on with EL VENCEDOR'S current preparation.

Race 9 BOOTHS TRANSPORT LIMITED HANDICAP 1600

AURORA DOLCE (C Lammas) – Co-trainer P Gerard reported to Stewards she was satisfied with the post-race condition of the mare, and at this stage it is her intention to carry on with AURORA DOLCE'S current preparation. P Gerard further advised the mare may have got her tongue over the bit during the running.

RACE COMMENTS**Race 1 ELLERSLIE EVENT CENTRE MAIDEN 1200**

SUCH IS LIFE (T Newman) – Began awkwardly making heavy contact with COPPERS.

COPPERS (J Kamaruddin) – Severely checked shortly after the start losing ground.

GAME DUKE (J Riddell) – Slow to begin.

DUSTY ROAD (J Doyle) – Raced wide without cover throughout. Was inclined to shift ground under pressure in the straight. Struck on the head by the whip of V Colgan (LASHANA) near the 50 metres.

READY EDDIE GO (L Satherley) - Raced three wide without cover. Made the final turn awkwardly. Crowded when weakening approaching the 150 metres making contact with SUCH IS LIFE.

BURGUNDY IFF (M Hashizume) - Became badly unbalanced when making contact with the running rail after being placed in restricted room near the 500 metres to the inside of TRAMONTO which had READY EDDIE GO racing tight to its outside with READY EDDIE GO then laying in before being immediately corrected by its rider. BURGUNDY IFF lost ground in this incident going back onto ARCEUS which was hampered having to be checked to avoid the heels of BURGUNDY IFF and shifting outwards forcing GAME DUKE wider on the track. L Satherley was advised to exercise care with Stewards being satisfied on this occasion she had taken immediate corrective measures.

TRAMONTO (K Asano) - Placed in restricted room near the 500 metres.

ARCEUS (C Grylls) - Checked to avoid heels when hampered near the 500 metres. Crowded approaching the 150 metres.

BLUE SKY AT NIGHT (A Goindasamy) - Held up approaching the 400 metres and did not obtain clear running until shifting outwards across heels passing the 200 metres.

SUCH IS LIFE (T Newman) - Contacted and unbalanced when crowded approaching the 150 metres.

A Goindasamy (BLUE SKY AT NIGHT) - Admitted a charge of careless riding after permitting his mount to shift outwards approaching the 150 metres when not sufficiently clear crowding ARCEUS onto READY EDDIE GO. After

considering submissions the Adjudicative Committee imposed a suspension of A Goindasamy's licence to ride in races from the conclusion of racing on Saturday 26 November up to and including racing on Wednesday 7 December, 6 national riding days.

Race 2 | **FRANKLIN LONG ROOFING 1200**

DON'T LOOK ETHEL (C Barnes) – Began awkwardly. Raced wide in the early and middle stages without cover.

EXTORTION (J Riddell) – Began awkwardly. Hampered near the 200 metres.

MADAME LE FAY (C Grylls) - Began awkwardly.

GWEN'S DAUGHTER (A Goindasamy) - Had difficulty obtaining clear running early in the final straight.

FLAMEBIRD (W Kennedy) - Contacted near the 450 metres when FLIP 'N' EASY shifted outwards to obtain clear running. When questioned regarding performance rider advised that after becoming unbalanced when contacted rounding the final turn, the filly had failed to recover and further added that the filly had not felt entirely comfortable in today's track conditions.

LANEWAY FLIRTING (W Pinn) – Was inclined to lay outwards under pressure in the straight having to be corrected by its rider on a number of occasions hampering EXTORTION near the 200 metres.

Race 3 | **BARFOOT & THOMPSON CHALLENGE STAKES 1100 (Listed Race)**

ORGULLO (L Satherley) - Restrained to the rear shortly after the start. Raced keenly in the middle stages.

LUBERON (W Kennedy) – Blundered leaving the barriers. Briefly steadied when placed in restricted room shortly after the start. When questioned regarding performance rider advised that the filly had never travelled comfortably in today's track conditions.

ETHEREAL STAR (W Pinn) – Made contact with CYCLONIC KING leaving the barriers. Raced wide without cover throughout.

CYCLONIC KING (C Grylls) – Made contact with ETHEREAL STAR leaving the barriers.

BALANCE OF POWER (C Zackey) – Raced greenly in the home straight shifting outwards abruptly approaching the 200 metres.

VILA BELMIRO (S Spratt) – Rider reported that the gelding had raced greenly throughout. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

S Spratt (VILA BELMIRO) – Reminded of her obligation to ride her mounts out fully to the finish, with Stewards on this occasion being satisfied that it had not compromised her finishing position.

Race 4 | **DUNSTAN HORSE FEEDS 1600**

WEOWNA TIGER (M Sanson) - Slow to begin. Brushed the running rail near the 1000 metres when racing keenly. When questioned regarding performance rider advised that after a poor beginning, she had got further back than intended but had nevertheless been disappointed that the gelding had not finished the race off in better fashion. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

MOLLYS GAME (M Hashizume) – Made contact with RANGER shortly after the start.

RANGER (L Satherley) – Made contact with MOLLYS GAME shortly after the start.

LIL RED'EYEDHOOD (E Bragg) – Raced keenly in the early stages. Lay out and away from BAHIA EMERALD near the 300 metres making contact with EL BANDOLERO. Continued to lay out for the remainder of the race making further contact with EL BANDOLERO on a number of occasions. Rider E Bragg reported that the mare appeared to be in season.

BRECKON POWER (W Pinn) – Raced wide without cover throughout.

TRUST IN YOU (C Zackey) – Held up for the majority of the final straight.

EL BANDOLERO (T Thornton) – Contacted on a number of occasions inside the final 300 metres.

T Thornton (EL BANDOLERO) - Admitted a charge in that she struck her mount EL BANDOLERO six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

Race 5 | **HR FISKEN & SONS 1600**

THE LETTER (T Abel) - Began awkwardly. Raced wide in the early stages until near the 1000 metres. When questioned regarding performance rider advised that the mare had failed to respond once placed under pressure and had been disappointing adding that in her opinion it may be feeling the effects of recent racing. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

MARCHAND (W Kennedy) – Slow to begin. Made contact with MANRICO when improving into a tight run to the inside of THE LETTER which shifted inwards when weakening passing the 250 metres.

JUST DANCE (V Colgan) – Restrained to the rear shortly after the start. Lost the right front plate near the 1050 metres. Had some difficulty obtaining clear running in the straight until passing the 300 metres.

BLUE MOON (W Pinn) – Raced keenly in the middle stages.

MANRICO (E Bragg) – Contacted passing the 250 metres.

Race 6 | **VERNON & VAZEY 2100**

HULA BEAT (C Zackey) - Began awkwardly. Inconvenienced near the 50 metres when AQUACADE lay out under pressure.

WHEAO (J Doyle) – Made contact with MARGARET JEAN shortly after the start. Inclined to over-race in the early stages when being restrained. Raced wide in the back straight.

MARGART JEAN (V Colgan) – Made contact with WHEAO shortly after the start. Raced wide throughout.

AMAZING GRACE (C Grylls) - Raced keenly in the early stages. When questioned regarding performance rider advised that in his opinion the mare may be feeling the effects of recent racing. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

SUPER SID (J Kamaruddin) – Raced keenly in the early and middle stages.

ARJAY'S FLIGHT (T Thornton) – Raced in restricted room rounding the final turn.

CANHEROC (M Sanson) – Held up rounding the final turn and early in the straight.

W Kennedy (AQUACADE) - Admitted a charge in that he struck his mount AQUACADE seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$400.

Following the race, the rider the 2nd placed horse HULA BEAT lodged a protest alleging interference over the concluding stages by the winner AQUACADE. After considering submissions and viewing films the Adjudicative Committee dismissed the protest with the placings standing 1st AQUACADE, 2nd HULA BEAT, 3rd WHEAO, 4th YOULEDO.

Following this race, the track was upgraded to Heavy 8.

Race 7 PREMIER HORSE TRANSPORT 1400

DUBAI DIVA (W Pinn) – Jumped inwards shortly after the start making contact with BELDARRA.

BELDARRA (W Kennedy) – Contacted shortly after the start by DUBAI DIVA. Rider reported that the mare had failed to handle today's track conditions.

SAINT ALICE (C Zackey) - Began awkwardly.

ZAILA (S Spratt) - Raced wide in the early stages.

IMPRESA (K Asano) – Lay out under pressure in the straight.

LOOKSEASY (A Goindasamy) – Rider dropped his whip near the 200 metres.

SOPHISTICARDO (J Kamaruddin) – Eased down over the concluding stages with the rider reporting that the gelding had felt indifferent in its action. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

Race 8 HAUNUI FARM COUNTIES BOWL 1100 (G3)

BABYLON BERLIN (J Riddell) - Knuckled leaving the barriers dislodging its rider. J Riddell was uninjured.

IS THAT SO (S Spratt) - Shifted outwards shortly after the start making contact with SACRED SATONO.

SACRED SATONO (C Zackey) – Contacted by IS THAT SO shortly after the start. Raced keenly in the early stages.

THAT'S ALL FINE (T Thornton) – Contacted shortly after the start by SACRED SATONO. Raced wide from the middle stages to the winning post.

LETZBEGLAM (W Kennedy) – Shifted ground approaching the 200 metres when inconvenienced by the riderless horse.

C Zackey (SACRED SATONO) - Admitted a charge in that he struck his mount SACRED SATONO eight times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of C Zackey's licence to ride in races from the conclusion of racing on Saturday 26 November up to and including racing on Wednesday 7 December, 6 national riding days and in addition imposed a fine of \$500.

Race 9 DUNSTAN FEEDS AUCKLAND THOROUGHBRED BREEDERS' STAKES 1400 (G2)

SLAVE TO LOVE (W Kennedy) – Raced three wide without cover for the majority of the race.

OSELETA (V Colgan) – Jumped away awkwardly making contact with MISS CARTIER losing ground. Had difficulty obtaining clear running in the straight until passing the 200 metres.

MISS CARTIER (C Grylls) – Made contact with OSELETA shortly after the start.

DARCI LA BELLA (J Riddell) – Held up early in the straight then being steadied off the heels of SLAVE TO LOVE which was being taken out by LA BELLA BEALS near the 450 metres and in doing so hampered MALT TIME.

MALT TIME (M Hashizume) – Hampered near the 450 metres with the saddle then shifting forward early in the straight inconveniencing its rider for the remainder of the race.

THE PERFECT PINK (C Zackey) - When questioned regarding performance the rider advised that the mare had never travelled well and had been very disappointing. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

LA BELLA BEALS (W Pinn) - When questioned regarding performance the rider advised that the mare had travelled well but had failed to respond once placed under pressure and had been very disappointing. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

V Colgan (OSELETA) - Admitted a charge in that he struck his mount OSELETA six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

CHERRY LANE (T Newman) – Began awkwardly making contact with RAPID FALLS.

RAPID FALLS (C Zackey) – Contacted by CHERRY LANE shortly after the start.

NO LOITERING (J Doyle) – Began awkwardly making contact with THE MAYOR.

THE MAYOR (C Lammas) - Contacted by NO LOITERING shortly after the start.

AROMATIC (C Grylls) – Began awkwardly making contact with OSAKA.

OSAKA (W Pinn) - Contacted by AROMATIC at the start.

ZEE FALLS (W Kennedy) - Began awkwardly. Raced wide without cover throughout.

SELF OBSESSION (V Colgan) – Was inclined to shift out under pressure over the concluding stages.

LE SABLIER (A Goindasamy) – Made contact with VIKTOR VEGAS when attempting to obtain clear running near the 350 metres.

VIKTOR VEGAS (K Asano) – Contacted near the 350 metres.

BELLE EN ROUGE (J Kamaruddin) – When questioned regarding performance rider advised that he had been disappointed with the mare’s effort and may not have been entirely suited by today’s track conditions. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

Following a period of heavy rain the track was downgraded to Heavy 10 retrospective to this race.

HOT SALSA (W Pinn) - Underwent a pre-race veterinary inspection at the barriers being passed fit to run.

IFFIN DOUBT DANCE (W Kennedy) - Slow to begin. Held up entering the final straight and continued to have difficulty obtaining clear running until near the 150 metres.

THE LANDING (V Colgan) – Began awkwardly. When questioned regarding performance rider advised that the gelding had never travelled well in today's track conditions.

LADY MAROAL (B Rogerson) – Was inclined to over-race in the early stages.

ENDEAN AFFAIR (C Grylls) – Raced wide throughout.

ELYSIAN FIELDS (S Spratt) – Raced wide throughout.

OUR TRISTABELLE (C Zackey) – Had some difficulty obtaining clear running early in the straight.

RUBYSHOWOFF (T Newman) - Held up passing the 450 metres until near the 250 metres.

J Kamaruddin (SHE'S OUTRAGEOUS) - Admitted a charge in that he struck his mount SHE'S OUTRAGEOUS six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.
