Race 2 HALLS REFRIGERATED TRANSPORT 3YO PREMIER 1400m

**DEPLOY (M McNab)** – Co-trainer Ms. K Williams advised Stewards, the stable was satisfied with the post-race condition of the filly, however, has now been sent for a spell.

**Race 5 RICcarton Park Function Centre Welcome Stakes 1000m (Listed Race)**

**NAVY LARK (S Wynne)** – Trainer Mr. P Harris reported to Stewards, that upon return to the stable NAVY LARK underwent a veterinary examination which revealed small lacerations to the off-hind hock. P Harris further advised the colt has been sent for a freshen up.

**Race 6 AMICUS Insurance Brokers Premier 1000m**

**HELLO MARY LOU (D Stackhouse)** – Trainer Mr. S Woodsford advised Stewards, HELLO MARY LOU, was showing signs of jarring up and as a result has been rested from exercise for the week. S Woodsford further advised, once the mare returns to trackwork it is his intention to continue on with HELLO MARY LOU'S current preparation.

**Canterbury Jockey Club at Riccarton Park, Saturday, 12 November 2022**

**Race 3 DAKINS Group Premier 2000m**

**HARMONIOUS (L Sutherland)** – Trainer Mr. A Bull reported to Stewards, he was satisfied with the post-race condition of the mare, however, has now been sent for a brief freshen up.

**Canterbury Jockey Club at Riccarton Park, Monday, 14 November 2022**

**Race 8 MARTIN COLLINS 159th New Zealand Cup (G3) 3200m**

**LEITRIM LAD (T Moseley)** – Stable representative Ms. K Williams advised Stewards, the gelding pulled up well after the post-race veterinary examination revealed a slow rate of recovery. K Williams further advising the gelding is now enroute back to Mr. E Greens stable at Pukekohe Park.

**RACE COMMENTS**

**Race 1 WHITE ROBE LODGE 2030m**

**DUNHILL (S Khetoo)** - Over-raced through the early and middle stages when sitting outside the leader. S Khetoo was spoken to advisedly regarding his whip action over the concluding stages.

**REDGUM (W Papier)** - Under pressure from the 600 metres eventually finishing in last placing. When asked to comment on the performance the rider could offer no explanation. A post-race Veterinary examination revealed the mare to have suffered cardiac arrhythmia. Trainer J Burrows was advised that REDGUM will not be permitted to start in any race or trial until a Veterinary Certificate is supplied declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**AQUATTACK (T Comignaghi)** - Had to shift ground outwards when briefly held up passing the 150 metres.

**Race 2 CROMWELL NEW WORLD 2030m**

**DIAMOND RIVIERE (S Wynne)** - Slow to begin.

**WHISPER ROCK (R Beeharry)** - Began awkwardly, shifting out contacting KITTY POWER with both runners losing ground.

**KITTY POWER (B May)** - Contacted at the start losing ground. Bumped and unbalanced passing the 250 metres.

**DR VELOCIOUS (S Khetoo)** - Crowded shortly after the start. Improved three wide without cover from the 1300 metres. Crowded and buffeted passing the 250 metres.

**BRIDGET TOWN (G Jogoo)** - Raced ungenerously in the early stages when being restrained to take cover racing into the first bend. Held up passing the 250 metres having to be shifted wider on the track to obtain clear racing room.

**SEVEN AAJES (C Campbell)** - Crowded and buffeted when placed in restricted room passing the 250 metres.

**YOUNEVERKNOW** (S Toolooa) - Held up early in the run home, then shifted ground outwards passing the 250 metres to find clear racing room. When asked to comment on the apparent improved performance trainer L Dobbs advised Stewards the mare had been racing without luck in recent starts and today was aided by a patient ride.

**THE BIG BOSS** (T Moseley) - Held up rounding the final bend.

**TAUMALOLO** (K Chowdhoo) - Held up rounding the final bend and in the run home and went to the line not fully tested by its rider.

**TIGER FIRE** (T Comignaghi) - Had some difficulty obtaining clear running in the middle stages of the run home.

**S Toolooa** (YOUNEVERKNOW) - Admitted a charge of careless riding, assisted by D Walsh, in that he permitted YOUNEVERKNOW to shift ground outwards passing the 250 metres when not sufficiently clear of DR VELOCIOUS and SEVEN AAJES which were both crowded and checked. After hearing penalty submissions, the Adjudicative Committee imposed a suspension of Mr Toolooa's riding licence from the conclusion of racing on Sunday 27 November until the conclusion of racing on Saturday 03 December 2022 (4 national days)

**Race 3** | **BREEN CONSTRUCTION & SUPERIOR 1220m**

**B & S Anderton** (RU BRADAR) – Issued with a warning for presenting the gelding without the notified tongue-tie.

**THE BOOGEYMAN** (W Papier) - Began awkwardly, making contact with NEW DAWN and losing some ground as a result. Placed in restricted room passing the 700 metres briefly contacting the rail and losing some momentum. Again, contacted the rail passing the 600 metres when attempting a marginal run to the inside of NEW DAWN. W Papier with the assistance of the Riding Mentor Mr D Walsh, was shown replays of his ride for educational purposes.

**RU BRADAR** (C Campbell) - When questioned regarding the performance of favoured runner rider could off no tangible excuse.

**Race 4** | **OMAKAU AUTO CENTRE & RTL & NZ CHERRY CORP MAIDEN 1220m**

**MININJAGIRL** (L Callaway) - Slow to begin. Crowded near the 300 metres, having to be steadied when GENERATION JOY shifted out. Held up passing the 200 metres having to shift ground outwards to obtain clear running.

**ON MY SHOULDERS** (S Wynne) - Slow to begin and was then taken back to obtain cover from a wide draw. Held up for clear running early in the run home having to shift ground outwards near the 200 metres and was then briefly steadied to avoid the heels of MININJA GIRL (L Callaway) which also shifted ground at this point. L Callaway was advised to exercise greater care.

**THE PIRANHA** (T Moseley) - Raced wide without cover through the early stages and was reported by its rider to have raced greenly throughout.

**CATS IN THE CRADLE** (M Taylor) - Faltered near the 250 metres and was pulled up by its rider. The mare was immediately attended to by the oncourse Veterinarian with the Horse Ambulance also being deployed immediately. The Veterinary inspection revealed the mare to have fractured its near side shoulder with the horse being humanely euthanised and transported from the track in the Horse Ambulance.

**Race 5** | **JACKSON SMART ROOFING & A WOMANS TOUCH MAIDEN 1400m**

**BUSH MILLS BILLY** (K Kalychurun) - Slow to begin.

**PROBELLA** (T Moseley) - Slow to begin.

**FAYE'S WARRIOR** (M Taylor) - Taken back from a wide draw to obtain cover shortly after the start.

**AMATERASU** (S Muniandy) - Taken back from a wide draw to obtain cover shortly after the start. Crowded and checked near the 200 metres.

**FARAH** (L Callaway) - Raced fiercely in the early stages causing rider L Callaway some difficulty. Continued to prove difficult to steer and was not persevered after running off near the 600 metres with rider L Callaway electing to dismount for safety reasons. L Callaway was uninjured in this incident. Underwent a post-race Veterinary examination which revealed no obvious abnormality. Connections were advised the gelding must barrier trial to the satisfaction of Stewards on one occasion prior to racing next. Trainer J Burrows advised Stewards she would be making gear changes prior to the gelding racing next.

**TWITCHY SQUIRREL** (G Saejorhor) - Badly hampered by FARAH in the run down the back straight and was forced over extra ground passing the 800 metres.

**NO BOUQUET** (K Mudhoo) - Held up in the run home and had to shift ground inwards passing the 200 metres to find clear racing room but was again disappointed for a run and raced in restricted room for the remainder of the event. When asked to comment on the performance of favoured runner rider advised that he had got further back than anticipated and had not had all favours in the run home.

**K Mudhoo** (NO BOUQUET) – Admitted a charge of careless riding in that he allowed NO BOUQUET to shift inwards when not sufficiently clear of AMATERASU which was crowded and checked passing the 200 metres. After hearing penalty submissions, the Adjudicative Committee imposed a suspension of Mr Mudhoo's riding licence from the conclusion of racing on Sunday 27 November until the conclusion of racing on Wednesday 07 December, (5 national days).

**POVERTY BAY** (K Williams) - Taken back from a wide draw to obtain cover shortly after the start then tailed the field throughout. When questioned regarding the performance rider advised that the gelding had failed to respond to her urgings during the race and had been less than genuine in its efforts today. A post-race Veterinary examination revealed no obvious abnormality. Trainer A Carston advised Stewards he will be making gear changes for the second day.

**DRAKE BAY** (J Fawcett) - Over-raced in the run down the back straight and near the 900 metres had to be restrained to avoid the heels of OUR TEDDY BOY.

**GEMSTONE JEWELS** (Y Atchamah) - Raced three wide without cover throughout.

**CASTLE ON THE HILL** (T Comignaghi) - Held up early in the run home and had to shift ground outwards passing the 125 metres to find clear racing room.

**S Wynne** (OUR TEDDY BOY) - Issued with a warning when allowing OUR TEDDY BOY to shift inwards near the 900 metres when not fully clear of DRAKE BAY which had to be steadied.

**THE GOOD SHEPHERD** (K Kalychurun) - Began awkwardly losing ground and tailed the field throughout.

**EMANON** (S Toolooa) - Raced three wide without cover throughout.

**CHOKITO** (Y Atchamah) - Held up early in the run home and shifted ground inwards passing the 250 metres to find clear racing room.

**IMBLAZE** (C Johnson) - Crowded and checked passing the 250 metres having to be restrained to avoid heels.

**Y Atchamah** (CHOKITO) - Admitted a charge of careless riding, assisted by D Walsh, in that he permitted CHOKITO to shift ground inwards passing the 250 metres when not sufficiently clear of IMBLAZE which was crowded and checked. After hearing penalty submissions, the Adjudicative Committee imposed a suspension of Mr Atchamah's riding licence from the conclusion of racing on Sunday 27 November until the conclusion of racing on Saturday 03 December 2022 (4 national days)

**POMANDER** (J Fawcett) - Fractious in the barriers and reared just prior to the start.

**SHAKIB** (B May) - Slow to begin. Raced wide without cover through the early stages before improving forward to sit outside the leader near the 1200 metres. Rider lost his whip near the 150 metres.

**LAST TRY** (R Mudhoo) - Over-raced in the early stages.

**R Beeharry** (EISENHOWER) - Issued with a warning after using the whip in 2 consecutive strides on EISENHOWER over the concluding stages with Stewards taking into account his clear recent record with regard to any breach of a whip rule.
