KAIMAI QUEEN (A Lawson-Carroll) – Began awkwardly, losing ground.

CLEESE (J Riddell) - Contacted shortly after the start. When questioned regarding the performance the rider could offer no excuse.

PINION (V Colgan) - Over-raced in the early stages.

BECAUSE (B Rogerson) - Over-raced in the early stages.

ATA RANGI (M McNab) - Over-raced in the early stages. Raced four wide without cover from the 1400 metres to the 1000 metres. Stewards questioned M McNab regarding the riding tactics adopted in the middle stages. M McNab advised that after being shuffled back toward the rear of the field in the early stages the gelding had commenced to over-race on a slow pace so he elected to improve forward to lead. He further advised that once gaining the lead ATA RANGI had relaxed well, and in his opinion finished the race off well. Stewards noted M McNab's comments.

CONTEMPLATION (W Kennedy) – Raced three wide without cover until near the 700 metres.

Race 2 FAIRVIEW MOTORS 2200

PARADING (T Newman) – Began awkwardly making contact with another runner shortly after the start. Raced keenly in the early to middle stages. Inconvenienced passing the 400 metres when EVE'S SONG shifted out.

EVE'S SONG (N Parmar) - Contacted by another runner shortly after the start. Held up early in the final straight before shifting outwards passing the 300 metres to obtain clear running.

CANHEROC (M Sanson) – Slow to begin. Raced three wide without cover throughout.

ANOTHER BELLA (C Grylls) – Slow to begin. Over-raced in the middle stages. Raced five wide from near the 700 metres.

ESS VEE ARE (C Zackey) - Held up until near the 150 metres before improving into a marginal run passing the 100 metres making contact with FINN MCCOOL then lay out over the concluding stages.

FINN MCCOOL (E Bragg) - Had to be firmly restrained when placed in restricted room passing the 100 metres after ESS VEE ARE had improved into a marginal run to its inside simultaneously as LAGERFELD had improved into a marginal run inside of DIGGER which shifted in slightly. Both C Zackey and T Thornton were advised to exercise care in similar circumstances.

LAGERFELD (J Riddell) - Held up rounding the final bend. Improved into a marginal run passing the 100 metres making contact with FINN MCCOOL becoming unbalanced then became awkwardly placed on heels passing the 50 metres having to be steadied.

LOGAN'S LOGIC (V Colgan) – Accidentally struck on the nose by the whip of A Lawson-Carroll approaching the 150 metres.

I Dornan (MAHOMES) - Trainer I Dornan admitted a charge in that she failed to scratch MAHOMES by the required time and was fined \$350 by the Adjudicator.

Following this race, the track was upgraded to Soft 6.

Race 3 SKYCITY HAMILTON WAIKATO CUP DAY 10 DEC 2YO 1100

STICKTO THE ORDERS (C Zackey) – Began awkwardly.

TOKYO TYCOON (M McNab) – Contacted by another runner shortly after the start.

TALISKER (W Kennedy) - Raced greenly rounding the final bend shifting wider. Had to be steadied approaching the 100 metres when SHE TURNS HEADS shifted out and TOKYO TYCOON shifted in slightly. Both M McNab and C Grylls were advised to exercise care in similar circumstances.

Stewards questioned rider W Kennedy (TALISKER) prior to the dividends being paid in relation to lodging a protest alleging interference passing the 100 metres. W Kennedy advised that the gelding had raced greenly from near the 400 metres and had responded poorly when placed in restricted room adding that he was of the opinion that it had not affected his finishing position.

Race 4 WAIKATO DRAUGHT 1100

NOVASHOW (C Zackey) - Restrained to the rear after the start.

PISCO SOUR (J Doyle) - Began awkwardly making contact with another runner shortly after the start.

CHARMARIO (V Colgan) - Crowded shortly after the start losing ground. Was inclined to lay in leaving the 600 metres.

MONTANA MIST (J Fawcett) – Raced three wide without cover throughout.

BERBIZIER (A Lawson-Carroll) - Had to be steadied after improving onto heels passing the 50 metres.

HERO WORSHIP (N Parmar) - Lay out when placed under pressure in the final straight.

T Pike (NOT GUILTY) - Trainer T Pike admitted a charge in that he presented NOT GUILTY to race without the notified blinkers and was fined \$50 under the minor infringement schedule.

Race 5 TREVOR CORALLIE EAGLE MEMORIAL 1500 (Listed Race)

SAVOIR FAIRE (C Grylls) – Began awkwardly making contact with another runner at the start.

THINK TWICE (A Goindasamy) – Began awkwardly making contact with another runner at the start.

SEA THE LIGHT (W Kennedy) - Slow to begin. Held up for a distance passing the 300 metres.

WAITAK (C Zackey) – Over-raced in the early and middle stages. Raced wide without cover from near the 600 metres.

S Marsh (SEDAKA & ENCIERRO) - Admitted a charge in that he failed to declare riders by the required time for SEDAKA (R5) and ENCIERRO (R7) and was fined \$300 by the Adjudicator.

Race 6 MAJESTIC HORSE FLOATS 1300

HEART OF GOLD (L Satherley) – Began awkwardly making contact with LES CRAYERES, losing ground.

LES CRAYERES (N Parmar) – Began awkwardly losing ground.

COOL CHANGE (W Kennedy) - Began awkwardly losing ground. Raced keenly through the middle stages.

COVENTINA BAY (C Butler) - Began awkwardly losing ground. When questioned regarding the performance the rider advised that she had not been disappointed with the performance and in her opinion would derive benefit from today's race. Underwent a post-race veterinary examination which did not reveal any abnormality.

TEVERE (M McNab) - Raced three wide without cover for the majority of the race. When questioned regarding the performance the rider advised that he had not been disappointed with the performance and in his opinion would derive benefit from today's race.

DRAGON QUEEN (C Zackey) – Held up rounding the final bend.

C Butler (COVENTINA BAY) - Admitted a charge in that she struck her mount COVENTINA BAY six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$250.

Race 7 EAGLE TECHNOLOGY STAKES 1600 (G3)

PAISLEY PARK (W Pinn) - Began awkwardly making contact with another runner. Held up until near the 200 metres.

PRISE DE FER (C Zackey) – Contacted by another runner shortly after the start.

SINARAHMA (C Grylls) - Slow to begin. Held up until near the 150 metres.

AQUAOIR (W Kennedy) – Held up for a short distance passing the 500 metres.

CHEAPERTHANDIVORCE (V Colgan) - Had some difficulty obtaining clear running until near the 150 metres.

JUSTAMAIZ (S Spratt) – Improved onto heels passing the 100 metres having to be steadied.

GINO SEVERINI (J Riddell) - Contacted and unbalanced approaching the 100 metres by ENCIERRO which shifted inwards.

BRANDO (M McNab) - When questioned regarding the performance the rider advised that he had been disappointed with the effort however could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

DAWN JESSIE (E Bragg) - When questioned regarding the performance the rider advised that in her opinion the mare had raced well but would now appreciate a step up in distance.

J Doyle (ENCIERRO) – Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of GINO SEVERINI which was contacted and unbalanced approaching the 100 metres.

Race 8 BCD GROUP 1400

BLOOD DIAMOND (V Colgan) - Began awkwardly, losing ground.

SHEPHERD'S DELIGHT (N Parmar) – Began awkwardly, losing ground. Unable to obtain clear running over the final 100 metres.

SULABELLA (W Kennedy) – Began awkwardly. Had to be checked to avoid heels passing the 1100 metres.

AYREON (M McNab) – Crowded shortly after the start, losing ground.

MACRAES (A Goindasamy) – Slow to begin then crowded shortly after, losing ground.

LADY MAROAL (B Rogerson) - Raced three wide without cover throughout.

HOVDAMER (T Newman) – Raced four wide without cover for the majority of the race.

DEEP BEAUTY (J Doyle) - Underwent a post-race veterinary examination which did not reveal any abnormality.

B Foote (AYREON) - Issued with a warning after presenting AYREON to race without the notified blinkers.

T Pike (MACRAES) - Admitted a charge in that he failed to declare a rider by the required time for MACRAES and was fined \$50 under the minor infringement schedule.

C Zackey (ALBATROSS) - Defended a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of SULABELLA which had to be checked to avoid heels passing the 1100 metres. After considering submissions the Adjudicator found the charge proven and imposed a suspension of C Zackey's licence to ride in races from the conclusion of racing on Wednesday 7 December up to and including racing on Friday 16 December, 5 national riding days.
