RACE COMMENTS**Race 1****AHD LTD HANDICAP 2200**

UNUSUAL SAINT (W Pinn) - Underwent a pre-race veterinary examination and was cleared to start.

RED 'N' SURF (C Barnes) - Slow to begin.

SECRET ASSASSIN (W Kennedy) - Began awkwardly losing ground. Connections advised that the gelding would not be persevered with as a racing proposition from their stable.

HESACITIBOY (A Mudhoo) - Crowded shortly after the start losing ground. Had some difficulty obtaining clear running until near the 200 metres.

LORD SPENCER (C Grylls) - Crowded shortly after the start losing ground.

TORQUE TIME (S O'Malley) - Had to be firmly restrained after improving on to heels near the 800 metres.

SADLER'S CHICK (M McNab) - Came together with PRIMO STELLA passing the 200 metres when both runners shifted ground, and again passing the 100 metres when PRIMO STELLA shifted inwards.

MAHOMES (J Riddell) - When questioned regarding performance the rider could offer no excuse.

Race 2**NZB KARAKA 2023 TRAINERS SERIES MAIDEN 1600**

ECCELLENZA (J Doyle) - Crowded and checked near the 1500 metres.

C'MON EILEEN (M Hashizume) - Crowded and checked near the 1500 metres.

RAVENNA ROSE (M Hudson) - Crowded and checked near the 1500 metres.

FUNZONE (C Lammas) - Improved on to heels near the 1100 metres, having to be firmly restrained.

ROADSTER (J Riddell) - Improved on to heels near the 600 metres, having to be steadied, dropping back on to TIME TO WONDER, which was hampered.

TIME TO WONDER (L Douglas) - Hampered passing the 600 metres.

FLICK THE SWITCH (K Hercock) - Inconvenienced passing the 350 metres.

DEADLY PONY (K Asano) - Underwent a post-race veterinary examination revealed the mare to have suffered cardiac arrhythmia. Connections were advised that DEADLY PONY will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of 1000 metres.

T Taiaroa (KRONE) - Admitted a charge of careless riding in that she permitted KRONE to shift inwards when not sufficiently clear of EXCELLENZA, C'MON EILEEN and RAVENNA ROSE, which were crowded and checked near the 1500 metres. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 17 December, until the conclusion of racing on Saturday, 24 December, 4 national riding days.

Race 3 | **HAPPY HIRE 3YO MAIDEN 1400**

WRITTEN UP (L Douglas) - Slow to begin.

MR BULLY TEE (T Mitchell) - Crowded shortly after the start losing ground.

COURVOISIER (K Hercock) - Raced ungenerously in the early and middle stages.

ASTERIAL (C Grylls) - Raced three wide without cover for the majority of the race.

Track Upgraded to Good 4 following Race 3.

Race 4 | **GAVELHOUSE.COM AUCTION ONLINE NOW MAIDEN 1400**

RIDE THE TIDE (J Doyle) - Slow away.

PERFECT POSY (S McKay) - Raced three wide without cover throughout.

VIVA LE VADA (J Riddell) - Had some difficulty obtaining clear running near the 200 metres.

Race 5 | **NEW YEARS EVE RACEDAY ON SALE NOW MAIDEN 1400**

PRINCESS BIDDY (S O'Malley) - Underwent a pre-race veterinary inspection behind the barriers and was cleared to start.

SKY DANCER (C Grylls) - Began awkwardly losing ground.

IFFIDAPUNT (L Allpress) - Crowded shortly after the start having to be steadied. Held up until near the 150 metres.

GOHUGO (K Hercock) - Slow to begin.

PURE FICTION (C Lammas) - Raced keenly in the early and middle stages. When questioned regarding performance rider advised that after over-racing throughout the running the filly had failed to finish the race off when placed under pressure.

Race 6 | **FOLLOW THE GRAND TOUR RACING FESTIVAL MAIDEN 1200**

EXPRESS YOURSELF (C Grylls) - Knuckled on jumping away.

CHEAP SAV (L Allpress) - Began awkwardly losing ground. Rider reported that the filly had felt indifferent in its action. Underwent a post-race veterinary examination which revealed the filly to be 1/5 lame.

BALLYANE (M McNab) - When questioned regarding performance the rider advised he had been disappointed, however he could offer no excuse. Underwent a post-race veterinary examination which revealed the mare to be showing signs of lameness. Connections were advised that a veterinary clearance is required prior to BALLYANE racing next.

SEALED WITH A KISS (S Weatherley) - Kicked out in the winner's enclosure. Underwent a post-race veterinary examination revealed a minor leg abrasion.

FINE CUT (S Spratt) - Raced three wide without cover throughout. Had to be steadied to avoid heels approaching the 350 metres.

K Hercock (PIPERS FLING) - Issued with a warning after permitting her mount to shift out when not sufficiently clear of FINE CUT, which had to be steadied to avoid heels approaching the 350 metres.

J Doyle (TIMING) - Admitted a charge in that he struck his mount 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$350.

Race 7 | **BREWS & QUES ON SALE NOW MAIDEN 1200**

LILLY THE FILLY (T Mitchell) - Slow to begin. Made the bend awkwardly near the 800 metres, running wider, then continued to lay outwards for a distance.

DEVA DYNASTY (S Weatherley) - Slow to begin.

READY TO DRINK (M McNab) - Made the bend awkwardly near the 850 metres when racing keenly, having to be steadied. Held up until near the 200 metres.

JESKO ABSOLUT (S Spratt) - Improved on to heels passing the 500 metres having to be firmly restrained.

VINO VALENTINO (M Hashizume) - Lay inwards when placed under pressure in the final straight being reluctant to improve into a marginal run before laying on to heels passing the 150 metres, having to be restrained.

Race 8 | **BRAMWELL BATE LAWYERS SPRING 1200**

SCOTCH (S Spratt) - Began awkwardly and then commenced to over-race. Underwent a post-race veterinary examination did not reveal any abnormality.

LIGHTNING FIELD (N Parmar) - Began awkwardly.

FALL ON A STAR (M McNab) - Began awkwardly.

KING FAROUK (S O'Malley) - Crowded shortly after the start losing ground. Raced keenly throughout.

MOHAWK BRAVE (H Kamaruddin) - Held up for some distance on entering the home straight and raced in restricted room until near the 100 metres.

Race 9 | **TREMAINS –R UGBY, RACING & REAL ESTATE HANDICAP 1400**

SHARE POWER (F Lazet) - Reared as the start was effected getting its head over the partition to its inside and as a result failed to jump on terms, being very slow away. Commenced to buck shortly after the start dislodging its rider. F Lazet was attended to by on-course ambulance personnel and found to be uninjured. Connections were advised that the gelding will be required to barrier trial to the satisfaction of Stewards prior to racing next.

SHA CARRI (L Allpress) - Began awkwardly losing ground. Steadied when placed in restricted room passing the 200 metres to the inside of RANGER (B Rogerson), which shifted in slightly. B Rogerson was advised to exercise care when in similar circumstances. Steadied when placed in restricted room over the concluding stages.

DUNCAN CREEK (J Doyle) - Came together with LANDRY just prior to the winning post when both runners shifted ground.

LANDRY (K Asano) - Came together with DUNCAN CREEK just prior to the winning post when both runners shifted ground.

ALBATROSS (C Grylls) - When questioned regarding performance the rider advised the mare had failed to respond when placed under pressure in the straight.

Connections of the 2nd placed **DUNCAN CREEK** viewed video footage alleging interference from the 1st placed **LANDRY** in the final straight before electing not to proceed with a protest.

Connections of 4th placed **SHA CARRI** viewed video footage alleging interference from the 3rd placed **RANGER** in the final straight before electing not to proceed with a protest.

ALIGHIERI (W Kennedy) - Underwent a pre-race veterinary examination behind the barrier and was cleared to start.

SAVANAH BELLE (L Allpress) - Slow to begin. Raced keenly for a distance passing the 1200 metres before being allowed to improve forward to race three wide without cover for the remainder of the race.

BLISSFUL BELLE (S Spratt) - Slow to begin.

SCUTAR (F Lazet) - Raced ungenerously in the early stages. Hampered passing the 1100 metres.

UNUSUAL COUNTESS (W Pinn) - Raced ungenerously when being restrained in the early stages then shifted inwards passing the 1100 metres hampering SCUTAR. Had some difficulty obtaining clear running early in the final straight. When questioned regarding the performance the rider advised that over racing in the early and middle stages the mare had failed to finish the race off.

FARRENC (N Parmar) - Raced keenly in the early stages.
