#### RACE COMMENTS

##### Race 1 | LODGE PROPERTY MANAGEMENT MILE MAIDEN 1600

**KEENASABEAN** (V Colgan) - Began awkwardly losing ground.

**STRANGE LOVE** (H Kamaruddin) - Slow to begin. Over-raced in the early stages.

**NOSNEVETS** (T Newman) - Began awkwardly losing ground.

**KIWI'S CRUISIN** (W Kennedy) - Began awkwardly losing ground.

**BITCOIN** (O Bosson) - Crowded leaving the barriers. Had some difficulty obtaining clear running early in the final straight.

**ANNETARZ** (C Barnes) - Raced wide in the early stages. Inconvenienced passing the 50 metres when runners either side shifted ground.

**CON ARTIST** (S Spratt) – Over-raced in the early and middle stages. Had to be steadied when placed in restricted room approaching the 50 metres when runners either side shifted ground.

**ELUSIVE CAPITAL** (T Mitchell) – Raced wide without cover throughout. Steadied when placed in restricted room to the inside of STRANGE LOVE which shifted in when not fully clear approaching the 350 metres. H Kamaruddin was advised to exercise care in similar circumstances.

**GHAZZAH** (C Lammas) – Had to be firmly restrained off heels near the 700 metres. When questioned regarding the performance the rider advised that the colt had failed to handle today's track conditions.

**HAMMER TIME** (A Lawson-Carroll) - Lay out when placed under pressure in the final straight.

**A Lawson-Carroll** (HAMMER TIME) – Issued with a warning after permitting his mount to shift out approaching the 50 metres dictating ANNETARZ outwards into the line of CON ARTIST which had to be steadied when placed in restricted room. Contributing was slight inward movement from STRANGE LOVE.

##### Race 2 | NATIONWIDE LIVESTOCK MILE 1600

**ASTERIX** (W Kennedy) - Began awkwardly then crowded shortly after clipping a heel and blundering, losing ground as a result.

**TUTUKAKA** (S Spratt) - Raced three wide without cover throughout.

**ENCIERRO** (S Weatherley) – Held up until near the 200 metres.

**LILY THUNDER** (E Bragg) - Was not ridden out fully over the final 100 metres after the rider suffered an injury. E Bragg dismounted the mare on pulling up and was attended to by the oncourse ambulance personnel and stood down from

her remaining rides. E Bragg was excused from weighing in by Stewards under Rule 647(1). E Bragg is to provide a medical clearance prior to riding next.

**FIELD OF GOLD** (V Colgan) - When questioned regarding the performance the rider advised that the gelding had travelled comfortably throughout, however when placed under pressure in the final straight, had failed to respond. Underwent a post-race veterinary examination which did not reveal any abnormality.

**WHITE NOISE** (K Hannan) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

**PIPPY** (S Weatherley) - Crowded leaving the barriers losing ground. Steadied off heels near the 900 metres.

**SAVACAT** (C Lammas) - Crowded leaving the barriers losing ground.

**NANCY SHE WROTE** (H Kamaruddin) - Began awkwardly. Raced ungenerously approaching the 1000 metres and continued to do so for some distance, shifting wider on the track near the 800 metres.

**IL RE** (T Newman) - Raced keenly in the early stages.

**KISZKAH** (C Barnes) – Raced wide without cover throughout.

**CANHEROC** (K Hannan) - Slow to begin (3L). Improved onto heels having to be steadied near the 1600 metres. Contacted and unbalanced near the 450 metres then held up until shifting outwards to obtain clear running near the 150 metres.

**FARAG** (A Goindasamy) - Over-raced in the early stages.

**SUPER SIX** (H Kamaruddin) – Raced keenly in the early and middle stages. Raced wide without cover from the 1300 metres.

**I'M ALICE** (T Thornton) – Raced keenly in the middle stages.

**MAHOMES** (T Mitchell) – Gave ground passing the 1000 metres and was retired from the race. Returned to the enclosure with blood present in both nostrils. Following a veterinary examination MAHOMES was confirmed to have bled. MAHOMES shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a veterinarian.

**DAYDREAM BELIEVER** (M Hashizume) – Lay outwards throughout the final straight finishing wide on the track.

**RAZORS EDGE** (V Colgan) - improved onto heels near the 550 metres having to be steadied.

**PAHI LASS** (Y Kumagai) – Shifted out slightly near the 450 metres making contact with the hindquarters of CANHEROC which became unbalanced. Held up entering the final straight.

**QUEEN SARABI** (S Weatherley) – Checked near 50 metres when ONEZEDBEE shifted outwards.

**PRISMATIC** (O Bosson) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

**M Cropp** (ONEZEDBEE) - Admitted a charge of careless riding in that he permitted his mount to shift out when not sufficiently clear of QUEEN SARABI which was checked passing the 50 metres. After considering submissions the Adjudicator imposed a suspension of M Cropp's licence to ride in races from the conclusion of racing on Saturday 17 December up to and including racing on Saturday 24 December, 4 national riding days.

**Race 5** | **LODGE COMMERCIAL STAYERS 2200**

**SWING LOW** (A Lawson-Carroll) - Slow to begin.

**AQUACADE** (W Kennedy) – Raced wide in the early stages.

**RISING STORM** (K Hannan) - Raced wide in the early stages.

**WHEAO** (L Satherley) - Raced three wide without cover for a majority of the race. Underwent a post-race veterinary examination which found the gelding to have a slower than normal recovery.

**PINION** (N Parmar) - Improved onto heels over the concluding stages having to be steadied by its rider.

**ATA RANGI** (M Hashizume) - Raced in restricted room just prior to the winning post.

**JOE'S LEGACY** (S Weatherley) - Underwent a post-race veterinary examination after pulling up in a slightly distressed state however recovered quickly with no obvious abnormalities being found.

**Race 6** | **LODGE REAL ESTATE 1200**

**STONYBRECK** (O Bosson) – Contacted leaving the barriers. Restrained in the early stages to obtain cover after jumping from the outside barrier.

**RABADA** (M Kareem) - Began awkwardly losing ground. Raced ungenerously in the early and middle stages.

**HEY HEY BABY** (T Mitchell) - Contacted leaving the barriers.

**INDUSTRIALIST** (A Goindasamy) – Began awkwardly. Was unable to obtain clear running throughout the final straight.

**PARADIGM SHIFT** (Y Kumagai) - Over-raced in the early stages having to be firmly restrained off heels passing the 800 metres. Crowded and checked approaching the 200 metres.

**POLLY PLUM** (R Elliot) - Raced wide without cover throughout.

**N Parmar** (MR RAINBOW) - Admitted a charge of careless riding in that he permitted his mount to shift out when not sufficiently clear of PARADIGM SHIFT which was crowded and checked approaching the 200 metres. After considering submissions the Adjudicator imposed a suspension of N Parmar's licence to ride in races from the conclusion of racing on Saturday 17 December up to and including racing on Sunday 1 January, 10 national riding days. N Parmar is to continue to be assessed by the Rider Skills Review Panel.

**Race 7** | **LAWNMASTER EULOGY STAKES 1600 (G3)**

**IMARICHGIRL** (A Goindasamy) - Began awkwardly then crowded shortly after, losing ground. Raced keenly in the early stages.

**IN THE LOOP** (N Parmar) - Began awkwardly. Raced ungenerously passing the 1100 metres having to be steadied off heels.

**FAMILY TIES** (H Kamaruddin) - Contacted leaving the barriers.

**SAKURA GIRL** (S Spratt) – Raced wide without cover throughout.

**SEDAKA** (C Barnes) - Had difficulty obtaining clear running for a distance passing the 300 metres.

**TIVACI PRINCESS** (S Weatherley) - When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**SEALED WITH A KISS** (O Bosson) - When questioned regarding the performance the rider advised that the filly had raced greenly throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 8**

**BRECKON FARMS – NZ BREEDER OF THE YEAR 1400**

**MISS ELLA** (C Barnes) – Crowded shortly after the start losing ground.

**COOL CHANGE** (W Kennedy) – Crowded and contacted leaving the barriers, losing ground.

**CASTLE BAY** (T Mitchell) – Contacted leaving the barriers losing ground.

**ROCKSPELL** (T Newman) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**DUNEAGLE** (A Goindasamy) – Over-raced in the early stages.

**MANRICO** (B Rogerson) – Raced wide without cover in the early and middle stages. When questioned regarding the performance the rider could offer no excuse.

**JOEY'S GIFT** (S Spratt) – Raced keenly in the early and middle stages. Came together with FARAGLIONI over the concluding stages when both runners shifted ground.

**FARAGLIONI** (V Colgan) – Came together with JOEY'S GIFT over the concluding stages when both runners shifted ground.

**WESTERN SPRINGS** (C Lammas) - When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions, and in his opinion would derive benefit from today's race.

**Race 9**

**LODGE – NOBODY KNOWS HAMILTON LIKE US MILE 1600**

**JIMMY DEAN** (H Kamaruddin) – Slow to begin.

**SEA THE LIGHT** (W Kennedy) - Began awkwardly.

**DIMAGGIO** (V Colgan) - Began awkwardly. Raced ungenerously in the early and middle stages.

**CASCATELLA** (T Abel) – Raced ungenerously when being restrained in the early stages.

**GALLIVANTER** (R Elliot) - When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

**LINGJUN XIONGFENG** (M Hashizume) - When questioned regarding the performance the rider advised that LINGJUN XIONGFENG failed to handle today's track conditions and had resented racing amongst other horses.

**N Parmar** (BRIAN LAMONT) - Admitted a charge in that he struck his mount BRIAN LAMONT six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.
