A rider dispute in Race 8 today was resolved prior to the first race with K Chowdhoory being declared to ride SEIKRID and K Kalychurun declared to ride SEVEN TWENTY. As a result, K Chowdhoory was issued with a warning under	

Rule 330(3)(b) in that he allowed himself to be double engaged for Race 8.

Rider **J Chung** advised Stewards he was unable to attend today's race meeting due to feeling unwell and was replaced as per above Summary. J Chung was advised he will be required to produce a medical certificate prior to riding next.

SUPPLEMENTARY

Ashburton Racing Club – Wednesday 21 December 2022

Race 6 – BLUES BROTHERS MAIDEN 2600m

BB Hong admitted a breach of Rule 638(3)(g)(i) in that he struck his mount LITIGATOR 6 times prior to the 100 metre mark with the Adjudicator imposing a fine of \$250.

RACE COMMENTS

Race 1 **DUNEDIN CASINO MAIDEN 1400m**

PLEASURENPAIN (B May) – Reluctant to load. The connections were advised that a warning would be placed against the gelding's barrier manners.

THE TUI TOILER (K Kalychurun) - Slow to begin.

WILD JAKKAL (K Kwo) - Raced wide throughout.

KOTIRO TERE (K Mudhoo) - Over raced in the early stages. Lay out rounding the final bend and in the run home.

UNUSUAL AFFAIR (C Campbell) - Held up rounding the final bend.

MISS PEARL (T Moseley) - When questioned regarding performance, rider advised that MISS PEARL had every opportunity, with trainer R Beckett advising that the mare would be sent for a spell.

Race 2 **WHITE ROBE LODGE DAY 4TH FEBRUARY 1200m**

REDMOND (Y Atchamah) - Fractious prior to the start. Over raced in the early stages.

CLAUDIUS MAXIMUSS (K Kalychurun) – Slow to begin. Made the bend near the 900 metres awkwardly. Rider reported that the gelding raced greenly throughout.

MOOLOOLABA (K Mudhoo) – Slow to begin. Had to be steadied when awkwardly placed on heels racing into the first bend.

GOLDIE'S CHANCE (T Moseley) - Over raced in the early stages.

NAKAMOTO (D Montes de Oca) – Lay inwards in the run home and became awkwardly placed on the heels of GOLDIE'S CHANCE having to shift ground inwards to obtain clear running near the 100 metres.

GENERATION JOY (R Mudhoo) - Shifted out abruptly having to be straightened by its rider passing the 150 metres.

Race 3 **POSITIVE SIGNS + PRINT 2200m**

TIGER FIRE (T Moseley) - Slow to begin.

HEY MICKEY (D Montes de Oca) - Raced wide in the early stages.

BAD FLAMINGO (K Williams) - Raced keenly through the early stages due to the lack of tempo and was then taken forward to lead near the 1200 metres.

PONIARD (R Mudhoo) - Raced in restricted room racing into the bend near the 1600 metres and was crowded and buffeted when TAUMALOLO shifted in when being steadied. Denied a marginal run near the 500 metres and when being steadied to avoid heels came back onto JIMINY CRICKET which also had to be steadied. Rider reported the gelding had felt indifferent in its action over the concluding stages. A post race veterinary examination did not reveal any obvious abnormality.

TAUMALOLO (K Chowdhoory) - Over raced due to the lack of tempo and became awkwardly placed inside the heels of BAD FLAMINGO having to be steadied near the 1600 metres.

COLOSSAL (Y Atchamah) - Over raced when being restrained to take cover in the middle stages.

LOCHNABERRY (G Jogoo) - Lay inwards throughout the run home having to be straightened by its rider on several occasions.

JIMINY CRICKET (B May) - Hampered and had to be restrained near the 500 metres.

Race 4	DUNEDIN CITY MOTORS 2200m

NESTA (K Kalychurun) - Slow to begin. Over raced in the middle stages getting its head up on several occasions.

KILOWATT (T Moseley) - Raced wide in the early stages. Crowded and buffeted passing the 200 metres.

RIVIERA ROCK (L Callaway) - Raced keenly in the early and middle stages. Briefly hampered in the run home by outside runner.

LETSBRINGITON (K Chowdhoory) - Lay in throughout the run home having to be straightened.

ASATHOUGHT (C Campbell) - Lay out passing the 300 metres and had to be straightened by its rider.

DUNHILL (R Mudhoo) - Lay inwards near the 200 metres despite the efforts of the rider, crowding and buffeting LEAVE IT TO ME, KILOWATT and HEIDI HI which all lost some ground, with the trailing ZAMBEZI ZIPPER also being hampered. Also contributing to this incident was some outwards movement from ASATHOUGHT. The connections were advised that a warning would be placed on DUNHILL's racing manners.

LEAVE IT TO ME (K Mudhoo) - Crowded and buffeted and lost ground passing the 200 metres.

HEIDI HI (K Williams) - Crowded and buffeted and had to be restrained passing the 200 metres when runners from either side shifted ground.

ZAMBEZI ZIPPER (D Montes de Oca) - Hampered passing the 200 metres having to be restrained.

ZENDORA (G Jogoo) – Underwent a post-race veterinary inspection at the request of the trainer who was disappointed with today's effort. The subsequent inspection revealed no obvious abnormality. Trainer J Dalton advised she would have follow up blood tests done and advise stewards of any subsequent abnormalities.

Race 5	NELLIES RESTAURANT AND BAR 1200m

WILLIS (G Jogoo) - Blundered at the start losing ground. Rider advised that after losing ground at the start the gelding had found the line well and in his opinion was looking for more distance.

DECISIVE (T Moseley) - Taken back from a wide draw to obtain cover.

LASER'S FURY (K Chowdhoory) - Saddle shifted backwards shortly after the start placing the rider at a disadvantage.

HE'S READY (K Williams) - Raced wide throughout. Rider reported the gelding had lay inwards in the run home.

TRADITION (R Beeharry) - Had difficulty finding clear running in the early stages of the run home.

MI CAROL (Y Atchamah) - Held up over the final 150 metres going to the line not fully tested by its rider.

OUR CLARRY (B May) - When asked to comment on performance rider advised in his opinion the gelding was unsuited by having to carry 59.5 kgs today which may have contributed to OUR CLARRY compounding over the concluding stages.

B May (OUR CLARRY) - Admitted a charge in that he struck his mount OUR CLARRY 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

Race 6	PROPERTY BROKERS HAZLETT STAKES 1200m

OKAY PAL (D Montes de Oca) - The start was delayed approximately 2 minutes when **OKAY PAL** required resaddling. Briefly crowded passing the 50 metres when **LIGHTNING JACK** lay in before being corrected by its rider.

GOLDEN HARVEST (G Jogoo) - Over raced in the early stages and got its head up near the 1000 metres when being restrained away from heels.

ROCKLAND (K Williams) - Crowded at the start losing ground when **LIGHTNING JACK** shifted inwards abruptly.

EPTIMUM (R Mudhoo) - Crowded and checked near the 900 metres.

LIVE DRAMA (J Laking) - Raced wide throughout. Was eased down near the 400 metres. Rider reported the mare to be hanging on one rein and could not be ridden to any advantage. A post race veterinary examination did not reveal any obvious abnormality. Stewards will follow up with the mare's recovery in the coming days.

THE RADIANT ONE (T Moseley) - Held up in the run home only gaining clear racing room inside the final 150 metres.

J Laking (LIVE DRAMA) - Spoken to advisedly regarding his conduct at the scales.

M & M Pitman (OKAY PAL) - Issued with a warning for incorrect saddling.

S Toolooa (EMANON) - Admitted a charge of careless riding in that he permitted his mount EMANON to shift inwards when not sufficiently clear of EPTIMUM which was crowded and checked near the 900 metres. After considering submissions the Adjudicator imposed a suspension of S Toolooa's licence to ride in races from the conclusion of racing on Sunday 1 January until the conclusion of racing on Friday 6 January, 5 national riding days.

Race 7	ODT SOUTHERN MILE QUALIFIER 1600m

POWERLITE (Y Atchamah) - Underwent a pre-race veterinary examination after being kicked at the start and was cleared to race. Rider reported the mare had felt sore on returning to the birdcage. A post-race veterinary examination did not reveal any obvious abnormality.

DUSHKU (K Mudhoo) - Slow to begin.

I AM A ROCK (G Saejorhor) - Restrained from a wide draw to take cover.

NOBLE KNIGHT (K Chowdhooory) - Began awkwardly. Raced three wide without cover in the early stages.

CAITLYN JAY (T Moseley) - Raced wide throughout.

CANDIDATE (L Callaway) - Lay inwards in the early stages of the run home and when being straightened crowded **DEMAND RESPECT** near the 100 metres.

PHYLLITE (C Campbell) - Held up throughout the run home going to the line not fully tested by its rider.

DEMAND RESPECT (J Laking) - Denied a run near the 100 metres when **CANDIDATE** which had lay in was straightened by its rider. L Callaway was advised to exercise greater care. When assessing this incident Stewards considered the contributing movement from **PICKENS** which was also shifting inwards and away from **CLASSIC DIVA** which was also shifting inwards.

Race 8	ODT SOUTHERN MILER QUALIFIER 1600m

BURGIE (T Moseley) - Underwent a pre-race veterinary examination at the trainer's request after suffering an abrasion enroute to the racecourse and was cleared to race. Lost the near front plate during the running.

ANJAMEME (G Jogoo) - Slow to begin. Raced wide in the early stages. Lay out from the 900 metres placing the rider at a disadvantage for the remainder of the race. Connections were advised the mare was on a racing manners warning. Rider reported that **ANJAMEME** locked on one rein, with the trainer advising he would be making gear changes prior to the mare's next start.

LARPOWER (K Kwo) - Slow to begin.

NAMIBIA MISS (R Mudhoo) - Began awkwardly.

LILY OF THE VALLEY (S Toolooa) - Taken back from a wide draw to obtain cover.

AERIAL BLUE (L Callaway) - Over raced in the middle stages. Crowded and had to steady near the 500 metres.

STAR BALLOT (D Montes de Oca) - Lay in throughout the run home having to be continuously straightened.

RAY'S IN COMMAND (C Campbell) - Lost the off rear plate during the running.

B May (SPECIALTY) - Issued with a warning after allowing his mount to shift out passing the 500 metres, with **AERIAL BLUE** having to be steadied to avoid heels.
