Race 10 – WAIKATO DRAUGHT FAREWELL 1600

T Abel (TRIGON LAD) - Admitted a charge in that she struck her mount TRIGON LAD eight times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.

POZZI VIBE (R Elliot) – Mr. S Cole advised Stewards he was satisfied with the post-race condition of the gelding, and it is his intention to nominate POZZI VIBE for the Whangarei RC meeting on Friday, 6 January.

RACE COMMENTS**Race 1 REAL CHARTERED ACCOUNTANTS MAIDEN 1600**

VERISMO (J Bayliss) - Slow to begin. Made contact with the running rail passing the 1100 metres.

GLITZABELLA (C Lammas) – Began awkwardly.

MOONLIGHT SHADOW (C Barnes) - Began awkwardly. Had some difficulty obtaining clear running early in the final straight.

BELLA VOLAIRE (T Newman) – Restrained to the back of the field shortly after the start.

MARIA (T Thornton) - Raced three wide without cover throughout. Underwent a post-race veterinary examination including an endoscopic examination which found the mare to have a mild respiratory infection.

HEY GIRLFRIEND (J Doyle) – Raced keenly in the early stages. Held up until near the 300 metres.

SILK ‘N’ DALE (W Kennedy) - Held up rounding the bend before shifting outwards passing the 350 metres making contact with BELLADONNA which was forced wider.

BELLADONNA (O Bosson) – Contacted and forced wider passing the 350 metres. When questioned regarding the performance the rider advised that the mare may not have handled today’s track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

ANNIE (V Colgan) - Held up until near the 350 metres.

Following this race, the track was upgraded to Good 4.

Race 2 HAPPY HIRE MAIDEN 1200

MR MONDELLO (A Lawson-Carroll) - Underwent a pre-race veterinary examination at the start and cleared fit to race. Began awkwardly. Raced ungenerously in the middle stages.

MELODRAMATIC (T Thornton) - Began awkwardly.

ESPIONAGE (C Grylls) – Began awkwardly.

WEY TOO COOL (K Hannan) – Connections were advised that a warning would be placed on the mare’s barrier manners after being fractious in its barrier stall. Began awkwardly. Raced three wide without cover from near the 1000 metres.

ADAM I AM (J Fawcett) – Began awkwardly then over-raced in the early and middle stages.

READY EDDIE GO (L Satherley) – Over-raced in the early stages.

FOREVER YOUNG (W Kennedy) - Raced wide in the early stages before working its way to the lead.

COCO EXPRESS (O Bosson) – Over-raced in the middle stages. When questioned regarding the performance the rider advised that the gelding had made abnormal breathing noises during the running. Underwent a post-race veterinary examination including an endoscopic examination which revealed the gelding to have right sided laryngeal dysfunction. Connections were advised a veterinary clearance would be required prior to racing next.

MCLAREN (J Doyle) - Raced greenly in the home straight.

ACCURACY (J Bayliss) - Held up for a distance passing the 350 metres.

LUELLA CRISTINA (S Weatherley) - Held up until near the 300 metres.

MARCELLA (V Colgan) – Slow to begin.

RABADA (M Kareem) - Slow to begin. Steadied just prior to the winning post when in restricted room.

MINI MINER (J Kamaruddin) – Began awkwardly. Had some difficulty obtaining clear running early in the straight.

OVER THE MOON (B Rogerson) - Crowded shortly after the start losing ground. Steadied after improving into restricted room passing the 350 metres.

APOLLYON (K Asano) - Began awkwardly. Raced wide without cover throughout.

DEEP PURPLE (C Barnes) - Raced wide without cover throughout.

GEMMA FLITZ (M Hashizume) - Raced wide without cover throughout.

Race 4	NEW WORLD TE PUKE MAIDEN 2100

AULD JOCK (J Kamaruddin) - Began awkwardly. Raced in restricted room passing the 100 metres having to be steadied.

THE SEAFARER (A Goindasamy) - Began awkwardly losing ground. Made the bend awkwardly near the 1700 metres and shifted out resulting in KANDANOS which had lay in, clipping a heel and blundering dislodging its rider. W Kennedy was attended to by oncourse ambulance personnel and stood down from his remaining rides. W Kennedy was advised a medical certificate would be required prior to riding next.

KANDANOS (W Kennedy) - Clipped a heel and blundered dislodging its rider near the 1700 metres.

HIBERRY (B Rogerson) – Raced three wide without cover throughout.

SHADOW BOXER (K Hannan) - Held up over the final 100 metres.

NINE REALMS (C Lammas) – Raced three wide without cover until near the 1400 metres.

DAYDREAM BELIEVER (M Hashizume) - Was inclined to hang out leaving the home straight on the first occasion. Raced wide without cover for the majority of the race. Steadied when placed in restricted room to the outside of ROCCIA which shifted outwards passing the 400 metres. Contributing was inward movement from SUPER SIX. Lay out entering the final straight forcing BINGWA wider.

ROCCIA (V Colgan) – Raced ungenerously in the middle stages.

BINGWA (A Goindasamy) – Forced wider entering the home straight.	
Race 6	DUNCAN DENTAL MAIDEN 1400
ARKADUS (C Lammas) - Slow to begin. TREATY OF PARIS (J Kamaruddin) – Began awkwardly. Had some difficulty obtaining clear running rounding the final bend. APOGEE (R Elliot) - Began awkwardly. DRAGON BUBBLES (M Hashizume) - Made contact with the barrier as the start was initiated. IRISH TWIST (K Asano) - Steadied shortly after the start then further hampered when laying outwards across heels. Raced keenly for a distance passing the 1000 metres. YOU KNOW (J Fawcett) - Raced three wide without cover throughout.	
Race 7	STE INDUSTRIAL ELECTRICAL MAIDEN 1400
BID FOR FAME (C Barnes) – Began awkwardly. HILL OF KINGS (S Weatherley) - Began awkwardly. PERSUADER (J Doyle) – Began awkwardly. Inclined to lay in over the concluding stages when placed under pressure. SPECIAL SWEY (K Asano) - Raced three wide without cover for a majority of the race. VICFRANILAN (C Lammas) – Over-raced in the middle stages. VENT VERT (J Bayliss) - Had some difficulty obtaining clear running early in the final straight.	
Race 8	NEW WORLD MOUNT MAUNGANUI 1400
HASSTOBE PERFECT (R Elliot) – Raced in restricted room shortly after the start losing ground. NOVASHOW (C Lammas) – Began awkwardly. ROCKSPELL (C Grylls) - Slow to begin. Held up for some distance early in the final straight. GET LIT (V Colgan) - Raced three wide without cover in the early stages before obtaining cover leaving the 1000 metres. SPLASH OF RED (A Lawson-Carroll) - Had to be restrained off heels approaching the 800 metres when racing keenly.
