RACE COMMENTS

Race 1 WHANGANUI CHRONICLE MAIDEN 1200

The start of this race was delayed approximately 4 minutes due to the bridle on POPSY ONE having to be replaced.

CALL ME SASSY (L Sutherland) - Slow away.

POPSY ONE (J Kamaruddin) - Began awkwardly. Hung outwards near the 400 metres dictating CRAFTY COLIN and RAURIMU wider. Hung outwards throughout placing the rider at a disadvantage. Connections were advised that POPSY ONE must trial to the satisfaction of Stewards prior to racing next.

ASAHI (L Allpress) - Over-raced and had to be steadied passing the 1000 metres. Trainer R Bergson reported that the gelding had been galloped on during the running and suffered a minor laceration.

CRAFTY COLIN (L Douglas) - Dictated outwards 400 metres.

RAURIMU (M Cropp) - Dictated outwards 400 metres.

TU TANGATA (J Mudhoo) - Made the final bend awkwardly.

CROSSFIRE (S O'Malley) - Performed below market expectations. When questioned rider was of the opinion the filly had held it's breath.

Trainer E Hocquard (POPSY ONE) - Issued with a warning for presenting POPSY ONE in incorrect gear (bit which did not comply with the regulations).

Race 2 WANGANUI INSURANCE BROKERS 1200

HORLISTIC (J Mudhoo) - Began awkwardly settling at the rear. Over-raced through the early and middle stages. Had to be steadied off heels near the 500 metres.

CLICKETY CLICK (A Goindasamy) - Restrained to the rear.

TOBIAS (C Butler) - Lay inwards near the 500 metres having to be straightened.

Race 3 LA NUOVA DRY CLEANERS MAIDEN 1340

LUCIKHAN (J Mudhoo) - Slow away.

PAPA SURF (M Hudson) - Over-raced in the early and middle stages. Dictated inwards 400 metres.

KEVE (M Cropp) - Checked 400 metres.

ZIVJELI (M Sanson) - Raced wide throughout.

J Riddell (HE'S A BATTLER) - Admitted a charge of careless riding in that he permitted HE'S A BATTLER to shift inwards passing the 400 metres dictating PAPA SURF inwards into the line of KEVE, which was checked. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Wednesday, 18 January up to and including racing on Thursday, 26 January, 4 national riding days.

Race 4 G BRISTOL & SONS MAIDEN 1340

TAKE ON (L Sutherland) - Slow away. Improved on to heels and had to be steadied near the 1100 metres. Bumped near 350 metres.

IZZIE'S BEAU (M Cropp) -Made the final bend awkwardly bumping TAKE ON.

LA CAPITA (K Hannan) - Began awkwardly bumping SHOW D'OR. Made the final bend awkwardly bumping SHOW D'OR.

SHOW D'OR (M Hudson) - Bumped at the start. Bumped near 350 metres.

BOURBON FALLS (R Elliot) - Steadied near the 1100 metres.

Race 5 PETER RUBERY CELEBRATES 40 YEARS MAIDEN 1600

MCDREAMY (L Sutherland) - Over-raced in the early and middle stages.

PERFECT TURN (L Allpress) - Over-raced in the early stages.

DERRYAIRE (M McNab) - Raced wide throughout.

OUR MATE REG (K Hannan) - Over-raced having to be steadled near the 1200 metres.

TAHI TAMA (S Weatherley) - Lay inwards having to be straightened on several occasions.

SNEEZE (S O'Malley) - Lay inwards over the concluding stages.

UNSCRIPTED (A Goindasamy) - When questioned into today's improved performance trainer advised the addition of blinkers had been a contributing factor.

A Goindasamy (UNSCRIPTED) - Admitted a charge of breaching Rule 638(3)(g)(i) in that he used his whip once more than permitted prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

Race 6 TRIBUTE TO IAIN HYNDMAN 1600

MY ZOI (L Allpress) - Had to be steadied near the 1400 metres. Lay outwards having to be straightened near the 900 metres.

SHARE POWER (L Douglas) - Lost the off-hind plate during the running.

Race 7 RIVERCITY CABS MAIDEN 2040

PAY WAVE (S O'Malley) - Slow away. Finished last. When questioned rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Connections advised the gelding will no longer be considered a racing proposition from their stable.

AUTARCHY (M McNab) - Hampered at the start. Raced wide through the early stages. Lay inwards near the 100 metres, bumping LOVE NESST. Performed below market expectations. When questioned rider advised the colt had been unsuited by today's track conditions.

WAIPAPA (L Allpress) - Hampered at the start.

LOVE NESST (S Weatherley) - Bumped 100 metres.

MINNIE MOUSE (K Hannan) - Raced wide through the middle stages.

TRIGGER HAPPY (C Butler) - Began awkwardly, hampering runners to its outside. Lay inwards throughout the home straight.

M Cropp (IRRIGATE) - Stewards inquired into the manner in which M Cropp used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

Race 8 HAPPY BIRTHDAY JANICE WEBSTER 2040

PINSK (L Douglas) - Hampered at the start when runners either side shifted ground.

SWING LOW (J Mudhoo) - Slow away. Settled at the rear.

LEGIT (J Riddell) - Over-raced through the early and middle stages having to be steadied.

OCEANIDES (K Hannan) - Raced wide for the majority.

GINGER SNAPZ (J Kamaruddin) - Finished last. When questioned rider advised the mare had over-raced early and had little left at the finish. Trainer advised the mare's future would be reassessed.
