RACE COMMENTS	
Race 1	SVS STARTING GATES MAIDEN 2100
<p>ANNIE (V Colgan) - Began awkwardly. When questioned regarding the performance the rider advised that in his opinion the mare would be better suited dropping back in distance.</p> <p>KING MONDO (T Mitchell) – Over-raced in the early stages when being restrained before being allowed to improve forward from near the 1600 metres to race three wide without cover for the remainder of the race.</p> <p>LIKE IT SWEET (W Kennedy) – Raced three wide without cover until near the 1100 metres.</p> <p>KIWI MAN (C Grylls) - Contacted and forced wider near the 350 metres.</p> <p>SAYAN (C Zackey) - Held up entering the final straight before shifting outwards passing the 300 metres making contact with KIWI MAN which was forced wider.</p> <p>C Lammas (TIZ LOUIE) – Reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.</p> <p>C Zackey (SAYAN) - Issued with a warning after angling his mount outwards near the 350 metres making contact with KIWI MAN which was forced wider. When assessing the incident Stewards took into account slight outward movement from LIKE IT SWEET.</p>	
Race 2	SKYCITY HAMILTON 1500
<p>LA DOLCE VITA (B Rogerson) – Began awkwardly losing ground. Over-raced in the middle stages when the tempo came out of the race, having to be restrained.</p> <p>RUACH (J Riddell) – Began awkwardly.</p> <p>HEART OF GOLD (S Weatherley) – Raced ungenerously in the early stages.</p> <p>KARMAN LINE (C Zackey) – Crowded shortly after the start losing ground. Over-raced in the middle stages when the tempo came out of the race, having to be restrained. Held up in the home straight and was untested over the concluding stages.</p> <p>TE TOKI (C Grylls) – Raced wide without cover throughout.</p> <p>BAD 'N' BOUJ (W Kennedy) – Held up for the entire straight.</p> <p>C Zackey (KARMAN LINE) - Stewards questioned rider C Zackey regarding his ride from near the 400 metres. C Zackey explained that KARMAN LINE was travelling well and after a run didn't appear to his outside early in the final straight, he made the decision to improve towards the rail where the mare quickly improved onto heels inside of HEART OF GOLD and from that stage, he had no option to improve. Stewards noted C Zackey's explanation.</p>	
Race 3	WAIKATO STUD WINNERS CIRCLE MAIDEN 3YO 1300
<p>CLAIRIERE (T Mitchell) – Slow to begin, then restrained soon after the start. Raced keenly in the middle stages.</p> <p>STRONG (W Kennedy) - Slow to begin, then restrained soon after the start. Steadied to avoid heels near the 700 metres. Had some difficulty obtaining clear running early in the final straight.</p>	

GOOD TIME GARRY (M McNab) - Improved onto heels near the 700 metres having to be firmly restrained dropping back onto **STRONG** which to steady to avoid heels.

GRAND CRU (K Hannan) - Raced three wide without cover throughout.

PAID A DOLLAR (R Elliot) - Ducked outwards abruptly passing the 350 metres.

Following this race, the track was upgraded to Good 3.

Race 4 | **LEGENDS DAY 11 FEB MAIDEN 1400**

TIDAL RUSH (T Thornton) - Slow to begin. Had some difficulty obtaining clear running early in the final straight. Had to be steadied approaching the 150 metres after **ROEDERER** shifted out making contact then raced in restricted room for a distance approaching the 100 metres. M McNab was advised to exercise care in similar circumstances.

MYLA (A Goindasamy) - Began awkwardly.

LAMBRUSQUET (S Weatherley) - Began awkwardly losing ground. Had some difficulty obtaining clear running early in the final straight.

OMINOUS (W Kennedy) - Began awkwardly.

CIMARRON (J Doyle) – Raced three wide without cover throughout. Dislodged rider J Doyle when pulling up. J Doyle was attended to by oncourse ambulance personnel and found to be uninjured.

PATRICIA (L Satherley) – Raced wide early before improving to sit outside the leader near the 1100 metres.

ROEDERER (M McNab) - Held up until near the 200 metres.

Race 5 | **FAIRVIEW MOTORS MAIDEN 1400**

MARKET PLACE (J Fawcett) - Slow to begin then bucked for a short distance passing the 1300 metres losing ground. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

READY EDDIE GO (J Kamaruddin) – Slow to begin then crowded shortly after.

MYLETT (T Thornton) - Began awkwardly losing ground. Held up until near the 100 metres.

PADDY WAGON (T Abel) - Raced three wide without cover throughout.

BLUE SKY AT NIGHT (A Goindasamy) – Held up throughout the final straight.

STAGE THREE (S Weatherley) - Held up early in the final straight.

KEREOPA (K Hannan) - Had some difficulty obtaining clear running early in the final straight.

KIWI'S CRUISIN (C Grylls) - Was unable to maintain contact with the body of the field in the early and middle stages despite the urgings of its rider. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality. Connections were advised that a warning would be placed against the gelding's performance.

Race 6 | **NZB KARAKA 2023 TRAINERS SERIES MAIDEN 1100**

FAIRY STEPS (T Newman) - Began awkwardly.

MS CANDEE LANE (T Thornton) – Raced in restricted room shortly after the start.

LONG GAME (C Lammas) - Began awkwardly.

MARY ELIZABETH (A Lawson-Carroll) – Began awkwardly losing ground.

WHATS THE ONE CODE (T Mitchell) - Raced ungenerously in the early stages when being restrained.

LUCKY CHARM (V Colgan) - Over-raced when being restrained leaving the 900 metres. Had to be steadied passing the 800 metres to avoid heels.

AMOROUS STU (J Doyle) - Raced three wide without cover throughout.

T Newman (FAIRY STEPS) - Issued with a warning after permitting her mount to shift in when not sufficiently clear of LUCKY CHARM which had to be steadied passing the 800 metres.

Race 7 | **BCD GROUP MILE 1600**

ALL THE RAGE (B Rogerson) – Slow to begin.

BUGATTI (W Kennedy) - Slow to begin then restrained in the early stages.

PENTARA (A Lawson-Carroll) - Over-raced in the early stages.

TEXAS (J Bayliss) - Over-raced in the middle stages.

CORISTA (K Hannan) – Raced three wide without cover throughout.

VADAMOS STAR (J Doyle) - Raced wide without cover from near the 800 metres. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions.

POSTER BOY (T Mitchell) - Held up until near the 150 metres.

J Bayliss (TEXAS) - Admitted a charge in that he used his whip in two consecutive strides on his mount TEXAS near the 50 metres with the Adjudicator imposing a fine of \$500.

Race 8 | **ALEXANDRA RC PIRONGIA CUP 2100**

GOOD OIL (A Lawson-Carroll) – Began awkwardly contacting the barrier.

STRINGLINE (T Thornton) - Over-raced in the early stages.

DAYDREAM BELIEVER (M Hashizume) - Over-raced in the early stages. Held up until near the 250 metres.

SHOCKALLIA (K Hannan) - Raced three wide without cover throughout. Steadied when placed in restricted room passing the 350 metres.

DIVINE SAVA (C Barnes) – Raced ungenerously for a distance approaching the 1400 metres. Inconvenienced passing the 350 metres when STRINGLINE shifted out when not fully clear. T Thornton was advised to exercise greater care in similar circumstances.

MIGHTY CONNOR (N Parmar) - Steadied when placed in restricted room passing the 350 metres.

TARWYN (R Elliot) - Improved onto heels near the 250 metres having to be steadied.

TIA D'OR (C Zackey) - When questioned regarding the performance the rider advised that when placed under pressure early in the final straight the mare had felt indifferent in its action so he elected not to persevere over the concluding stages. Underwent a post-race veterinary examination which found the mare to have a slower than normal recovery.

O Bosson (SUPER SIX) - Issued with a warning after permitting his mount to shift in passing the 350 metres when not sufficiently clear of MIGHTY CONNOR and SHOCKALLIA which both had to be steadied when placed in restricted room.

Race 9	WAIKATO DRAUGHT MAIDEN MILE 1600

SEYDOUX (J Fawcett) - Raced in restricted room shortly after the start.

ANDALUS (C Zackey) – Began awkwardly. Held up until near the 300 metres.

SUNDAY FEVER (K Hannan) – Began awkwardly. Over-raced in the early stages when being restrained. When questioned regarding the performance the rider could offer no excuse.

GINGE 'N' WINGE (J Doyle) – Raced three wide without cover throughout. Returned to the enclosure with blood present in both nostrils. Following a veterinary examination GINGE 'N' WINGE was confirmed to have bled. GINGE 'N' WINGE shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

STYX (W Pinn) - Steadied when placed in restricted room when racing to the outside of LIGHT OF PLUTUS which shifted out slightly and inside of AMBERITE which was dictated inwards by ANDALUS near the 50 metres. Both C Zackey and C Grylls were advised to exercise greater care in similar circumstances. When questioned regarding the performance the rider advised that the gelding had been unsuited by today's track conditions.

Race 10	RACE A HORSE WITH TE AKAU MAIDEN MILE 1600

DANZA (W Kennedy) – Reared as the start was initiated getting its head over the partition to the inside and as a result took no competitive part in the race. Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.

SUPER LOVE DRAGON (J Bayliss) – Began awkwardly losing ground. Held up until near the 200 metres.

HIGH CURRENCY (C Zackey) – Had some difficulty obtaining clear running early in the final straight.

KAIDU'S PRIDE (N Parmar) – Firmly contacted then unbalanced near the 350 metres. Contacted and forced wider near the 225 metres. Came together with SKY DANCER passing the 150 metres when both runners shifted ground.

SKY DANCER (C Grylls) - Contacted and forced wider near the 350 metres. Came together with KAIDU'S PRIDE near the 150 metres when both runners shifted ground.

ARKADUS (R Elliot) - Forced wider near the 350 metres.

SAMUEL LANGHORNE (W Pinn) - Shifted out slightly passing the 225 metres with BURGUNDY IFF shifting out and away making contact with KAIDU'S PRIDE which was forced wider.

Following the running of this race connections of the 2nd placed horse KAIDU'S PRIDE lodged a protest alleging interference in the final straight by the winner BURGUNDY IFF. After hearing evidence and considering submissions the Adjudicator dismissed the protest with placing standing BURGUNDY IFF 1st, KAIDU'S PRIDE 2nd, SKY DANCER 3rd, SAMUEL LANGHORNE 4th.

J Doyle (BURGUNDY IFF) - Admitted a charge of careless riding in that he angled his mount outwards when not sufficiently clear of KAIDU'S PRIDE which was contacted and unbalanced near the 350 meters. Also hampered as a result was SKY DANCER. After considering submissions the Adjudicator imposed a suspension of J Doyle's licence to ride in races from the conclusion of racing on Saturday 28th January up to and including racing on Monday 6th February, 5 national riding days.

Race 11	SEE YOU @ TE RAPA TAVERN MAIDEN MILE 1600

SAGACIOUS (R Elliot) - Began awkwardly losing ground.

KAJITSU (C Lammas) - Began awkwardly then crowded shortly after having to be steadied.

PERSUADER (J Doyle) – Raced three wide without cover throughout. Came together with PHANTOM DRAGON passing the 100 metres when both runners shifted ground.

PREFERENTIAL (V Colgan) - Held up rounding the final bend.

JOYFUL WINKLE (W Kennedy) - Raced greenly having to be steadied when placed in restricted room passing the 200 metres to the inside of RAVEN which shifted in and away from PHANTOM DRAGON. Contributing was outward movement from GROOMSMAN.

PHANTOM DRAGON (J Bayliss) – Came together with PERSUADER passing the 100 metres when both runners shifted ground.

PENURIOUS (W Pinn) - When questioned regarding performance the rider advised that in his opinion the filly would benefit from a step up in distance.
