Race 3	KIWI MAIDEN 1000

JUST BEN (K Hannan) - Removed from its barrier, underwent a pre-race veterinary examination and cleared to start.

LA BELLA NERA (T Mitchell) - Began awkwardly hampering BELLA DA PARTY. Put in a rough stride near the 400 metres becoming unbalanced. Shifted out under pressure throughout the home straight.

BELLA DA PARTY (K Hercock) - Hampered shortly after the start.

ALPINO (L Allpress) - Crowded shortly after the start when runners either side shifted ground and as a result lost ground. Rider advised that in her opinion the mare would benefit from a step up in distance on a more rain-affected track.

JOHNNIE KASTLE (A Lawson-Carroll) - Rider dropped his right rein approaching the 350 metres, with the rider becoming unbalanced when regathering the rein.

LINCOLN VALLEY (A Goindasamy) - Hung throughout the running. Raced greenly throughout the final straight with NINJA TURTLE being hampered near the 250 metres. A Goindasamy was shown footage of his ride and advised he is expected to straighten his mount soon than he did on this occasion.

NINJA TUTRLE (A Mudhoo) - Hampered 250 metres.

UNLEASHED (C Butler) - Shifted out under pressure throughout the home straight.

EXTRAORDINAIRE (S O'Malley) - Shifted out under pressure throughout the home straight.

Race 4 GREAT SENSATION 1000

FIBONACCI (L Hemi) - Late scratching at 1.57pm in the tie-up stall area on veterinary advice. Connections were advised that a veterinary clearance is required prior to FIBONACCI racing next.

BURGUNDY ROSE (K Hannan) - Slow to begin.

MEGA BOURBON (C Barnes) - Slow to begin.

BRADMAN (T Mitchell) - Raced ungenerously for a distance passing the 800 metres.

LINCOLN'S KRUZ (L Sutherland) - Lost the off-fore plate during the running.

Race 5 CASTLETOWN 1200

PISCO SOUR (K Hannan) - Began awkwardly losing ground.

VISHAKHA (S O'Malley) - Crowded shortly after the start losing ground.

SIDE BY SIDE (A Goindasamy) - Restrained behind runners shortly after the start to obtain cover.

LILHOOVESGOTMOVES (C Barnes) - Ducked inwards abruptly making contact with the hind quarters of TANZANITE ROSE, which became unbalanced, near the 1150 metres.

TANZANITE ROSE (C Butler) - Contacted and unbalanced 1150 metres.

MAHOE (L Sutherland) - Had to be steadied when becoming awkwardly placed on the heels of TANZANITE ROSE (C Butler), which shifted in when not fully clear approaching the 800 metres. Lost the offside hind plate during the running.

FREE BEE (T Mitchell) - Ducked in and away from TANZANITE ROSE passing the 400 metres.

C Butler (TANZANITE ROSE) – Admitted a charge of breaching Rule 638(3)(g)(i) in that she used her whip once more than permitted prior to the 100-metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

C Butler (TANZANITE ROSE) – Issued with a warning for allowing her mount to shift inwards when not fully clear of MAHOE, which had to be steadied approaching the 800 metres.

Race 6 GOOD LORD 2100

VIDIANO – T Mitchell replaced F Lazet.

OPAWA JACK (L Sutherland) - Underwent a pre-race veterinary examination behind the barrier and was cleared to start.

THE TRUE BELIEVER (K Hannan) - Contacted then crowded shortly after the start when runners either side shifted ground and as a result lost ground.

NEST EGG (C Barnes) - Blundered at the start and was then hampered, losing ground.

DIVINE SPIRIT (A Mudhoo) - Slow to begin. Finished well back. Rider had no excuse. A post-race veterinary examination did not reveal any obvious abnormality.

RISCHIO (L Allpress) - Restrained behind runners shortly after the start to obtain cover.

RUFFHOUSE ROSIE (A Goindasamy) - Had to steady when being placed in restricted room after OPAWA JACK (L Sutherland) shifted outwards when not fully clear passing the winning post on the first circuit simultaneously as TORQUE TIME (S O'Malley) shifted inwards. L Sutherland and S O'Malley were advised to exercise greater care. Overraced in the back straight.

BEAR GRYLLS (C Lammas) - Three wide without cover throughout.

TORQUE TIME (S O'Malley) - Commenced to give ground early in the home straight, finishing some distance last. Exhibited a slow recovery after undergoing a post-race veterinary examination. Connections will monitor TORQUE TIME over coming days and report any anomalies to Stewards.

AMATHUSIA (K Hercock) - Had to steady off the heels of the tiring TORQUE TIME near the 600 metres prior to being angled outwards to improve. Had to steady off the heels of WENEEDASHOCK (R Mudhoo) near the 200 metres, when that runner shifted inwards when not clear. R Mudhoo was issued with a warning. Stewards took into account simultaneous outward movement from THE TRUE BELIEVER (K Hannan) when assessing the interference. K Hannan was advised to exercise greater care. THE SEAGULL was also tightened in the movement.

THE SEAGULL (D Bradley) - Tightened near the 200 metres.

R Mudhoo (THE TRUE BELIEVER) - Issued with a warning after allowing his mount to shift inwards near the 200 metres.

C Lammas (BEAR GRYLLS) - Stewards inquired into the manner in which C Lammas used his whip in the home straight and could not be conclusively satisfied that he had contravened the rule.

 BELARDO BOY (L Sutherland) - Began awkwardly. Raced three-wide without cover throughout.

CRUZ RAMIREZ (L Allpress) - Placed in restricted room shortly after the start, having to steady, losing ground.

MEHRTENS (A Mudhoo) - Contacted at the start losing ground.

Race 8 IL TEMPO 1600

RED HUSSAR (K Hannan) - Began awkwardly losing ground.

LOVE LETTER (L Sutherland) - Buffeted shortly after the start losing ground.

MORMAIRE (S O'Malley) - Restrained behind runners shortly after the start to obtain cover.

PRIDE OF ASPEN (L Allpress) - Shifted outwards near the 200 metres simultaneously as GEEZAS GEORGE was attempting a narrow run to its outside. This resulted in GEEZAS GEORGE having to shift ground inwards to improve. After questioning riders L Allpress was advised to exercise greater care. Hampered over the final 100 metres when BOSTON STRONG BOY (T Newman) shifted ground outwards when not clear. T Newman was shown footage of her ride and issued with a warning.

WELL I NEVER (C Barnes) - Finished back. When questioned C Barnes advised the mare had been disappointing.

 BATTLE HEIGHTS 1400

 GUCCI BELT (L Sutherland) - Underwent a pre-race veterinary examination behind the barrier and was cleared to start.

REGAL REWARD (K Hannan) - Underwent a pre-race veterinary examination behind the barrier and was cleared to start.

ARCADIAN IYNX (C Lammas) - Underwent a pre-veterinary examination behind the barrier and was cleared to start. Began awkwardly losing ground. Commenced to race ungenerously getting its head up on a number of occasions through the early and middle stages. C Lammas reported the mare failed to perform after being worked up behind the barrier and in his opinion may improve with the run.

SCELTA DI ELENA (L Douglas) - Began awkwardly becoming awkwardly placed on heels having to be steadied, and as a result lost ground.

SEA MONARCH (T Newman) - Raced wide without cover throughout.
