#### GENERAL

Following Race 3, **K Mudhoo** was attended to by St John Paramedics and stood down from his remaining rides following direction that he take on fluid after suffering dehydration.

**B Murray** (CHEYENNE DREAMS) - Admitted a charge in that he failed to make the contracted weight for CHEYENNE DREAMS in Race 10 and was replaced as per Summary above, with the Adjudicator imposing a fine of \$100 under the Minor Infringement Schedule.

#### SUPPLEMENTARY

**STALLION TENDER OPEN NOW R75 1600 METRES**

After advising stewards that **JIN LU** which bled during the running would be retired, trainer L Didham advised it is now his intention to give the gelding another campaign.

#### RACE COMMENTS

##### Race 1 GRAND CASINO MAIDEN 1400m

**FAYE'S WARRIOR** (K Hannan) - Slow to begin. Held up over the final 100 metres and went to the line not fully tested by the rider.

**VANITY** (R Mudhoo) - Began awkwardly losing ground and then restrained shortly after the start to obtain cover. Shifted ground outwards across heels passing the 250 metres to find clear racing room.

**TWILIGHT GEM** (L Callaway) - Began awkwardly losing ground and then restrained shortly after the start to obtain cover.

**OREPUKI RIPPER** (J Lowry) - Raced keenly through the early and middle stages.

**WAYNES RUBY** (T Moseley) - Lay out throughout the run home.

##### Race 2 CROMBIE LOCKWOOD INSURANCE BROKERS MAIDEN 1400m

**TAIL LIGHTS** (K Chowdhoory) - Began awkwardly and was then contacted and crowded shortly after the start losing ground.

**RAGHALLAIGH** (B May) - Began awkwardly shifting in making contact with TAIL LIGHTS. Placed in restricted room having to steady near the 375 metres.

**BENJI'S BOY** (K Asano) - Slow to begin. When questioned regarding performance rider advised in his opinion the gelding would benefit from some easing in track conditions.

**MUMBO JUMBO** (R Mudhoo) - Was restrained behind runners to obtain cover shortly after the start. Lay in briefly rounding the final bend.

**SIT DOWN DEAR** (J Fawcett) - Raced three wide without cover throughout.

**BORNHOLM** (B Murray) - Raced keenly through the early and middle stages. When questioned regarding performance, rider advised that something felt amiss with the gelding. A post-race veterinary examination showed the gelding to be suffering minor heat stress.

**MISS OTIS REGRETS** (C Barnes) - Stopped quickly in the run home with the rider advising that the mare had been very disappointing and feeling that something may have been amiss. A post-race veterinary examination showed the mare to be suffering minor heat stress.

**PAR TEE** (T Moseley) - Held up by a tiring runner passing the 200 metres.

**K Chowdhoory** (TAIL LIGHTS) - Issued with a warning after permitting his mount TAIL LIGHTS to shift outwards placing RAGHALLAIGH in restricted room which had to steady passing the 375 metres. In assessing this penalty Stewards took into account some movement from MUMBO JUMBO which was laying in at the time.

<b>Race 3</b>	<b>TARGET ACCOUNTING 1400m</b>

**HENRY HUBBER** (C Barnes) - Slow to begin.

**CHOUX IN** (K Kalychurun) - Began awkwardly losing ground.

**GLOBAL BEAUTY** (B May) - From its wide barrier was restrained behind runners shortly after the start to obtain cover.

**CAPO DELL IMPERO** (J Lowry) - From its wide barrier was restrained behind runners shortly after the start to obtain cover.

**JEWEL OF PATCH** (H Kamaruddin) - Commenced to race keenly through the early and middle stages. Raced three wide without cover throughout. Shifted out under pressure throughout the home straight.

**TRADITION** (R Beeharry) - Raced wide without cover from the 800 metres.

**STELLA CREEK** (S Muniandy) - Held up entering the final bend having to shift outwards across heels to obtain clear running passing the 350 metres.

**LASER'S FURY** (K Chowdhoory) - Had to be briefly steadied after becoming awkwardly placed on the heels of KING COUGAR (T Newman) which shifted out when not fully clear near the 300 metres. T Newman was advised to exercise greater care when shifting ground.

**KAPINOS** (K Hannan) - When questioned regarding the performance of this favoured runner, rider advised that being challenged for the lead for the majority of the race had been detrimental to the gelding's chances today.

**H Kamaruddin** (JEWEL OF PATCH) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height on 3 occasions. After considering submissions the Adjudicator imposed a fine of \$250.

Following the running of this race the Judge incorrectly called 3<sup>rd</sup> and 4<sup>th</sup> placings in the wrong order. This was quickly rectified prior to dividends being declared.

<b>Race 4</b>	<b>PROPERTY BROKERS DUNEDIN 1200m</b>

**CHOKITO** (J Kamaruddin) - Underwent a pre-race veterinary examination at the start area at the request of the rider and was cleared to race.

**IHU** (K Chowdhoory) - Bounded at the start unbalancing the rider who was dislodged inside the gates, with the horse continuing riderless. Following the running of the race Stewards enquired into the reasons why IHU's rider was dislodged at the start. After hearing evidence from the Starter and connections, Stewards deemed that the incident was attributable to the gelding's barrier manners. The connections were advised that IHU must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**RADIANT ROSIE** (B May) - Began awkwardly losing ground.

**GIVEHERAGO** (C Barnes) - Raced keenly through the early and middle stages.

**SO NATURAL** (K Asano) - Had to be firmly restrained when hampered by the riderless horse near the 900 metres.

**EPTIMUM** (J Fawcett) - Raced wide through the early stages and then improved forward to lead. Hampered by the riderless horse passing the 500 metres.

**REDFORD** (T Newman) - Held up until inside the final 100 metres when attempting a marginal run to the inside of EMANON.

**EMANON** (S Toolooa) - When questioned regarding the performance of this favoured runner, rider advised that the mare had been disappointing when placed under pressure.

<b>Race 5</b>	<b>NELLIES BAR AND RESTAURANT DUNEDIN GUINEAS 1500m</b>

**ELSIE MAY** (K Williams) - Began awkwardly losing ground. Was inclined to lay inwards in the run home and was then held up from the 200 metres and went to the line not fully tested by its rider.

**SESTINA** (T Newman) - Slow to begin.

**JAFFA** (T Moseley) - Slow to begin. Held up in the run home having to shift ground outwards near the 75 metres to find clear racing room.

**CORRECTION** (L Callaway) - From its wide barrier draw was restrained behind runners to obtain cover shortly after the start.

**HAGGLE** (C Barnes) - Raced wide through the early and middle stages.

**CHARBANO** (K Asano) - Raced wide from the 600 metres.

**BETTY SPAGHETTI** (K Chowdhoory) - Had some trouble gaining clear racing room until inside the final 100 metres.

**SPECIALTY** (B May) - Lay inwards in the run home and near the 200 metres shifted in inconveniencing ROMANCING THE MOON.

**ROMANCING THE MOON** (H Kamaruddin) - Inconvenienced near the 200 metres.

<b>Race 6</b>	<b>DUNEDIN CITY MOTORS 2200m</b>

**J & K Parsons** (COLOSSAL & HEY HICKEY) - Issued with a warning after presenting their two runners late in the birdcage.

**S Kennedy & A Furlong** (THE BOLD LIONESS) - Fined \$50 under the Minor Infringement Schedule after presenting runner with incorrect saddle cloth.

**NOBLE KNIGHT** (J Lowry) - Declared a late scratching by order of Stewards at 2.41pm after dislodging its rider during the preliminary and galloping riderless for some distance before being recaptured. J Lowry was uninjured in this incident. As a result the start of this race was delayed approximately 7½ minutes.

**KING OF THE DANCE** (B May) - Slow to begin.

**SAVVY MAN** (K Chowdhoo) - Began awkwardly losing ground then commenced to over race when being restrained to obtain cover in the early stages.

**POMANDER** (J Fawcett) - Began awkwardly losing ground. Raced three wide without cover through the middle stages.

**MADISON ROSE** (T Moseley) – From its wide barrier draw was restrained behind runners to obtain cover shortly after the start. Held up over the concluding stages going to the line not fully tested by its rider.

**HEY MICKEY** (T Newman) - Raced keenly through the early and middle stages.

**GOING STEADY** (J Kamaruddin) - Held up through the middle stages of the run home and had to shift ground outwards across heels passing the 175 metres to find clear racing room.

**CAGE PHYTA** (K Williams) - Had some difficulty obtaining clear running in the middle stages of the run home.

**EULOGY SHOW** (C Barnes) - Finished a distant last. Rider could offer no explanation. A post-race veterinary examination did not reveal any obvious abnormality.

**THE BOLD LIONESS** (K Asano) - When asked to comment on performance, rider advised he had a nice run throughout but when placed under pressure the mare had failed to respond and had been disappointing, adding that it may not have backed up from its run last week.

<b>Race 7</b>	<b>POSITIVE SIGNS + PRINT DUNEDIN GOLD CUP 2400m</b>

**KILOWATT** – Declared a late scratching at 1.31pm on veterinary advice after suffering an injury in the float enroute to the racecourse and was treated by the Veterinarian for the injury.

**WANNABE ‘N’ PARIS** (B May) - Lost a small saddle pad shortly after the start, with the rider weighing in at the correct weight.

**EKSTREMEMISS** (T Newman) - Slow to begin. Raced wide without cover from the 800 metres when attempting to improve.

**ILLICIT MISS** (H Kamaruddin) - Slow to begin. Raced in restricted room passing the 375 metres having to shift ground outwards near the 200 metres to find clear racing room. Was then inclined to lay in for the remainder of the run home and was held up over the concluding stages going to the line not fully tested by its rider. Post race was found to have suffered a suspensory injury to the left foreleg. A stable representative was advised a veterinary clearance will be required prior to racing next. Connections advised they would be reassessing the racing future of the mare.

**SADLER’S LASS** (K Hannan) - Slow to begin.

**LEAVE IT TO ME** (T Moseley) - After being initially slow to begin was taken back from a wide draw to obtain cover. Lay in throughout the run home.

**SECOND THOUGHT** (K Chowdhoo) - Began awkwardly shifting out crowding RIVIERA ROCK.

**RIVIERA ROCK** (L Callaway) - Crowded at the start losing ground.

**DUNHILL** (R Mudhoo) - Improved wide from the 1100 metres. Lost the off fore plate during the running.

**LETSBRINGITON** (K Williams) - Lay inwards rounding the final bend and early in the run home placing **ILLICIT MISS** in restricted room for a short distance near the 375 metres.

<b>Race 8</b>	<b>STEVE ANDERTON MEMORIAL 1200m</b>

**SHE'S AN ACE** – Declared a late scratching at 1.14pm on veterinary advice.

**PLAY THE FIELD** (J Mudhoo) - Began very awkwardly making contact with **THE NUMBER ONE SON** and as a result lost considerable ground. Improved quickly onto the heels of **THE NUMBER ONE SON** which was giving ground having to be firmly restrained near the 800 metres.

**THE NUMBER ONE SON** (R Mudhoo) - Contacted at the start. Over raced through the early and middle stages. Commenced to give ground quickly passing the 800 metres and was eased down by its rider due to the saddle slipping backwards, considerably placing the rider at a disadvantage.

**THE GOOD SHEPHERD** (K Kalychurun) - Began awkwardly losing ground.

**ZOULANDER** (K Chowdhoory) - Began awkwardly losing considerable ground. Rider K Chowdhoory was reprimanded after weighing in .4 kg under his weigh out weight which is within the accepted tolerance.

**KERANY** (B Murray) - Crowded shortly after the start losing ground when runners either side shifted ground.

**AUNT CINDY** (S Toolooa) - Raced wide without cover for the majority of the race.

**MARYWEKA** (K Hannan) - When asked to comment on the performance of this favoured runner, the rider was unable to offer any tangible excuse.

<b>Race 9</b>	<b>WHITE ROBE LODGE 1600m</b>

**LIVE DRAMA** (K Chowdhoory) - Slow to begin. Held up early in the run home, only gaining clear racing room inside the final 225 metres.

**ROCK SENSATION** (K Asano) - Began awkwardly shifting out hampering **AVAQUINELLA**.

**AVAQUINELLA** (K Hannan) - Hampered shortly after the start.

**EXCHANGE** (J Lowry) - Began awkwardly losing ground.

**PERFECT SCENARIO** (J Kamaruddin) - Blundered shortly after the start losing ground.

**CAMINO ROCOSO** (T Newman) - Over raced in the early to middle stages.

**PRISE DE FER** (J Laking) - Held up over the concluding stages when beaten. When asked to comment on the performance of this favoured runner, rider advised that the gelding had been flat throughout and had been disappointing when placed under pressure, particularly in the run home. A post-race veterinary examination revealed no obvious abnormalities. Stewards will follow up with connections in coming days.

**B May** (GREEN LUCK) - Admitted a charge in that he struck his mount GREEN LUCK 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$550.

**Race 10**

**ODT SOUTHERN MILE QUALIFIER 1600m**

**POWERLITE** (K Williams) - Declared a late scratching on veterinary advice at 5.06pm after losing a plate and standing on a nail which caused a laceration and severe lameness. Connections were advised that a veterinary clearance will be required prior to trialling or racing next.

**THE TUI TOILER** (G Jogoo) - Began awkwardly losing ground.

**CHEYENNE DREAMS** (R Mudhoo) - Began awkwardly losing ground.

**UNUSUAL AFFAIR** (T Moseley) - Slow to begin.

**HUGH GLASS** (R Beeharry) - After initially being slow to begin was obliged to race wide without cover throughout.

**POVERTY BAY** (J Laking) - Crowded shortly after the start when runners on either side shifted ground, losing ground as a result.

**TOMYTURBO** (K Chowdhoory) - From its outside barrier was restrained behind runners to obtain cover shortly after the start.

**ROSY CLARK** (C Campbell) - Raced three wide without cover throughout and near the 250 metres lay out briefly contacting LA OPCION.
