RACE COMMENTS

Race 1 KURIPUNI SPORTS BAR AND TAB MAIDEN 1000m

NASSAU (S O'Malley) - Reared and slow away after being fractious in the barriers. Connections were advised a warning has been placed on the colt's barrier manners.

RUN RABBIT RUN (K Hannan) - Hampered when runners either side shifted ground.

MISS LILLY (A Mudhoo) - Over-raced, having to be steadied passing the 800 metres.

SILVER MUSK (W Kennedy) - Rider reported the colt had raced greenly and hung throughout.

Race 2 HERBERT MORTON ACCOUNTANTS 2YO MAIDEN 1000m

TULSI (M McNab) - Hampered at the start when CHERISHED LADY began awkwardly. Over-raced in the early and middle stages when wide.

CHERISHED LADY (L Sutherland) - Began awkwardly.

CHANTILLY LACE (K Hannan) - Held up having to angle outwards inside the final 100 metres to gain clear racing room.

LANGMORE (C Grylls) - Bumped and became momentarily unbalanced near the 300 metres when NO RAIN EVER was angled into clear running. Disappointed finishing well back. When questioned rider was of the opinion there was something amiss with the filly. A post-race veterinary examination revealed the filly to have suffered cardiac arrhythmia. Trainer J Bary was advised that LANGMORE will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of 1000 metres.

Race 3 SOUTH WAIRARAPA VETERINARY SERVICES 1000m

RUM (M Hudson) - Restrained to the rear.

SHOW US MORE (M McNab) - Briefly held up early in the home straight.

HAVARTI (C Grylls) - Finished towards the rear. When questioned rider could offer no excuse but was of the opinion the gelding would derive benefit from today's race.

GRACIE LEE (K Hercock) - Disappointed, finishing towards the rear. When questioned rider was of the opinion the mare may be better suited to being ridden back off the pace.

O Bosson (GRACE 'N' GREY) - Issued with a warning after using the whip in 2 consecutive strides on GRACE 'N' GREY near the finish with Stewards taking in to account his clear recent record under this section of the rule.

Race 4 POPE & GRAY CONTRACTORS MAIDEN 1300m

CALL ME SASSY (R Elliot) - Slow away. Improved onto the heels of the weakening APOLLYON, having to be angled outwards passing the 200 metres.

PEGAU (W Kennedy) - Began awkwardly, settling towards the rear.

VICTORTHEINFLICTOR (S O'Malley) - Raced wide throughout.

GRAEME JOHN (K Hercock) - Lay outwards rounding the final bend.

APOLLYON (A Goindasamy) - Commenced to weaken near the 300 metres.

LA BELLA GRANDE (O Bosson) - Disappointed, finishing towards the rear. O Bosson advised the mare had raced greenly throughout when changing legs on a number of occasions and when placed under pressure near the 400 metres had failed to respond advising Stewards that something may be amiss. A post-race veterinary examination did not reveal any obvious physical abnormality however a hind plate had become displaced. Trainer R Bergerson advised that LA BELLA GRANDE would undergo further tests on return to his stable and he would provide Stewards with an update, including the results of an endoscopic examination.

Race 5 CRIGHTON ITM GREYTOWN MAIDEN 2050m

WAIPAPA (O Bosson) - Restrained to the rear from its wide draw.

MOMENTS LIKE THESE (A Mudhoo) - Raced ungenerously throughout.

BILLY EASTON (S O'Malley) - Raced wide without cover throughout. Bumped near the 120 metres.

RACCOURCI (M McNab) - Bumped near the 120 metres.

KATTEGAT (C Grylls) - Held up early in the home straight and then lay outwards near the 120 metres bumping BILLY EASTON which in turn bumped RACCOURCI. C Grylls was advised to exercise care.

TICKFORD (L Hemi) - Raced in restricted room approaching the 100 metres and went to the line untested. Lost the off-hind plate during the running.

BEAUTIFUL NOISE (R Elliot) - Raced in restricted room early in the home straight.

Race 6 HAPPY HIRE WAIRARAPA CUP 2050m

TRAV (L Sutherland) - Fractious in the barriers, getting its head over the next barrier stall immediately as the start was made, resulting in TRAV losing considerable ground. Prior to the authorisation of dividends, Stewards viewed footage of the start but were satisfied that TRAV had not been denied a fair start.

SCUTAR (K Hannan) - Made the first bend awkwardly. Over-raced, having to be steadied passing the 1400 metres.

FIERCE FLIGHT (O Bosson) - Inclined to lay inwards in the home straight and shifted inwards abruptly hampering LINCOLN STAR when struck with the whip near the 100 metres prior to being straightened.

LINCOLN STAR (J Riddell) - Hampered near the 100 metres.

HE NO OPILIO (T Allan) - Lay outwards under pressure over the concluding stages. A post-race endoscopic veterinary examination revealed the gelding to have bled. HE NO OPILIO shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian with a veterinary clearance provided.

LAVITA VISHVI (C Grylls) - Finished towards the rear. C Grylls could offer no excuse.

RED HUSSAR (R Elliot) - Finished last. R Elliot had no excuse. Underwent a post-race veterinary examination which did not reveal any abnormalities. Connections advised the gelding's future would be reassessed.

Race 7 CLUBS NZ WAIRARAPA THOROUGHBRED BREEDERS STAKES 1600m (Listed Race)

BELLE EN ROUGE (O Bosson) - Slow away. Disappointed, finishing towards the rear. When questioned, rider advised that after being slow away the mare had failed to respond when placed under pressure in the home straight and was disappointing. A post-race veterinary examination revealed the mare to be 1/5 lame in the left hind and sustained a

cut to the left hind fetlock. Connections were advised BELLE EN ROUGE will require a veterinary clearance prior to racing next.

BINGWA (C Grylls) - Slow away.

TAMAHINE (M Cropp) - Hampered at the start.

BURITZ (C Barnes) - Blundered at the start, hampering TAMAHINE. Over-raced through the early and middle stages. Raced wide throughout.

BELCLARE (M McNab) - Held up in the home straight until inside the 100 metres

PODIUM (S Weatherley) - Lay outwards away from a runner to its inside over the concluding stages becoming awkwardly placed on the heels of LES CRAYERES near the finish having to steady.

LES CRAYERES (R Elliot) - Lay inwards near the finish.

LOVE TO ALL (K Hercock) - Lost the near hind plate during the running.

Race 8 NZB INSURANCE PEARL SERIES RACE 1600m

HARMONIOUS (K Hannan) - Late scratching at the barrier at 4.32pm on veterinary advice when the mare was found to be lame after receiving a kick to the left shoulder. A veterinary clearance will be required prior to racing next.

KNICKERLESS (L Hemi) - Restrained to the rear from its wide draw. Shifted inwards under pressure over the concluding stages.

LIFFEY (S Weatherley) - Raced wide without cover throughout.

RIBBONS (M McNab) - Held up through the home straight, going to the line without being fully tested.

MAZZINI (L Sutherland) - Jostled for some distance in the home straight with RIBBONS, which was held up when attempting to obtain a run. Stewards took into account inward movement from KNICKERLESS (L Hemi) when assessing the interference. However, both L Hemi and M McNab were advised to exercise greater care when in similar circumstances.

PATRIARCA (W Kennedy) - When questioned rider advised the mare had hung throughout and failed to respond when placed under pressure. Underwent a post-race veterinary examination which revealed the mare to be 1/5 lame in the right hind. Connections were advised PATRIARCA will require a veterinary clearance prior to racing next.

Race 9 CHATHAM ISLANDS JOCKEY CLUB MAIDEN 1600m

CRACKERJACK (L Hemi) - Restrained to the rear from its wide draw. Finished well back. When questioned rider advised the gelding was not suited by the fast tempo of today's race and failed to make up any discernible ground in the home straight.

ME (K Hercock) - Began awkwardly bumping DIAL A PRINCE.

DIAL A PRINCE (C Butler) - Bumped at the start.

BELCAMINA Began awkwardly, hampering KRONE.

KRONE (T Taiaroa) – Hampered at the start.

UNUSUAL PEARL (A Mudhoo) - Raced wide throughout.
