RACE COMMENTS

Race 1 | VILLA MARIA MAIDEN 1400m

CLAIRIERE (J Bayliss) - Slow away. Held up for clear running from the top of the straight to the winning post and had to steady off heels near the 250 metres.

MEDIA MISS (C Zackey) - Slow away.

KARAOKE (K Asano) - Over-raced in the early stages.

NO BID (M Hudson) - Over-raced in the early to middle stages refusing to settle for its rider. Was inclined to shift inwards under pressure in the home straight.

FREE THYME (K Hercock) - Had to be steadied passing the 1100 metres when NO BID was racing erratically. Shied and became momentarily unbalanced passing the 400 metres.

JUST BEN (L Allpress) - Raced three-wide without cover throughout and weakened over the concluding stages.

THE REPUBLICAN (W Kennedy) - Raced greenly throughout.

INNOCENT VICTIM (M Hashizume) - Had to be steadied approaching the 150 metres when racing in restricted room and was not fully tested over the concluding stages.

COURTHEZON (C Grylls) - Returned to the enclosure with blood present in both nostrils. Trainer J Bary was advised that COURTHEZON is now ineligible to race in New Zealand as this was its second attack of nasal bleeding.

C Lammas (INCHAARJ) - Advised to exercise more care after allowing his mount to shift outwards when not sufficiently clear in the home straight.

Race 2 | AHD PRODUCTION ANIMAL SUPPLIER HANDICAP 1400m

PRIORESS (K Asano) - Late scratching at 12.58pm after refusing to go to the barriers. L Latta was advised that PRIORESS must trial to the satisfaction of Stewards prior to racing next.

LADY MAROAL (C Lammas) - Began awkwardly. Over-raced in the early stages, then raced three-wide without cover from the 1000 metres. Lay inwards when placed under pressure in the home straight.

MAGNETO (M McNab) - Bumped shortly after the start, losing ground.

FREE BEE (T Taiaroa) - Raced three-wide without cover until the 1000 metres before sitting outside the leader.

SPRINGSTEEN (L Allpress) - Over-raced in the early and middle stages.

ONE DREAM ONE SOUL (J Kamaruddin) - Inconvenienced near the 250 metres when LADY MAROAL lay inwards when placed under pressure.

Race 3 | STELLA ARTOIS HANDICAP 1200m

SCOTCH (J Kamaruddin) - Stood flat footed losing considerable ground and then restrained to the rear of the field. A warning has been placed against the gelding regarding its barrier manners. Trainer J Bary advised Stewards the gelding's future would be reassessed.

RUM (L Sutherland) - Raced three-wide without cover throughout.

WESTWOOD (W Pinn) - Began awkwardly.

POWER 'N' GLORY (M Hudson) - Began awkwardly. Improved up on to heels having to steady approaching the 600 metres, when over-racing.

PHINSTON (J Riddell) - Over-raced in the middle stages when being restrained.

ELCHEIKHALI (W Kennedy) - Checked near the 800 metres when NO TIME TO JAZZ (T Mitchell) shifted inwards when not sufficiently clear.

T Mitchell (NO TIME TO JAZZ) - Admitted a charge of careless riding in that she permitted NO TIME TO JAZZ to shift inwards when not sufficiently clear of ELCHEIKHALI (W Kennedy) which was checked near the 800 metres. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 18 February, until the conclusion of racing on Friday, 24 February, 4 national riding days.

Race 4 | **PAUL NELSON/CORRINA McDOUGAL RACING 1200m**

ZOULUMINOUS (N Parmar) - Began awkwardly losing ground.

SHEZZACATCH (W Pinn) - Over-raced in the middle stages.

CAN I GET AN AMEN (K Hercock) - Raced three-wide without cover throughout.

GERMANICUS (C Zackey) - Unable to find clear running throughout the home straight, going to the line without being tested.

ON THE BUBBLES (O Bosson) - Raced in restricted room near the 100 metres having to be steadied.

ROSE 'N' POWER (J Riddell) - Held up momentarily passing the 50 metres.

CAVALLO VELOCE (S McKay) - Rider advised the gelding had not travelled throughout today's race and in his opinion CAVALLO VELOCE is now looking for more ground and would benefit from today's run.

Race 5 | **LITTLE AVONDALE LOWLAND STAKES DAY 1/3 2100m**

HUNTER PENCE (K Hannan) – Stood flat footed losing ground. Raced ungenerously in the early stages when being restrained.

SHARE POWER (V Jalalkuncha) - Began awkwardly losing ground, then refused to settle in the early and middle stages of the race. In the opinion of the rider, SHARE POWER was racing well out of its grade today.

HAIL DAMAGE (T Mitchell) - Raced three-wide without cover to the 1400 metres.

INMYSHADOW (O Bosson) - Raced three wide without cover from the 900 metres.

THE SEAGULL (K Hercock) - Lay inwards when placed under pressure over the concluding stages.

Race 6 | **COLLIERS COMMERCIAL HAWKES BAY HANDICAP 2100m**

MARK TWAIN (W Kennedy) - Began awkwardly, contacting the barriers, losing ground.

STRANGE LOVE (J Bayliss) - Shied at the winning post on the first occasion. Rider advised the mare had raced intractably throughout the race.

HIGH CHOICE (T Mitchell) - Raced three-wide without cover until approximately the 1700 metres. Rider dropped her whip near the 300 metres.

JAMESON (M McNab) - Raced three-wide without cover from the 800 metres.

VERISMO (N Parmar) - Raced four-wide without cover from the 800 metres.

GOOD OIL (K Hannan) - Raced greenly early in the straight and shifted in abruptly hampering VIDIANO near the 250 metres. Lay inwards when placed under pressure over the concluding stages.

VIDIANO (L Allpress) - Improved on to heels near the 250 metres when dictated inwards by GOOD OIL (K Hannan), which was laying inwards when placed under pressure. K Hannan was advised to exercise more than when in similar circumstances.

MOONLIGHT HUSTLER (C Grylls) - Became unbalanced approaching the 250 metres when VIDIANO was placed closely on its heels. Lost a front plate during the running.

Race 7

LA LADIES DAY FUNCTION – ON SALE NOW 3YO 1600m

IN THE LOOP (C Grylls) - Late scratching at 3.09pm by order of the Stewards after IN THE LOOP arrived at the racecourse wearing a poultice, which is not permitted. An investigation was opened and adjourned to a later date.

DUNCAN CREEK (M McNab) - Slow to begin. Raced keenly in the early stages. Failed to handle the home turn, laying outwards.

SASSYNESS (W Pinn) - Raced three-wide without cover to the 1000 metres.

BELLANO (N Parmar) - Raced three-wide without cover from the 800 metres.

DIMAGGIO (O Bosson) - Raced keenly in the early stages. Had to be steadied when racing in restricted room near the 700 metres when improving on to heels.

Race 8

WAIROA RACING CLUB @ HASTINGS 19 FEB HANDICAP 1600m

KARMAN LINE (C Zackey) - Late scratching at 3.55pm due to transport difficulties.

LANGKAWI (N Parmar) - Slow to begin. Over-raced in the middle stages when the pace eased.

BEAN A PLEASURE (L Allpress) - Raced keenly in the early and middle stages.

CRUZ RAMIREZ (K Hannan) - Raced three-wide without cover throughout.

LILLY LAGUNA (J Kamaruddin) - Improved on to heels approaching the 100 metres when in restricted room, having to be momentarily steadied.

ALIGHIERI (W Kennedy) - The gelding proved difficult in the home straight, wanting to duck in behind runners. Rider reported the gelding pulled up in a normal post-race condition and was disappointing by today's performance and could offer no excuse.

EXTORTION (C Grylls) - Finished last. C Grylls advised he had some concerns with the gelding on pulling up. A post-race veterinary examination revealed the gelding to have suffered cardiac arrhythmia. Trainer C Cole was advised that EXTORTION will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

C Grylls (EXTORTION) - Reminded of his obligation regarding whip use on a runner out of contention.

Race 9

FAREWELL GOATMAN FROM HAWKES BAY RACING HANDICAP 1600m

CHAMPAGNE SUNDAY (J Riddell) - Late scratching at 2.31pm on veterinary advice. Trainer L Latta was advised that CHAMPAGNE SUNDAY will require a veterinary clearance prior to trialling or racing next.

WEOWNA TIGER (J Bayliss) - Stood flat footed missing the start by a considerable distance then restrained to the rear of the field.

ZAHER (C Grylls) - Raced keenly in the early stages then raced wide without cover to the 900 metres.

SEALED WITH A KISS (L Allpress) - Momentarily held up having to switch off the heels of a tiring runner approaching the 200 metres.

HASSTOBEPERFECT (W Kennedy) - Held up for clear running near the 200 metres when the rider elected to take a run to the inside and a tiring runner impeded his run.

CALVARIA (J Kamaruddin) - Rider was of the opinion the mare had failed to handle today's firmer ground and would prefer more rain-affected going.
