<b>Race 1</b>	<b>AUTOBAHN CAFE MAIDEN 2100</b>

**NOSNEVETS** (T Newman) – Began awkwardly.

**VERISMO** (W Pinn) - Began awkwardly then contacted leaving the barriers. Held up for clear running in the final straight and went to the line untested.

**RED CHATEAU** (K Asano) - Slow to begin.

**TRIPLE MONEY** (C Lammas) - Over-raced in the early stages when being restrained. When questioned regarding the performance rider reported that he was disappointed with the gelding's effort and could offer no explanation.

**KUROMIES** (A Goindasamy) – Over-raced in the early and middle stages.

**TRIPLE MONEY** (C Lammas) – Steadied away from heels near the 1800 metres.

**RHODESIAN** (N Parmar) - Raced wide in the early stages before being restrained to the rear of the field. Finished a distant last. Underwent a post-race veterinary examination which revealed the gelding to have suffered a cardiac arrhythmia. Co-trainer P Gerard was advised that RHODESIAN will not be permitted to race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**HEART OF ALLADIN** (M McNab) – Over-raced in the middle stages before improving to sit outside the leader passing the 1000 metres.

**MCENROE** (T Thornton) - Had difficulty obtaining clear running over the concluding stages.

**VAMOS** (J Bayliss) – Held up for clear running until passing the 250 metres.

<b>Race 2</b>	<b>MAJESTIC HORSE FLOATS MAIDEN 2100</b>

**PRIZE PRINCE** (L Satherley) - Slow to begin.

**THE JAKKAL** (S Weatherley) - Began awkwardly making contact with SAVABOURBON. Made contact with the running rail near the 1000 metres.

**SAVABOURBON** (K Asano) – Contacted leaving the barriers. Held up for clear running until passing the 250 metres. When questioned regarding the improved performance connections advised that the gelding was better suited to a larger track.

**CONTRIBELLE** (C Barnes) – Restrained in the early stages to obtain cover after jumping from an outside barrier

**TIZ LOUIE** (C Lammas) – Restrained in the early stages to obtain cover after jumping from an outside barrier.

**NYSTROM** (J Kamaruddin) - Raced ungenerously in the early stages having to be restrained off heels.

**I'M ON FIRE** (J Bayliss) – Raced wide in the early stages before obtaining cover near the 1600 metres. Shifted out and away from **THEODEN** which was laying out approaching the 100 metres.

**THEODEN** (M Hashizume) - Lay out under pressure over the concluding stages.

**BRONTES GOLD** (K Hannan) - Rider dropped her whip near the 350 metres.

<b>Race 3</b>	<b>HALLMARK STUD MAIDEN 1200</b>

**BELIEVE IT OR NOT** (J Kamaruddin) – Slow to begin (4L).

**BUSTER MOON** (M Hashizume) - Raced keenly in the early stages having to be steadied to avoid heels racing into the first bend when placed in restricted room.

**AMOROUS STU** (N Parmar) - Raced wide in the early stages.

**THE CHROME NUN** (K Hannan) – Had to be firmly restrained off heels passing the 800 metres when there was easing of the pace.

**LUCIENNE** (C Grylls) - Had to be firmly restrained off heels passing the 800 metres when there was easing of the pace.

**SOUL QUEEN** (T Abel) - Lay out under pressure over the concluding stages.

**T Thornton** (MS CANDEE LANE) - Admitted a charge in that she unreasonably reduced the speed of her mount approaching the 800 metres resulting in **THE CHROME NUN** and **LUCIENNE** having to be firmly restrained to avoid heels, also hampered was **BUSTER MOON**. After considering submissions the Adjudicator imposed a suspension of T Thornton's licence to ride in races from the conclusion of racing on Saturday 4 March up to and including racing on Wednesday 15 March, 6 national riding days.

<b>Race 4</b>	<b>BADGEMAKERS MAIDEN 1400</b>

**LERADO** (C Barnes) - Late scratched at 3.16 pm on veterinary advice after becoming fractious in the barriers. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**TERRYSAWUS** (T Abel) - Underwent a pre-race veterinary examination after its gate opened prematurely and was passed fit to race.

**COMPOSURE** (T Thornton) – Slow to begin.

**AY TEE VEE** (K Hannan) - Began awkwardly losing ground.

**PROVENCE** (S Weatherley) – Restrained in the early stages to obtain cover after jumping from an outside barrier.

**CONGO** (C Grylls) – Raced wide without cover throughout.

**THE INSTIGATOR** (W Pinn) – Raced wide throughout.

**COURAGEOUS STEP** (M Hashizume) - Raced wide in the early stages before improving to lead near the 700 metres.

**CHANTARI BAY** (T Newman) – Shifted out when placed under pressure near the 350 metres inconveniencing FOREVER YOUNG.

**FOREVER YOUNG** (K Asano) – Inconvenienced passing the 350 metres.

Following this race, the track was upgraded to Good 4.

**Race 5** | **MOUNT SHOP MAIDEN 1400**

**POW TONG** (R Elliot) – Began awkwardly losing ground.

**ACCURACY** (C Grylls) - Slow to begin. When questioned regarding performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

**ACAPULCO** (T Thornton) – Contacted and crowded leaving the barriers.

**ALA DI VESPA** (W Pinn) – Jumped inwards making contact with ACAPULCO at the start. Raced three wide without cover throughout. Contacted passing the 350 metres when CORNWALLIS shifted ground outwards.

**THE MAVERICK** (J Kamaruddin) – Contacted shortly after the start losing ground.

**LOUISVILLE** (M Hashizume) – Contacted shortly after the start. Improved onto heels near the 400 metres having to shift ground inwards to obtain clear running. Lay out under pressure in the straight.

**CHINOOK** (L Satherley) – Over-raced in the early stages.

**CIMARRON** (K Asano) – Commenced to race keenly passing the 1000 metres when being restrained.

**CORNWALLIS** (J Bayliss) - Rider dropped his inside rein passing the 100 metres.

**Race 6** | **ELLERSLIE EVENT CENTRE MAIDEN 1600**

**ARMINO** (W Pinn) - Late scratched at 4.27 pm after becoming fractious in the barrier injuring its rider. W Pinn was taken to hospital for further observation and stood down from his remaining ride. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**RISING PACIFIC** (J Bayliss) - Slow to begin. Raced wide in the early stages before obtaining cover near the 1000 metres.

**HE'S CLASSIC** (K Hannan) - Slow to begin.

**SWIFT ACE** (R Elliot) – Raced keenly in the early stages and continued to do so for some distance. Made the bend near the 900 metres awkwardly.

**ELLDECREE** (M McNab) – Raced wide in the early stages before improving to sit outside the leader near the 1000 metres.

**LAUDING** (K Asano) - Raced three wide without cover from the 900 metres.

**MOOLOOLABA** (M Hashizume) – Improved onto heels having to be steadied approaching the 600 metres.

**J Bayliss** (RISING PACIFIC) - Admitted a charge in that he struck his mount RISING PACIFIC six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$250.

<b>Race 7</b>	<b>BEATTIE CIVIL MAIDEN 1600</b>
<p><b>NAGA EYE</b> (K Asano) - Underwent a pre-race veterinary examination after becoming fractious in its barrier and was passed fit to race. Began awkwardly. Connections were advised that a warning would be placed against the gelding's barrier manners.</p> <p><b>LITTLE MISS WONDER</b> (T Abel) - Slow to begin.</p> <p><b>LADY HIKA</b> (R Elliot) - Began awkwardly.</p> <p><b>ROC DANCER</b> (A Goindasamy) – Raced keenly in the middle stages having to steady off heels.</p> <p><b>TOKO ONO</b> (C Grylls) – Hampered approaching the 100 metres having to shift ground. V Colgan was advised to exercise greater care in similar circumstances.</p> <p><b>BID FOR FAME</b> (V Colgan) - Lay out when placed under pressure approaching the 100 metres hampering TOKO ONO.</p>	
<b>Race 8</b>	<b>BRIGHTHILL FARM MAIDEN 1600</b>
<p>This race was delayed by 4 minutes due to multiple horses requiring the assistance of the Clerk of the Course to the barriers.</p> <p><b>TE ATATU MEMPHIS</b> (J Bayliss) - Slow to begin. Lay in when placed under pressure near the 400 metres having to be corrected by its rider. When questioned regarding the performance rider reported that the gelding would appreciate a track with more give.</p> <p><b>MISTER PUCCI</b> (L Satherley) - Hampered at the start.</p> <p><b>BLUE SKY AT NIGHT</b> (M McNab) - Began awkwardly then hampered at the start.</p> <p><b>REINSTATEMENT</b> (J Kamaruddin) – Shifted inwards abruptly at the start hampering inside runners. Raced three wide without cover throughout.</p> <p><b>WHATS THE ONE CODE</b> (T Newman) – Raced keenly in the early and middle stages when leading.</p> <p><b>BERNSTONE</b> (C Barnes) - Commenced to give ground from the 600 metres. When questioned regarding performance the rider could offer no explanation.</p>	
<b>Race 9</b>	<b>PUKEKOHE TRADERS 1400</b>
<p><b>ROCKSPELL</b> (C Grylls) – Contacted the barriers when the start was initiated losing ground (3L). Steadied off heels passing the 900 metres.</p> <p><b>TRUST IN YOU</b> (J Kamaruddin) – Raced three wide without cover throughout.</p> <p><b>GOLDBURG</b> (S Weatherley) – Restrained in the early stages to obtain cover.</p> <p><b>CHASE 'N' GOLD</b> (K Asano) – Raced wide throughout.</p> <p><b>CASCATELLA</b> (T Abel) - Firmly restrained off heels near the 800 metres.</p> <p><b>NO AGENDA NIGEL</b> (T Newman) - Had difficulty obtaining clear running until passing the 200 metres.</p>	

Race 10	NZB INSURANCE PEARL SERIES MAIDEN RACE 1400
<p><b>ARMADA</b> (M McNab) - Slow to begin.</p> <p><b>THE IBERIAN</b> (C Barnes) - Restrained to obtain cover in the early stages after jumping from the outside barrier.</p> <p><b>SANTENAY</b> (N Parmar) – Began awkwardly losing ground. Made the bend near the 900 metres awkwardly shifting wider on the track.</p> <p><b>ZAKAYA</b> (J Kamaruddin) – Over-raced in the middle stages having to be steadied off heels.</p> <p><b>VHAGAR</b> (J Bayliss) - Raced keenly in the early and middle stages. When questioned regarding the performance rider reported that the filly was unsuited by the slow tempo.</p> <p><b>DODDLE</b> (S Weatherley) – Lay out when placed under pressure near the 100 metres having to be corrected by its rider.</p> <p><b>S Marsh</b> (THE IBERIAN &amp; DODDLE) - Presented runners to race at plate inspection with incorrect saddle cloths and fined \$50 under the minor infringement schedule.</p> <p><b>J Bayliss</b> (VHAGAR) - Admitted a charge in that he failed to ride his mount out to the end of the race when there was a reasonable chance of finishing in a higher placing. After considering submissions the Adjudicator imposed a fine of \$300.</p>
