**LADDIE BOY** (C Butler) - Began awkwardly. Raced ungenerously through the early and middle stages.

MCLAREN (J Kamaruddin) - Began awkwardly hampering LEICA SONG. Hampered near the 400 metres.

**LEICA SONG** (L Hemi) - Hampered at the start, bumping BANANARAHMA. Steadied near the 300 metres when there was simultaneous movement from BANANARAHMA and LADDIE BOY.

BANANARAHMA (C Grylls) - Bumped at the start.

SUPERCELL (K Hannan) - Slow away. Lay outwards over the concluding stages.

**KAREHANA BAY** (M Hudson) - Made the bend awkwardly, laying inwards for a short distance near the 400 metres hampering CHARLOTTE'S WAY and MCLAREN prior to being straightened.

CHARLOTTE'S WAY (L Allpress) - Hampered near the 400 metres. Bumped, becoming unbalanced near the finish.

TIVACI'S JOY (L Sutherland) – Made the final bend awkwardly.

Following the running of the race the rider of the third placed horse CHARLOTTE'S WAY, L Allpress, lodged a protest with the Adjudicator alleging interference in the final straight by the second placed horse MCLAREN. After considering submissions the Adjudicator upheld the protest and the amended placings are now 1<sup>st</sup> BANANARAHMA, 2<sup>nd</sup> CHARLOTTE'S WAY, 3<sup>rd</sup> MCLAREN.

**J Kamaruddin** (MCLAREN) - Admitted a charge of careless riding in that he permitted MCLAREN to shift outwards over the concluding stages, making contact with CHARLOTTE'S WAY and unbalancing that runner near the finish. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 4 March until the conclusion of racing on Sunday, 12 March, 5 national riding days.

### Race 6 MAD BUTCHER WANGANUI MAIDEN 1600 metres

**THE BIG PICTURE** (L Sutherland) - Over-raced in the early stages.

**LUCIKHAN** (A Mudhoo) - Raced ungenerously in the early and middle stages bumping FABIAN HAWK near the 1400 metres. Lay inwards under pressure in the home straight.

**TELLEMALIE** (R Elliot) - Over-raced in the early stages. Lost the off-hind plate during the running.

KAZADEROSE (J Kamaruddin) - Raced ungenerously in the early and middle stages.

**GOOD WORK MEN** (M Hudson) – Awkwardly placed on heels nearing the 400 metres having to be steadied.

**FABIAN HAWK** (L Allpress) – Bumped near the 1400 metres. Lay inwards under pressure over the concluding stages. Underwent a post-race veterinary examination and found to have a laceration consistent with being galloped on.

### Race 7 FLOYD AND TOY REAL ESTATE 1600 metres

**CHAMPAGNE SUNDAY** (L Sutherland) - Late scratching on veterinary advice at approximately 3.50pm after bolting during the preliminary.

BRUNO MAGILE (T Taiaroa) – Slow away.

**TUTIN CANS** (C Grylls) – Slow away. Made the first bend awkwardly, having to be steadied. Lay inwards under pressure over the concluding stages.

**BOSTON STRONG BOY** (T Newman) - Made the final bend awkwardly. Lay outwards under pressure in the home straight.

Race 8 WANGANUI INSURANCE BROKERS HANDICAP 2040 metres

**TRUSTWORTHY** (L Hemi) - Restrained to the rear from its wide draw. Had to angle across heels entering the home straight to gain clear racing room.

**ROAD DIVA** (A Mudhoo) – Restrained to the rear from its wide draw.

**SHARE POWER** (C Barnes) - Began awkwardly hampering AQUILO. Over-raced in the middle stages having to be steadied on several occasions.

AQUILO (J Kamaruddin) - Hampered at the start losing ground.

**SON OF THUNDER** (J Riddell) - Raced wide throughout.

DEVOTED (C Grylls) - Lay outwards under pressure over the concluding stages.
