SUPPLEMENTARY**Banks Peninsula Racing Club at Riccarton Park – Saturday 11 February 2023****RACE 10 – ODT SOUTHERN MILE QUALIFIER 1600m**

At a reconvened hearing, rider **K Williams** admitted a charge of careless riding under Rule 638(1)(d) in that she permitted her mount **JUST MAYBE** to shift inwards when not sufficiently clear of **TAIMATE DIVA** which clipped a heel and dislodged its rider **R Mudhoo** passing the 1400 metres. After considering submissions the Adjudicator imposed a suspension of **K Williams**' licence to ride in races from the conclusion of racing on Saturday 4 March until the conclusion of racing on Saturday 1 April, 4 national riding weeks.

RACE COMMENTS**Race 1** | **NZB INSURANCE PEARL SERIES RACE MAIDEN 1200m**

LYNLEY'S EVEREST (G Jogoo) - Slow to begin.

TROGLODYTE (T Moseley) - Slow to begin.

TARZINO BELLE (K Asano) - Slow to begin.

LET'S GO (K Chowdhoo) - Slow to begin and then crowded shortly after the start losing ground.

TYPHOON TIP (C Barnes) - Began awkwardly losing ground.

MISS OTIS REGRETS (M McNab) - Lay in early in the run home and had to shift ground outwards near the 250 metres to find clear racing room and in doing so inconvenienced **DECISION TIME**.

DECISION TIME (K Williams) - Inconvenienced near the 250 metres.

DELPHILLIOUS (K Mudhoo) - When asked to comment on the performance of this favoured runner, rider advised that the filly had not been comfortable in today's Heavy track conditions.

Stewards enquired into the reason **TYPHOON TIP** had begun awkwardly, with rider **C Barnes** advising she had been calling out that she had no outside iron when the barrier was released. **C Barnes** added that the mare had been fractious in the barrier which was the reason she did not have her foot in the iron at the time the start was effected, however she was quickly able to regain her iron but **TYPHOON TIP** began awkwardly losing ground. After speaking to **C Barnes**, the Starter and Starter's Assistant, Stewards could not be conclusively sure that **TYPHOON TIP** had been denied a fair start.

Race 2 | **RICCARTON PARK FUNCTION CENTRE 1200m**

DIVINE DIVE (L Allpress) - Began very awkwardly shifting in crowding **PAPAGENA**. Rider reported that the gelding had hung throughout the running. Stewards ordered a post-race veterinary examination which did not reveal any obvious abnormality.

PAPAGENA (S Toolooa) - Crowded shortly after the start losing ground. Raced keenly through the early and middle stages.

KAPALKA (K Chowdhoo) - Slow to begin.

SYMPATHIQUE (G Jogoo) - Had to be steadied off heels when placed in restricted room near the 700 metres. Again had to briefly steady when crowded and placed in restricted room passing the 200 metres.

D Tait (THE MOTIVATOR) - Issued with a warning after permitting her mount THE MOTIVATOR to shift outwards when not sufficiently clear of SYMPATHIQUE which was crowded having to briefly steady and race in restricted room passing the 200 metres.

Race 3 | **PUNTERS CHALLENGE 15 APRIL 1200m**

BRITISH ROYALTY (C Barnes) - Slow to begin then lay out shortly after the start making contact with ANNELIESE. Briefly held up passing the 300 metres having to shift ground inwards to find clear racing room.

ANNELIESE (K Mudhoo) - Contacted at the start. Held up early in the final straight having to shift outwards across heels to obtain clear running near the 300 metres.

NIGHT RAIDER (M McNab) - Slow to begin.

MR HASS (T Newman) - Shifted in shortly after the start crowding TWIN SHOT. Raced keenly through the early and middle stages.

TWIN SHOT (B Rogerson) - Crowded at the start losing ground.

MARYWEKA (L Allpress) - Held up rounding the final bend and in the run home, only gaining clear racing room inside the final 200 metres.

Race 4 | **SPEIGHT'S SUMMIT ULTRA ON TAP MAIDEN 1800m**

HIGH PINS (L Callaway) - Blundered at the start. Over raced in the early stages when sitting outside the leader. Dislodged rider L Callaway on return to scale. L Callaway was stood down by St John Paramedics for the remainder of the day after suffering a suspected shoulder injury. L Callaway was advised he must produce a medical certificate prior to riding next.

DEVIL IN DISGUISE (M McNab) - Slow to begin. When asked to comment on the performance of this favoured runner, rider was of the opinion the gelding had not handled today's Heavy track conditions.

IT'S BELSANTO (B May) - Slow to begin.

TAWHIRIMATEA (D Bothamley) - Slow to begin and then restrained behind runners to obtain cover shortly after the start.

SEVEN ELEVEN (K Chowdhoo) - Began awkwardly losing ground.

PACKING TAVI (T Jonker) - From its wide barrier draw restrained behind runners to obtain cover shortly after the start.

MOKOPEKA (T Newman) - Over raced in the early stages.

MARCHING ON TAVI (L Allpress) - Raced three wide without cover throughout.

Race 5 | **BOOK A SUITE FOR AUTUMN RACING MAIDEN 1600m**

LILITH (B May) - Stood flat footed as the start was effected and then began awkwardly losing considerable ground.

JON OL ROCCO (J Laking) - Began awkwardly making contact with **SISTER SARAH** and further hampered losing ground when runners either side shifted ground shortly after the start.

HEAVENLY BOUQUET (C Barnes) - Began awkwardly losing ground. Raced wide without cover throughout.

ECCELLENZA (B Murray) - Slow to begin and then restrained behind runners to obtain cover.

SISTER SARAH (T Jonker) - Contacted then crowded shortly after the start when runners to either side shifted ground.

WAYNES RUBY (T Moseley) - Shifted out shortly after the start crowding outside runners.

ATLANTIC CITY (M McNab) - Rider advised that the gelding had not handled today's Heavy track conditions.

CRUSHING (K Chowdhoo) - Rider advised that the gelding had not handled today's Heavy track conditions.

J Lowry (**ATLANTIC CITY**) - Admitted a charge of being unable to make the contract weight for **ATLANTIC CITY** and was replaced by M McNab. After considering submissions the Adjudicator imposed a suspension of J Lowry's licence to ride in races from the conclusion of racing on Saturday 4 March until the conclusion of racing on Saturday 11 March, 4 national riding days.

Race 6 | **COUPLAND'S BAKERIES MAIDEN 1400m**

ROYAL VALOUR (C Barnes) - Escaped riderless behind the barriers galloping for some distance and declared a late scratching at 3.47pm on Stewards' direction. Connections were advised that **ROYAL VALOUR** must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. The start was delayed approximately 9½ minutes as a result of the late scratching, with all runners which had been loaded being removed from their barriers and reloaded, and further delayed when **ARCTIC GLOW** proved difficult to load.

ARCTIC GLOW (K Chowdhoo) - Proved difficult to load causing a further delay to the start of the race. Connections were advised that a warning would be placed on the barrier manners of **ARCTIC GLOW**. Began very awkwardly shifting out and contacting **VAUDEVIRE** losing ground as a result.

CORA LEE (J Mudhoo) - Slow to begin. Had some trouble obtaining clear running early in the run home and had to be shifted outwards to obtain clear running near the 350 metres.

VAUDEVIRE (K Mudhoo) - Contacted shortly after the start. Hampered passing the 1100 metres.

FIRST LIEUTENANT (J Laking) - Over raced in the early stages and when being steadied hampered the trailing **VAUDEVIRE** passing the 1100 metres. When questioned regarding performance, rider advised that after over racing in the early stages the gelding had been unable to quicken over the final stages on a wet track which was not suitable.

PROPER TWELVE (K Asano) - Over raced in the early stages and got its head up on a number of occasions.

B Rogerson (**TAVANASIA**) - Issued with a warning after she struck her mount **TAVANASIA** 6 times prior to the 100 metre mark. In assessing penalty Stewards took into account B Rogerson's good record under this section of the whip rule.

Race 7 | **DR CORIN & BOBBITY MURFITT 1400m**

The start was delayed approximately 6½ minutes due to the delay in Race 6 and several runners proving difficult to load.

NO RIGMAROLE (T Moseley) - Bounded at the start beginning awkwardly.

BOOT IT SCOOTER (K Mudhoo) - Bounded at the start beginning awkwardly.

GLAMOUR (B Rogerson) - Shifted out shortly after the start dictating POWERFUL MOSS outwards and crowding PROSERVE.

PROSERVE (K Chowdhoo) - Slow to begin and then crowded losing ground. Lay in throughout the run home and shifted in under pressure passing the 175 metres briefly hampering MACRAES which had to steady and shift ground. When asked to comment on the improved performance, co-trainer M Pitman advised that the gelding had been suited by the Heavy track today, adding he would be making gear adjustments in an endeavour to improve the gelding's tendency to lay in.

SENTIENT (R Beeharry) - Slow to begin.

MACRAES (K Asano) - Dictated inwards passing the 200 metres having to be briefly steadied to avoid heels.

K Mudhoo (BOOT IT SCOOTER) - Spoken to advisedly in regard to riding his mount out fully to the finish when circumstances permit.

J Laking (GALILEO EXPRESS) - Spoken to advisedly in regard to riding his mount out fully to the finish when circumstances permit.

PROSERVE (K Chowdhoo) - Issued with a warning after permitting his mount PROSERVE to shift inwards under pressure resulting in MACRAES having to be briefly steadied to avoid heels passing the 200 metres.

SAVVY BOY (D Montes de Oca) - Began awkwardly. Over raced for a distance passing the 1000 metres having to be heavily restrained off heels. Angled wider on the track passing the 600 metres to find clear racing room.

CHEEKINI (C Barnes) - Began awkwardly making contact with ROYAL KHAN.

ROYAL KHAN (K Hannan) - Slow to begin and then contacted losing ground. Lost a hind plate during the running.

DUSHKU (K Asano) - Began awkwardly losing ground then shifted out shortly after the start making contact with A BOX OF TRICKS.

VICTOR ROUGE (T Moseley) - Slow to begin and then crowded losing ground when runners to either side shifted ground.

A BOX OF TRICKS (K Williams) - Contacted shortly after the start.

DRAKE BAY (B Rogerson) - Raced keenly in the early stages.

ARCHERFIELD (K Chowdhoo) - Began awkwardly shifting out crowding VULTURE STREET.

VULTURE STREET (T Moseley) - Crowded shortly after the start losing ground.

EL BEE JACK (T Newman) - Slow to begin.

WILD ROVER (K Hannan) - Slow to begin. Rider was of the opinion the gelding was not suited by the holding nature of today's Heavy track conditions.

DA VINCI GIRL (D Montes de Oca) - Began awkwardly losing ground.

ZADANE (G Jogoo) - Raced keenly while leading through the early stages.

Race 10

RACECOURSE HOTEL & MOTOR LODGE 2000m

MADISON ROSE (K Hannan) - Became fractious in its barrier and then reared making heavy contact with the right side of the barrier gate, beginning very awkwardly and dislodging its rider. Connections were advised that MADISON ROSE must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. A post-race veterinary examination revealed no obvious abnormalities. K Hannan was attended to by St John Paramedics and transferred to hospital with a suspected fractured right wrist.

ALTA BELLA (K Williams) - Slow to begin.

AMAZON GODDESS (A Mudhoo) - Began awkwardly.

TIFFEN (T Moseley) - Restrained to the rear from a wide draw to obtain cover.

TURF WAR (K Chowdhoo) – Very fractious in its barrier prior to the start. Connections were advised the gelding was on a final barrier manners warning. Held up rounding the final bend, gaining clear racing room passing the 375 metres.
