Race 7 - J SWAP CONTRACTORS LTD MATAMATA BREEDERS' STAKES 1200 (G2)

ULANOVA (S Weatherley) – Stable Forman Mr R Mildon advised Stewards, upon return to the stable, ULANOVA underwent a veterinary examination which included and endoscopic examination, as well as on Monday 27 February, was examined by the chiropractor, with no abnormalities being detected in either examination. R Mildon further advised it is the stables intention to continue with the filly's current preparation.

RACE COMMENTS

Race 1 ARAWA PARK HOTEL ROTORUA 3YO 1400

ANGELS WINGS (J Kamaruddin) - Slow to begin. Raced keenly in the early stages having to be steadied away from heels approaching the 800 metres.

ANELA (A Goindasamy) - Restrained at the start from its wide barrier. Raced keenly in the early stages.

BLACK OPAL (R Elliot) - Restrained at the start from its wide barrier. The rider reported that the gelding had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which revealed the gelding to be 2/5 lame in the right foreleg.

READY TO REIGN (B Rogerson) – Over-raced in the early stages when leading.

KENTUCKY ROSE (T Mitchell) – Over raced in the early stages making contact with the rail near the 1200 metres.

HE'S BESET (M McNab) - Held up passing the 450 metres before shifting outwards placing PURE FICTION and JUSTICE in restricted room. M McNab was advised to exercise care in similar circumstances. Inconvenienced passing the 200 metres when KENTUCKY ROSE shifted out when not fully clear. T Mitchell was advised to exercise care. When questioned regarding performance the rider advised that in his opinion the gelding would now be better suited to a step up in distance.

JUSTICE (T Thornton) - Steadied when placed in restricted room approaching the 400 metres.

PURE FICTION (C Lammas) - Steadied when placed in restricted room approaching the 400 metres.

MACFIRE (L Satherley) - Underwent a post-race veterinary examination including an endoscopic examination which revealed dirt in the trachea.

T Thornton (JUSTICE) - Issued with a warning after permitting her mount to shift in when not sufficiently clear of ANGELS WINGS which had to be steadied when racing keenly near the 800 metres. When assessing the incident Stewards took into account the racing manners of ANGEL WINGS.

Race 2 CAMPBELL INFRASTRUCTURE 2YO 1215

PERENARA (C Grylls) - Slow to begin. Commenced to race keenly in the middle stages.

BALANCE OF POWER (O Bosson) – When questioned regarding performance the rider could offer no excuse.

Race 3 HOUSE OF ELLIOTT MAIDEN 1560

ON ICE (M Sanson) - Declared a late scratching on veterinary advice at 1.38 pm after breaking through the front of its barrier stall.

INCHAARJ (M McNab) - Crowded at the start.

SAVANNAH ROSE (C Grylls) - Slow to begin.

AULD JOCK (S Weatherley) - Began awkwardly.

TERRYSAWUS (T Abel) - Raced wide in the early stages until improving to sit outside the leader near the 1200 metres.

TRAMONTO (V Colgan) - Raced keenly in the middle stages.

Race 4 SWEENEY TOWNSEND INSURANCE BROKERS MAIDEN 1560

ELTON ROCKS (M Kareem) - Slow to begin. Made the bend near the 1200 metres awkwardly.

ELUSIVE NATION (J Kamaruddin) - Contacted the rail becoming briefly unbalanced near the 1100 metres.

NORTHERN RAIDER (T Thornton) - Raced keenly for a distance when being restrained approaching the 900 metres.

SHIMMERING (C Lammas) - Raced three wide without cover until improving to sit outside the leader near the 800 metres.

TIME TO WONDER (N Parmar) – Had some difficulty obtaining clear running until early in the final straight.

ROEDERER (M McNab) – Held up until near the 250 metres.

Race 5 WAITOMO FUELS MAIDEN 1215

PAUL DAVID (C Grylls) - Slow to begin. Held up until near the 250 metres.

PEPE PEPERONI (L Satherley) - Crowded at the start.

DEEP PURPLE (J Doyle) - Knuckled at the start. Made the bend awkwardly having to be steadied near the 850 metres after being placed in restricted room inside of MISS CAPRICORN.

MISS CAPRICORN (M Sanson) - Raced three wide without cover throughout.

Race 6 SHERLOCK CONTRACTING MAIDEN 1215

CALL ME BILLIE (C Lammas) - Crowded at the start. Raced three wide without cover throughout.

BLAZING DANCER (J Kamaruddin) - Slow to begin.

SHIRAZELLE (T Abel) - Raced keenly in the early stages when being restrained. Held up until near the 250 metres.

LONG GAME (A Goindasamy) - Over-raced in the early and middle stages. When questioned regarding the performance the rider advised that after racing keenly during the running the gelding had failed to respond when placed under pressure.

WISHEART (M Kareem) - Raced wide without cover throughout.

ANNIE JAMES (T Newman) – Had some difficulty obtaining clear running early in the final straight.

NOTWORTHWATCHING (O Bosson) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 7 LANCE LAWSON 1215

CORBATIN (C Lammas) - Slow to begin.

ORLEANS BELLE (N Parmar) - Slow to begin.

NORTH OF HAVANA (J Doyle) - Raced three wide without cover throughout.

PARADIGM SHIFT (S Spratt) – Raced keenly in the early and middle stages.

DRAGON BISCUIT (B Rogerson) - When questioned regarding the performance the rider advised that the gelding was unsuited by today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

K Fursdon (ORLEANS BELLE) - Stewards accepted her explanation as to why her rider declaration for ORLEANS BELLE was late on this occasion.

Race 8 MACMILLAN ACCOUNTANTS 1400

ZUMA ROCK (M Sanson) - Slow to begin.

RABADA (M Kareem) - Began awkwardly.

BOLD PERFORMER (T Mitchell) – Raced keenly in the early and middle stages.

Race 9 HAVE YOUR FUNCTION AT "ARAWA PARK" 1950

AVONDALAY (O Bosson) - Began awkwardly losing ground.

I'M ALICE (T Thornton) - Slow to begin.

BRANCIFORTI (S Spratt) - Raced keenly in the early stages.

CALL ME FLINT (J Doyle) – Raced three wide without cover from near the 1300 metres.

RISING ROAD (T Mitchell) - Raced three wide without cover until near the 1300 metres.

CANADIAN GIRL (J Kamaruddin) - Shifted out and away from CALL ME FLINT who shifted out approaching the 150 metres making contact with the hindquarters of HELLY BELLY which shifted in slightly with HELLY BELLY then laying in having to be straightened by its rider resulting in CANADIAN GIRL having to be steadied to avoid heels. Both J Doyle and M McNab were advised to exercise care in similar circumstances.

Race 10 LASER ELECTRIAL ROTORUA MAIDEN 1950

PRIZE PRINCE (L Satherley) - Slow to begin.

NOSNEVETS (K Asano) - Began awkwardly.

GIN GIN (S Weatherley) - Began awkwardly losing ground.

MOONLIGHT SHADOW (T Thornton) - Raced keenly in the early stages when being restrained.

QUALIA (M Hashizume) - Raced three wide without cover throughout.

LIGHT OF PLUTUS (N Parmar) - Improved into restricted room for a distance approaching the 50 metres having to be steadied.

M Hashizume (QUALIA) – Issued with a warning after weighing in 0.4 kgs under the weight at which he weighed out at.
