## RACE COMMENTS

### Race 1 | TRACMAC WANGANUI MAIDEN 2200m

**KAZADEROSE** (L Allpress) - Refused to settle into stride in the early stages of the race. Inclined to lay inwards when entering the home straight.

**DEBISUE** (M Hudson) - Jumped out awkwardly making contact with another runner. Over-raced in the early stages.

**LUCIKHAN** (A Mudhoo) - Inconvenienced when another runner made contact at the start.

**KHANIVORE** (B Rogerson) - Jumped outwards shortly after the start. Returned to the enclosure with blood present in one nostril. Underwent a post-race veterinary examination which confirmed the gelding to have bled. KHANIVORE cannot be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1,000 metres in the presence of a Veterinarian.

**LEGALLY BLONDE** (C Barnes) - Slow to begin.

**RIGHT NOW** (T Newman) - Restrained shortly after the start to a rearward position and over-raced for a short period.

**STAYINYALANE** (L Hemi) - Inclined to lay inwards under pressure over the concluding stages.

**Race 2** | **EMMA THURLOW'S BIRTHDAY 2200m**

**MAHOE** (L Allpress) - Jumped awkwardly contacting another runner. Over-raced in the early stages.

**BURITZ** (M McNab) - Jumped awkwardly contacting another runner. Lay outwards under pressure over the concluding stages.

**FLYING MEG** (C Butler) - Raced keenly in the early and middle stages.

**Race 3** | **WAGON WHEEL MAIDEN 1200m**

**GOT THE GOLD** (C Barnes) - Leapt in the air as the start was made losing ground then restrained to the rear of the field.

**KEEN ON BUBBLES** (L Sutherland) - Jumped awkwardly losing ground. Over-raced in the early stages.

**GIA MARQUESA** (M McNab) - Jumped awkwardly losing ground. Over-raced in the early stages.

**PHOEBE FOX** (C Butler) - Raced three-wide throughout.

**EL ZORO** (B Rogerson) - Inclined to shift out when placed under pressure entering the home straight.

**IDYLLIC** (L Allpress) - Returned to the enclosure with blood present in the mouth. A subsequent veterinary examination revealed a displaced tooth consistent with having contacted the front of the gate prior to the start.

**Race 4** | **SHADOWDOWNS POLL HEREFORDS STUD 1200m**

**VISHAKHA** (C Barnes) - Slow to begin. Leapt in the air as the start was made losing ground then restrained to the rear of the field. Had to be steadied off heels approaching the 150 metres to obtain clear running.

**KANA** (L Allpress) - Fractious in the barriers prior to the start. Began awkwardly contacting another runner, losing ground. Raced wide throughout.

**UNLEASHED** (C Butler) - Raced keenly in the early and middle stages.

**Trainer R Patterson** (UNLEASHED) was issued with a warning under Rule 616(4) for presenting his runner to the mounting yard with incorrect gear.

**Race 5** | **MOORE MARKHAMS ACCOUNTANTS 1400m**

**GURTLYN** (A Mudhoo) - Slow to begin.

**DU'BLUES** (C Barnes) - Raced three-wide to the 900 metres.

**MASSIVE PRINCE** (M McNab) - Lay outwards rounding the turn and was inclined to shift outwards under pressure in the home straight.

**PHINSTON** (J Riddell) - Raced three-wide without cover from the 650 metres.

**DESTINY ONE** (B Rogerson) - Failed to handle the home turn and shifted out.

**Race 6** | **SANDFORDS TRUCKING MAIDEN 1400m**

**STORMCAST** (T Newman) - Slow to begin. Failed to handle the turn out of the back straight.

**MCCRAW** (C Carmine) - Raced keenly in the early and middle stages. C Carmine was reminded of his obligation regarding the use of his whip on a runner out of contention.

**ZAH HONEY** (A Mudhoo) - Raced keenly in the early and middle stages.

**REGAL DICE** (M McNab) - Raced keenly in the middle stages.

**BLUE RATA BOLDNESS** (L Hemi) - Raced wide without cover throughout.

**MILLY MILLS** (C Barnes) - Steadied momentarily near the 150-metre mark when there was simultaneous movement from BLUE RATA BOLDNESS (L Hemi) which shifted in and FREE THYME (B Rogerson) which shifted out marginally. Both L Hemi and B Rogerson were reminded to exercise greater care when in similar circumstances.

**SISTER JANE** (L Sutherland) - Rider reported the mare hung throughout, placing her at a disadvantage in that it was unable to ridden out fully in the home straight.

**Race 7** | **SPORTS BAR/JOLT COFFEE HOUSE 1650m**

**SHARE POWER** (C Barnes) - Raced keenly in the early and middle stages.

**LINDA LOLA** (T Taiaroa) - Raced wide without cover from the 1200 metres. Raced ungenerously approaching the 1400 metres.

**CREAM** (K Hercock) - Over-raced in the early and middle stages. Shifted out in the home straight when placed under pressure.

**TAKE ON** (L Sutherland) - Raced ungenerously when the rider was endeavouring to settle the gelding in the early stages.

**HANAKIN** (L Allpress) - Forced to race wide in the straight when CREAM shifted out under pressure.

**PINKERTON** (C Carmine) - Had to be steadied off heels approaching the 1400 metres when LINDA LOLA was racing erratically.

**HARMONIOUS** (M McNab) - M McNab was of the opinion the mare is better suited to more rain-affected footing.

**Race 8** | **NZB INSURANCE PEARL SERIES MAIDEN RACE 1650m**

**LOVE NESST** (C Butler) - Slow to begin.

**SACRED ANGEL** (M Hudson) - Slow to begin. Raced wide in the home straight when placed under pressure.

**JAMAICAN EXPRESS** (K Hercock) - Raced keenly in the early and middle stages.

**WAIPAPA** (M McNab) - Raced four-wide without cover from the 500 metres.

**BURLACE** (T Newman) - Raced three-wide without cover throughout.

**DETONATE** (T Allan) - Received lacerations to the hind legs consistent with being galloped on during the race.

**Race 9**

**TREADWELL GORDON MAIDEN 1650m**

The start of this race was delayed approximately 8 minutes due to **GOLDSTONE** dislodging its rider in the preliminary and galloping some distance prior to being recaptured.

**GOLDSTONE** (A Mudhoo) - Late scratching at 5.06pm on veterinary advice.

**KEVE** (T Newman) - Leapt in the air as the start was made losing ground then raced ungenerously in the early and middle stages when being restrained.

**REBAL AGENT** (C Barnes) - Raced keenly in the middle stages.

**DASH OF RED** (C Carmine) - Over-raced in the early and middle stages. Shifted out approaching the 400 metres when not sufficiently clear of **TAHI TAMA**

**PERFECT TURN** (T Taiaroa) - Steadied off heels approaching the 400 metres when **KEVE** was forced wider.

**C Carmine** (**DASH OF RED**) - Admitted a charge of careless riding in that near the 400 metres he permitted **DASH OF RED** to shift outwards when not sufficiently clear of **TAHI TAMA** which was dictated outwards forcing **KEVE**, which was improving to its outside, into the line of **PERFECT TURN** which had to be steadied. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 11 March until the conclusion of racing on Monday, 20 March, 5 national riding days.
