<b>Otago Racing Club @ Wingatui – Saturday 4 March 2023</b>
<b>Race 6 - PROPERTY BROKERS 1400m</b>
<b>DIVOVSKI</b> (L Allpress) – Co-trainer Ms A Tyler advised Stewards that upon return to the stable DIVOVSKI underwent a veterinary examination which included blood tests, with results showing the gelding to have Lymphangitis to the off-hind leg. A Tyler further advised that DIVOVSKI has been placed on a course of antibiotics and once completed will be sent for a spell.
<b>Race 8 - ODT SOUTHERN MILE FINAL 1600m</b>
<b>EARS BACK</b> (J Fawcett) – Trainer Mr J Blackadder reported to Stewards that on Monday 6 March EARS BACK underwent a veterinary examination and blood tests which revealed the mare to be heavily in season. J Blackadder further advised that EARS BACK has now been sent for a brief freshen up.

<b>RACE COMMENTS</b>
<b>Race 1</b>   <b>RICCARTON PARK FUNCTION CENTRE MAIDEN 1200m</b>
<b>AN MORRIGHAN</b> (K Kwo) - Began awkwardly making contact with LADYSWEY. Raced greenly in the early stages and near the 800 metres had to be steadied away from heels.
<b>LADYSWEY</b> (T Mitchell) - Contacted at the start.
<b>TAIL LIGHTS</b> (Y Coonee) - Crowded shortly after the start when runners either side shifted ground and as a result lost ground.
<b>JETHRO</b> (D Tait) - Began awkwardly crowding TAIL LIGHTS. Raced keenly through the early and middle stages. When entering the course proper became awkwardly placed on heels having to be steadied.
<b>BENJI'S BOY</b> (K Chowdhoo) - Slow to begin.
<b>GIVEALITTLE</b> (L Sutherland) - Slow to begin.
<b>BORNHOLM</b> (B Murray) - Began awkwardly. Raced keenly through the early and middle stages. When tiring steadied near the 250 metres after LADY INCANTO (D Montes de Oca) shifted out to find clear racing room at this point. Rider D Montes de Oca was advised to exercise greater care when shifting ground. When asked to comment on performance, rider B Murray was of the opinion the gelding had not been entirely comfortable with today's softer track conditions.

**D Tait** (JETHRO) - Admitted a charge in that she struck her mount JETHRO 7 times (2 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

**Race 2** | **MARTIN COLLINS 1200m**

**DA VINCI GIRL** (Y Coonee) - Began awkwardly losing ground.

**RADIANT ROSIE** (T Moseley) - Began awkwardly losing ground.

**THE MOTIVATOR** (D Tait) - Began awkwardly and then hampered shortly after the start losing ground as a result.

**RUSSIAN FABLE** (K Asano) - Began awkwardly hampering THE MOTIVATOR.

**STAR BALLOT** (K Chowdhoo) - Rider advised that the gelding was looking for more ground.

**MAKE BELIEVE** (K Mudhoo) - When asked to comment on the apparent improved performance, the trainer advised that the mare had had a change of training regime after two recent disappointing runs and the addition of blinkers had led to today's improved performance.

**FISCAL FUN** (C Barnes) - Rider was of the opinion the mare had not been entirely comfortable in today's softer track conditions. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection including an endoscopic examination FISCAL FUN was confirmed to have bled. FISCAL FUN shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**Race 3** | **SAM KEENAN TENNIS COACH 1200m**

**LOVEBUG** (C Barnes) - Began awkwardly.

**SENTIENT** (R Beeharry) - Began awkwardly briefly unbalancing its rider and was then buffeted shortly after the start losing ground when runners either side shifted ground.

**MAGIC CONDOR** (T Moseley) - Began awkwardly. Rider reported that the mare had been striking itself during the running. Received post-race treatment for superficial wounds to the left hind fetlock consistent with having struck itself during the running.

**VALYRIAN** (L Sutherland) - Slow to begin.

**BELASARD** (K Chowdhoo) - Slow to begin.

**KAPALKA** (B Rogerson) - From its wide barrier draw restrained behind runners to obtain cover shortly after the start.

**LIPA MALA** (K Asano) - Jumped away awkwardly with the rider briefly losing control of his whip before regaining it shortly after the start. Rider dropped his whip passing the 150 metres.

**GELATO** (T Jonker) - Over raced in the early stages.

**TOWN BELT** (J Fawcett) - Returned to the enclosure minus the right front plate.

**J Fawcett** (TOWN BELT) - Issued with a warning after she struck her mount TOWN BELT 6 times (1 more than permitted) prior to the 100 metre mark, with Stewards taking into account her clear recent record with regard to any breach of a whip rule.

<b>Race 4</b>	<b>PUNTERS CHALLENGE 15 APRIL MAIDEN 1400m</b>
<p><b>SASSMAN</b> (L Allpress) - Began awkwardly. When asked to comment on the disappointing performance of this favoured runner, rider could offer no tangible excuse.</p> <p><b>LUSCIOUS LOVER</b> (J Fawcett) - Began awkwardly losing ground. Held up early in the run home until obtaining clear running passing the 350 metres.</p> <p><b>MUMBO JUMBO</b> (K Asano) - Began awkwardly shifting out abruptly crowding outside runners. Got its head up when being steadied away from heels passing the 1000 metres. When questioned regarding performance, rider advised he had been disappointed with the mare's effort and could offer no tangible excuse. A post-race veterinary examination revealed grade 1 lameness to the right foreleg after losing that racing plate during the running.</p> <p><b>CHADILLAC</b> (L Callaway) - Crowded at the start losing ground.</p> <p><b>TARZINO BELLE</b> (T Newman) - Began awkwardly shifting inwards abruptly crowding inside runners. Raced three wide without cover throughout.</p> <p><b>LIFESTYLE</b> (R Beeharry) - Crowded at the start losing ground. Inconvenienced near the 250 metres.</p> <p><b>BELLA ROSE</b> (D Montes de Oca) - Lay inwards through the run home and near the 250 metres shifted in inconveniencing LIFESTYLE.</p> <p><b>MISS OTIS REGRETS</b> (T Mitchell) - Lay outwards over the concluding stages.</p> <p><b>J Mudhoo</b> (TROGLODYTE) - Admitted a charge in that he struck his mount TROGLODYTE 7 times (2 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.</p>	
<b>Race 5</b>	<b>BOOK A SUITE FOR AUTUMN RACING MAIDEN 1400m</b>
<p><b>BUSY LAD</b> (Y Coonee) - Began awkwardly crowding outside runner. When racing keenly had to be continually steadied when improving onto heels for some distance passing the 1000 metres. Connections advised that BUSY LAD had been retired as a racing proposition from their stable.</p> <p><b>SINCERE</b> (J Laking) - Crowded shortly after the start losing ground.</p> <p><b>THROW THE DICE</b> (K Asano) - Slow to begin. Raced greenly throughout. Made heavy contact with the Clerk of the Course on pulling up dislodging rider K Asano who was uninjured in this incident.</p> <p><b>LADY'S LEGACY</b> (K Chowdhury) - Began awkwardly losing ground and further hampered when contacted by TYPHOON TIP. Placed in restricted room passing the 1000 metres when MAYBE I'M DREAMING which was continuing to race greenly stepped in on the point of the turn.</p> <p><b>TYPHOON TIP</b> (C Barnes) - Began awkwardly shifting out and making contact with LADY'S LEGACY. Dictated inwards passing the 1200 metres.</p> <p><b>PROPER TWELVE</b> (L Allpress) - Slow to begin. Hampered near the 1200 metres and was then allowed to improve forward to lead passing the 700 metres.</p> <p><b>TELLME YOU LOVEME</b> (D Montes de Oca) - Slow to begin.</p>	

**MAYBE I'M DREAMING** (J Fawcett) - Steadied passing the 1200 metres to avoid the heels of LUCKY SIMON and when being steadied shifted in dictating MURDER SHE WROTE inwards onto TYPHOON TIP which was dictated inwards at this point, and when being corrected by its rider shifted out hampering PROPER TWELVE. Raced greenly for the majority of the race and wide without cover from the 800 metres.

**MURDER SHE WROTE** (T Newman) - Dictated inwards onto TYPHOON TIP passing the 1200 metres.

**THROW THE DICE** (K Asano) - Got its head up when over racing in the early stages and when placed in restricted room near the 1000 metres again got its head up when being steadied.

**T Moseley** (LUCKY SIMON) - Issued with a warning after permitting his mount LUCKY SIMON to shift inwards when not sufficiently clear of MAYBE I'M DREAMING which had to steady and shift inwards to avoid heels passing the 1200 metres.

**Race 6** | **SPEIGHT'S SUMMIT ULTRA ON TAP MAIDEN 1600m**

**SASSY CHOUXS** (L Sutherland) - Reluctant to load. Connections were advised that a barrier manners' warning would be placed on SASSY CHOUXS' record.

**JON OL DYLAN** (K Chowdhoo) - Began awkwardly losing ground.

**BAILADOR** (S Muniandy) - Began awkwardly losing ground.

**LILITH** (R Beeharry) - Stood flat footed as the start was effected losing considerable ground (5L). Connections were advised that LILITH would be required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. Held up rounding the final bend and early in the run home.

**WAYNES RUBY** (B Murray) - Raced three wide without cover throughout.

**SISTER SARAH** (T Jonker) - Raced keenly through the early and middle stages.

**SIR ALBERT** (L Allpress) - Rider advised that the gelding had made respiratory noises during the running and may have held its breath. A post-race veterinary examination did not reveal any obvious abnormality.

**R Beeharry** (LILITH) – Admitted a charge of using the whip in 2 consecutive strides on his mount LILITH shortly after the start. After considering submissions the Adjudicator imposed a fine of \$150.

**L Sutherland** (SASSY CHOUX) - Admitted a charge in that she struck her mount SASSY CHOUX 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of L Sutherland's licence to ride in races from the conclusion of racing on Saturday 11 March until the conclusion of racing on Thursday 16 March, 3 national riding days, and in addition imposed a fine of \$500.

**Race 7** | **COUPLAND'S BAKERIES HANDICAP 1400m**

**FRANKIE THE FOX** (S Muniandy) - Became very fractious in its barrier, rearing and dislodging its rider. FRANKIE THE FOX was removed from the barriers and underwent a veterinary examination before being declared a late scratching at 3.23pm on veterinary advice. Connections were advised that FRANKIE THE FOX would be required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. S Muniandy was uninjured in this incident.

**SUMMER FESTIVAL** (J Mudhoo) - Became very fractious in its barrier after FRANKIE THE FOX reared and began kicking out. SUMMER FESTIVAL was removed from the barriers and underwent a veterinary examination prior to being cleared to race.

**AVAQUINELLA** (K Mudhoo) - Slow to begin.

**THE GROWLER** (K Chowdhoo) - Slow to begin.

**OUR ECHO** (T Newman) - Lay inwards in the run home and near the 250 metres shifted inwards crowding JUNE BUG before being straightened by its rider.

**JUNE BUG** (L Sutherland) - Crowded near the 250 metres.

**T Mitchell** (THE BUFFER) - Admitted a charge in that she struck her mount THE BUFFER 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

**Race 8** | **DAPHNE BANNAN MEMORIAL 1400m**

**JUST TICKETY BOO** (D Tait) - Slow to begin and further hampered losing ground when MACRAES shifted out at the start. Held up passing the 300 metres having to shift ground inwards near the 225 metres to find clear racing room.

**MACRAES** (K Asano) - Began awkwardly shifting outwards contacting JUST TICKETY BOO.

**BRITISH ROYALTY** (B Murray) - Slow to begin.

**LADY TELENA** (T Jonker) - Slow to begin.

**DECISION TIME** (T Moseley) - Began awkwardly losing ground. Raced four wide without cover throughout.

**HEY SOUL SISTER** (G Jogoo) - Raced three wide without cover for the majority of the race.

**K Mudhoo** (ANNELIESE) - Issued with a warning after he struck his mount ANNELIESE 6 times (1 more than permitted) prior to the 100 metre mark, with Stewards taking into account his clear recent record with regard to any breach of a whip rule.

**T Newman** (ROYCE ROCA) - Admitted a charge in that she struck her mount ROYCE ROCA 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

**Race 9** | **LINDAUER 2000m**

**MATSCOT** (J Laking) - Slow to begin.

**TAKE THE DEEL** (G Jogoo) - Began awkwardly and was then crowded losing ground when MATSCOT shifted out at the start. Began to over race passing the 1800 metres and continued to race keenly through the middle stages.

**VULTURE STREET** (K Asano) - Began awkwardly losing ground.

**LIGHT UP** (K Kwo) - When over racing was placed in restricted room having to be steadied passing the 1800 metres when AMAZON GODDESS (J Fawcett) improved forwards and inwards at the same time. J Fawcett was advised to exercise greater care.

**DOC MARTYN** (K Mudhoo) - Raced keenly in the early stages.

**THE BOLD LIONESS** (L Allpress) - Lay out passing the 150 metres having to be straightened by its rider.

**Race 10** | **RACECOURSE HOTEL MOTOR LODGE 1600m**

**POWERFUL MOSS** (D Montes de Oca) - Became fractious and reared in its barrier becoming briefly cast before being removed to undergo a veterinary examination and declared a late scratching at 5.20pm. Connections were advised that **POWERFUL MOSS** would be required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**MISS ONAKI** (G Jogoo) - Began awkwardly hampering **JUST MAYBE**.

**JUST MAYBE** (L Sutherland) - Hampered at the start.

**VICTOR ROUGE** (T Moseley) - Stood flat footed as the start was effected and was slow away losing ground. Over raced passing the 1400 metres and had to be firmly restrained to avoid the heels of **AWATANE** near the 1350 metres.

**SAVVY BOY** (L Allpress) - Slow to begin.

**TIFFEN** (J Mudhoo) - Began awkwardly losing ground.

**IDLE LADY** (C Barnes) - Raced three wide without cover throughout.

**J Laking** (**AWATANE**) - Admitted a charge of careless riding in that he permitted his mount **AWATANE** to shift inwards when not sufficiently clear of **VICTOR ROUGE** which had to be firmly restrained and checked passing the 1400 metres. After considering submissions the Adjudicator imposed a suspension of J Laking's licence to ride in races from the conclusion of racing on Saturday 18 March until the conclusion of racing on Sunday 26 March, 5 national riding days.
