<b>Race 1</b>	<b>BECOME A MEMBER @ TAUPO \$50 MAIDEN 2000</b>
<p><b>CONFIDENTIAL</b> (J Fawcett) - Slow to begin.</p> <p><b>GROOMSMAN</b> (M McNab) - Began awkwardly. Jumped the crossing leaving the straight on the first occasion. Raced three wide without cover. When questioned regarding performance the rider could offer no excuse.</p> <p><b>ROC DANCER</b> (A Goindasamy) - Over-raced in the early stages.</p> <p><b>TAVITA MISS</b> (J Bayliss) - Over-raced in the early stages.</p>	
<b>Race 2</b>	<b>BECOME A SIGN SUPPORTERS @ TAUPO MAIDEN 2000</b>
<p><b>TREATY OF PARIS</b> (W Kennedy) - Began awkwardly.</p> <p><b>VAMOS</b> (J Bayliss) - Slow to begin.</p> <p><b>TIZ LOUIE</b> (R Elliot) - Began awkwardly. Improved onto heels having to be steadied approaching the 200 metres.</p> <p><b>INNOCENT VICTIM</b> (M Hashizume) - Raced wide without cover until near the 900 metres. Lost the off-fore plate during the running.</p> <p><b>GLITZABELLA</b> (C Lammas) – Checked when weakening passing the 100 metres.</p> <p><b>BRONTES GOLD</b> (J Doyle) - Checked passing the 100 metres.</p> <p><b>K Asano</b> (LAUDING) – Issued with a warning and reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.</p> <p><b>K Asano</b> (LAUDING) - Admitted a charge of careless riding in that he permitted his mount LAUDING to shift inwards when not sufficiently clear of TREATY OF PARIS which was forced inwards forcing ANNETARZ in, resulting in BRONTES GOLD and GLITZABELLA having to be checked near the 100 metres. After considering submissions the Adjudicator imposed a suspension of K Asano’s licence to ride in races from the conclusion of racing on Saturday 18 March up to and including racing on Saturday 1 April, 7 national riding days.</p> <p>Following the running of this race the connections of the 2<sup>nd</sup> placed horse viewed Stewards footage before electing not to proceed with a protest.</p>	
<b>Race 3</b>	<b>MOBILE WELDER MAIDEN 1400</b>
<p><b>SANTENAY</b> (J Doyle) - Slow to begin (6L). Connections were advised that a warning would be placed against the mare’s barrier manners.</p> <p><b>ALA DI VESPA</b> (S Spratt) - Began awkwardly. Raced three wide without cover throughout.</p> <p><b>STUNNING MAIRE</b> (A Goindasamy) - Knuckled at the start.</p> <p><b>WANDA LU</b> (C Lammas) - Improved onto heels passing the 50 metres having to shift outwards to improve.</p>	

**O Bosson (FIRRIATO)** - Issued with a warning and reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

**Race 4** | **NZB INSURANCE PEARL SERIES RACE 1400**

**RUBY'S LANDED** (C Grylls) - Slow to begin.

**DON'T LOOK ETHEL** (C Barnes) - Began awkwardly.

**HASSTOBEFAST** (M McNab) - Began awkwardly.

**TASER** (L Satherley) – Over-raced in the early stages.

**COVERMEINSUNSHINE** (J Doyle) – Improved onto heels having to be steadied near the 700 metres.

**BIT NOSY** (W Pinn) - Ran off rounding the final turn being pulled up by its rider. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**W Hillis** (BIT NOSY) - Issued with a minor infringement and fined \$50 after BIT NOSY raced in incorrect gear.

**Race 5** | **NAME A TIE-UP \$1000 MAIDEN 1200**

**BELIEVE IT OR NOT** (O Bosson) – Slow to begin (3L). Raced keenly in the middle stages. Held up until near the 200 metres.

**ASMARDE** (L Satherley) – Steadied to avoid heels passing the 1100 metres then commenced to over-race in the middle stages. Steadied when placed in restricted room near the 100 metres between BELIEVE IT OR NOT which shifted out slightly, and SORCHA which shifted in slightly. Both O Bosson and M McNab were advised to exercise care in similar circumstances.

**AMOROUS STU** (S Spratt) - Raced greenly when placed in restricted room near the 200 metres.

**BELLEZOR** (W Kennedy) - When questioned regarding the performance the rider advised that in his opinion the filly would benefit from a step up in distance.

**S Spratt** (AMOROUS STU) - Issued with a warning after permitting her mount to shift in when not sufficiently clear of ASMARDE which had to be steadied to avoid heels near the 1100 metres.

**Race 6** | **NZB INSURANCE PEARL SERIES MAIDEN 1100**

**IFF I GET PAAID** (H Kamaruddin) – Began awkwardly. Improved onto heels near the 500 metres having to be steadied.

**CHANTARI BAY** (M Sanson) - Slow to begin.

**ZIRCON** (W Kennedy) - Began awkwardly. Had some difficulty obtaining clear running rounding the final bend.

**MIDNIGHT BELLE** (C Grylls) - Began awkwardly.

**INTREPID GIRL** (S Spratt) – Over-raced in the early and middle stages. Made the first bend awkwardly shifting outwards.

**TELESCOPIC** (T Abel) - Raced three wide without cover for the majority of the race.

**SWEY'S LASS** (J Doyle) - When questioned the rider reported that the filly had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 7** | **VOLUNTEERS TEAMWORK @ TAUPO MAIDEN 1100**

**ZAZON** (W Kennedy) - When questioned regarding performance the rider advised that the filly had been outpaced in the early stages and had raced greenly throughout.

**Race 8** | **TAUPO LIFE MEMBERS 1800**

**FAST WILLIE** (W Kennedy) - Crowded shortly after the start losing ground. Had to be steadied off heels approaching the 1100 metres then shifted outwards being obliged to race three wide without cover for the remainder of the race. Steadied when weakening passing the 150 metres when placed in restricted room.

**IRIDESSA** (K Asano) - Crowded shortly after the start losing ground.

**INVINCIBEEL** (O Bosson) - Began awkwardly losing ground. Held up until near the 150 metres.

**ALL THE RAGE** (B Rogerson) - Jumped out abruptly at the start.

**VINO VALENTINO** (S Weatherley) - Slow to begin. When questioned regarding the performance the rider could offer no excuse.

**CALVARIA** (J Doyle) - Over-raced in the early and middle stages.

**NEST EGG** (M McNab) – Held up rounding the final bend.

**SON OF THUNDER** (C Grylls) – Steadied when placed in restricted room over the concluding stages when weakening.
