RACE COMMENTS

Race 1 | **GRAHAM'S PAINTERS 1200m**

INTENT (L Sutherland) - Over-raced in the early stages.

MAKETAWA MISS (L Allpress) - Over-raced in the early stages of the race.

SANS DOUTE (H Kamaruddin) - Had to be steadied for some distance when improving onto the heels of MAKETAWA MISS in the early stages of the race.

ELCHEIKHALI (N Parmar) - Forced to race wider leaving the 600 metres when SANS DOUTE shifted outwards.

H Kamaruddin (SANS DOUTE) - Issued with a warning after permitting SANS DOUTE to shift outwards when negotiating the junction onto the course proper when not sufficiently clear of ELCHEIKHALI which was forced wider near the 600 metres.

Race 2 | **HIREMASTER 1000m**

ARIS ARIS (H Kamaruddin) - Performed below market expectations. A post-race veterinary examination did not reveal any obvious abnormality.

N Parmar (CAVALLO VELOCE) - Admitted a charge in that he struck his mount CAVALLO VELOCE 7 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 18 March until the conclusion of racing on Wednesday, 29 March, 6 national riding days.

Race 3 | **PROGRESSIVE LANDINGS LTD/CHEMWASH 1200m**

FAR SITE (T Davies) - Slowly away.

MEGLIO DI FALCREST (T Taiaroa) - Over-raced in the early stages of the race.

BRADMAN (H Kamaruddin) - Raced ungenerously in the early stages of the race.

MEHRTENS (A Mudhoo) - Inclined to hang inwards in the home straight.

BELLE'S ECHO (C Barnes) - Inclined to shift outwards when placed under pressure entering the course proper.

EXPRESS YOURSELF (L Allpress) - Inclined to lay inwards over the concluding stages placing the rider at a disadvantage with the mare going to the line without being fully tested.

Race 4 | **TIDY SLABS MAIDEN 2200m**

C'MON EILEEN (C Barnes) - Raced wide throughout.

RED EMPEROR (M Hudson) - Checked severely on the first occasion leaving the home straight when MARTINA DIVA (B Rogerson) crossed when insufficiently clear, causing RED EMPORER to clip heels and blunder, unbalance its rider and lose significant ground. A post-race veterinary examination revealed lacerations to its hind legs consistent with being galloped on.

FLERTA (A Mudhoo) – Had to be steadied off heels when leaving the home straight on the first occasion when RIGHT NOW was forced to race wide. Returned to the enclosure showing signs of lameness. A post-race veterinary examination revealed the mare to be lame in the right foreleg. Connections were advised FLERTA requires a veterinary clearance prior to racing next.

DEBISUE (T Taiaroa) - Raced four-wide without cover from the 1000 metres. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

RIGHT NOW (M Singh) – Had to be steadied leaving the home straight on the first occasion when RED EMPORER was severely checked, forcing the gelding to race wide for the majority of the race.

B Rogerson (MARTINA DIVA) - Admitted a charge of careless riding in that she permitted MARTINA DIVA to shift inwards when not sufficiently clear of RED EMPEROR which was severely checked leaving the home straight on the first occasion. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 18 March, until the conclusion of racing on Saturday, 1 April, 7 national riding days.

Race 5 | **TOTAL BUILD WELLINGTON 2200m**

MASSO (L Hemi) - Jumped awkwardly. Improved its position from the rear to near the front due to the slow pace near the 1100 metres.

SCUTAR (L Allpress) - Over-raced in the back straight due to the lack of pace.

FLYING MEG (C Butler) - Over-raced near the 1400 metres.

PRINCESS ANI (H Kamaruddin) - Over-raced in the middle and later stages of the race.

Race 6 | **MG TILING/MANA PLUMBING 1400m**

GUCCI BELT (A Mudhoo) - Over-raced in the middle stages. Held up momentarily entering the home straight and had to be steadied off heels approaching the 400 metres to obtain clear running.

MCKHAN (M Hudson) - Lost the near-hind plate during the running.

HEMI RIDAPEST (L Allpress) – On returning to scale the rider reported the gelding was very disappointing but could offer no excuse. A post-race veterinary examination did not reveal any obvious abnormality.

N Parmar (COLLATERAL DAMAGE) - Reminded of his obligation to ride his mounts out fully to the line when circumstances permit.

Race 7 | **FUSION ELECTRICAL 1600m**

MARKUS AURELIUS (H Kamaruddin) - Began awkwardly. Inclined to shift ground under pressure in the home straight. Performed below market expectations. A post-race veterinary examination did not reveal any obvious abnormality.

KELLY COE (T Taiaroa) - Over-raced in the early stages of the race.

BRANDO (C Butler) - Held up momentarily entering the home straight and had to be steadied off heels approaching the 300 metres to obtain clear running.

LOVE FOR ALL (L Allpress) – On returning to scales the rider reported the mare had not handled today's track conditions.

Race 8 | **REGISTERED MASTER BUILDERS ASSOCIATION 1600m**

MORUS (H Kamaruddin) - Slowly away.

TAKE ON (L Sutherland) - Had to take evasive action to avoid the heels of SHARE POWER which was severely checked by STRANGE LOVE near the 600 metres.

STRANGE LOVE (N Parmar) – Over raced in the early stages proving difficult for its rider. Approaching the 600 metres shifted in abruptly severely checking SHARE POWER which had to be steadied losing ground. Shifted outwards when placed under pressure in the home straight.

KING OF HEARTS (L Hemi) – Raced three wide without cover from the 1000 metres.

SHARE POWER (M Singh) – Raced wide without cover in the early stages of the race, before obtaining the lead approaching the 1000 metres. Checked severely approaching the 600 metres when STRANGE LOVE (N Parmar) crossed when insufficiently clear, causing SHARE POWER to clip heels and blunder, unbalance its rider and lose significant ground.

N Parmar (STRANGE LOVE) - Admitted a charge of careless riding in that he permitted STRANGE LOVE to shift inwards when not sufficiently clear of SHARE POWER, which was severely checked and blundered near the 600 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing Sunday, 2 April up to and including racing on Wednesday, 19 April, 10 national riding days.

N Parmar (STRANGE LOVE) - Admitted a charge in that he struck his mount STRANGE LOVE 7 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Thursday, 20 April until the conclusion of racing on Saturday, 29 April, 8 national riding days.
