<b>Race 1</b>	<b>WEOWNA PARK 1600</b>
<p><b>CHASE 'N' GOLD</b> (T Abel) – Slow to begin.</p> <p><b>AQUILO</b> (J Kamaruddin) - Slow to begin.</p> <p><b>FLORENCENIGHTNGALE</b> (O Bosson) - Saddle slipped shortly after the start placing the rider at a disadvantage throughout the race.</p> <p><b>NO AGENDA NIGEL</b> (T Newman) - Raced three wide without cover throughout.</p> <p><b>DEVOTED</b> (H Kamaruddin) - Improved onto heels approaching the 200 metres before being steadied to obtain clear running.</p> <p><b>HARDCORE HENRY</b> (J Riddell) - When questioned regarding the gelding's performance the rider could offer no explanation.</p> <p><b>RIP VAN GOGH</b> (J Doyle) - Performed below market expectations. When questioned the rider could offer no explanation.</p>	
<b>Race 2</b>	<b>TOKOROA CLUB (INC) MAIDEN 1050</b>
<p><b>THE GOLDEN GOOSE</b> (C Barnes) – Proved difficult to load. Connections were advised the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p><b>GIOVANNI</b> (C Lammas) - Slow to begin.</p> <p><b>PRINCE LONHRO</b> (N Parmar) - Began awkwardly.</p> <p><b>BEEBEEP</b> (A Goindasamy) – Raced keenly in the early stages when being restrained by its rider. Received veterinary attention post-race for a laceration to the left fore pastern.</p> <p><b>FRANCEE</b> (H Kamaruddin) – Raced wide without cover throughout.</p> <p><b>EXCELSIOR</b> (C Grylls) – Laid in under pressure approaching the 200 metres making slight contact with PETRUCCI.</p> <p><b>PETRUCCI</b> (M McNab) - Held up until near the 200 metres when EXCELSIOR laid in under pressure.</p>	
<b>Race 3</b>	<b>TOKOROA COSMOPOLITAN CLUB MAIDEN 1200</b>
<p><b>THERE GOES MY HERO</b> (J Riddell) - Late scratching at the barrier at 3.22 pm after refusing to load. Connections were advised the colt would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p><b>JUST CALL ME JONNY</b> (S McKay) - Raced keenly in the middle stages. Underwent a pre-race veterinary inspection at the start after being fractious in the enclosure and was cleared to start.</p> <p><b>DARCI'S ANGEL</b> (J Doyle) - Crowded shortly after the start losing ground.</p> <p><b>FIORE DI CAMPO</b> (M McNab) - Began awkwardly shifting outwards contacting DARCI'S ANGEL, becoming unbalanced. Raced greenly in the early and middle stages.</p>	

**TRANQUIL EYES** (W Pinn) - Slow to begin. Made the first bend awkwardly running wider.

**THE PRINCIE ONE** (O Bosson) - Began awkwardly contacting DARCI'S ANGEL. Raced greenly in the early and middle stages.

**Race 4** | **KEN SOLLY & ASSOCIATES CHARTERED ACCOUNTANTS 1200**

**ACCIDENTAL TOURIST** (H Kamaruddin) - Slow to begin then commenced to buck shortly after the start unbalancing its rider who lost both irons and as a result lost all chance. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**GIACOMO** (S McKay) – Began awkwardly contacting ROC CHA. Raced three wide without cover throughout.

**ROC CHA** (B Rogerson) - Began awkwardly contacting another runner shortly after the start. Inclined to lay in leaving the 800 metres.

**THE BIZZNESS** (C Grylls) - Held up momentarily leaving the 400 metres before switching off heels to obtain clear running.

**CADEAU** (T Newman) - Underwent a post-race veterinary examination which revealed the mare to have suffered cardiac arrhythmia. Trainer C Cole was advised that CADEAU will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**H Kamaruddin** (ACCIDENTAL TOURIST) - Issued with a warning for his whip use on a runner out of contention.

**Race 5** | **NZB INSURANCE PEARL SERIES MAIDEN 1400**

**THE SPRINKLER** (M McNab) - Dislodged the rider on the way to the barriers. M McNab was attended to by oncourse paramedics and cleared to fulfil his ride. Underwent a pre-race veterinary examination and was cleared to start.

**FELICITY THEN** (J Fawcett) - Began awkwardly losing ground. Raced keenly in the middle stages.

**HIGH CURRENCY** (K Asano) - Crowded shortly after the start having to be steadied.

**SCRIBBLEINTHESKY** (C Barnes) - Crowded shortly after the start having to be steadied. Laid out passing the 550 metres forcing FERMANAGH wider.

**SHIRAZELLE** (T Abel) – Raced ungenerously when being restrained in the early stages then continued to race keenly through the middle stages. Underwent a post-race veterinary examination which found the mare to be 1/5 lame in the right hind leg. Connections were advised a veterinary clearance would be required prior to racing next.

**CLAIRIERE** (C Lammas) - Raced keenly in the early and middle stages.

**LUCIENNE** (C Grylls) - Raced wide without cover from near the 700 metres.

**JUST A KARIN** (J Doyle) - Raced three wide without cover throughout.

**NIGELLA LANE** (B Rogerson) – Raced wide without cover before sitting outside the leader approaching the 700 metres.

**FERMANAGH** (W Pinn) - Forced outwards passing the 550 metres. Was not persevered with from near the 350 metres when well back. Rider reported that the mare had felt indifferent in its action. Underwent a post-race veterinary examination including an endoscopic examination which did not reveal any abnormality.

<b>Race 6</b>	<b>MATLEY FINANCIAL SERVICES MAIDEN 1400</b>
<p><b>MCLAREN</b> (W Pinn) - Late scratched at 5.00 pm by order of Stewards after being fractious in its preliminary. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p><b>TRUE NORTH</b> (T Newman) - Crowded shortly after the start losing ground.</p> <p><b>SPELLCRAFT</b> (J Kamaruddin) – Jumped inwards shortly after the start crowding TRUE NORTH.</p> <p><b>ELUSIVE NATION</b> (B Grylls) – Raced keenly in the early and middle stages.</p> <p><b>ESPIONAGE</b> (O Bosson) - Raced three wide without cover throughout.</p>	
<b>Race 7</b>	<b>HOLSTER ENGINEERING LALLY &amp; SYMES SOUTH WAIKATO CUP 2000</b>
<p><b>THE MIGHTY SPAR</b> (H Kamaruddin) - Began awkwardly. Raced in restricted room leaving the home straight on the first occasion, having to be steadied.</p> <p><b>LEICALOT</b> (W Pinn) - Laid in leaving the home straight on the first occasion. Raced three wide until leaving the 1000 metres before improving to sit outside the leader.</p> <p><b>MOTUMAN</b> (M Hashizume) - Made the turn out of the home straight awkwardly when being steadied. Had to be steadied when weakening on the home turn when THE MIGHTY SPAR shifted out to obtain clear running. H Kamaruddin was advised to exercise care in similar circumstances.</p> <p><b>SAGUNTO</b> (S McKay) - Steadied when placed in restricted room just prior to the winning post when THE MIGHTY SPAR shifted inwards when not fully clear. H Kamaruddin was advised to exercise care in similar circumstances.</p> <p><b>LANGKAWI</b> (N Parmar) - Was unable to obtain clear running for the majority of the final straight.</p>	
<b>Race 8</b>	<b>FERTCO MAIDEN 2000</b>
<p><b>HERE'S JOHNNY</b> (M Hashizume) – Crowded shortly after the start.</p> <p><b>REELROSE</b> (C Lammas) - Crowded shortly after the start.</p> <p><b>INCHAARJ</b> (M McNab) - Raced keenly when being restrained in the early stages. Over-raced in the middle stages. When questioned regarding performance the rider could offer no explanation.</p> <p><b>TERRYSAWUS</b> (S Weatherley) - Raced three wide without cover until near the 1500 metres.</p> <p><b>DON PAULY</b> (O Bosson) – Raced keenly in the early and middle stages.</p> <p><b>MYLA</b> (N Parmar) - Dropped his near side rein leaving the 200 metres.</p> <p><b>AGHANIM</b> (R Elliot) - When questioned regarding performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p><b>ARKADUS</b> (V Colgan) - Underwent a post-race veterinary examination which revealed minor lameness in the hindquarters.</p>	

**T Newman** (NOSNEVETS) - Spoken to advisedly in regard to the manner in which she used her whip shortly after the start.

**Race 9**

**TIRAU VETERINARY CENTRE MAIDEN 2000**

**BELLANO** (M McNab) - Began awkwardly losing ground. Held up for clear running from the 150 metres and unable to gain clear running with the filly not being fully tested to the line.

**RHODESIAN** (C Lammas) – Raced wide throughout.

**SUPER GUNN** (T Newman) - Raced three wide without cover until approaching the 1600 metres before improving to sit outside the leader.

**OCEAN GAIL** (V Colgan) - Held up for clear running until approaching the 100 metres.

**MISTER PUCCI** (J Riddell) - Commenced to lay out rounding the final bend then ran off entering the final straight. When questioned regarding performance rider advised that the gelding had proved a difficult ride. Underwent a post-race veterinary examination which did not reveal any abnormality. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.
