Race 1 - RAY WHITE BREAM BAY 1200

J Fawcett (WHISKEY LIES) – Admitted a charge in that she struck her mount WHISKEY LIES seven times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of Jockey J Fawcett's licence to ride in races from the conclusion of racing on Wednesday 14 June up to and including racing on Thursday 22 June, 5 national riding days.

#### **RACE COMMENTS**

## Race 1 ITM/GIB PROGRESSIVE QUALIFYING MAIDEN RACE 1550

**INFER** (R Elliot) - Dislodged its rider during the preliminary before being recaptured. Underwent a pre-race veterinary examination and was cleared to start. As a result, this race ran approximately 4 minutes late. Hampered at the 1400 metres when TEMPEST KHAN failed to handle the turn. Laid in in the home straight.

**SHEEZE A BREEZE** (H McNeill) - Slow to begin. Over-raced in the back straight when the tempo of the race slackened. Had to be steadied when improving onto heels over the concluding stages.

**MERSEY BEAT** (C Barnes) – Over-raced in the early stages. Momentarily held up for clear running entering the home straight.

**TEMPEST KHAN** (N Hailey) - Failed to handle the turn near the 1400 metres hampering GINTYS STAR, JAMAICA FAREWELL, INFER, TOO CLASSY and RIKKI RICARDO. Failed to handle the turn near the 800 metres then raced three wide without cover.

GINTYS STAR (A Lawson-Carroll) – Hampered at the 1400 metres when TEMPEST KHAN failed to handle the turn.

**JAMAICA FAREWELL** (T Newman) - Hampered and steadied off heels at the 1400 metres when TEMPEST KHAN failed to handle the turn.

TOO CLASSY (N Parmar) - Hampered at the 1400 metres when TEMPEST KHAN failed to handle the turn.

**RIKKI RICARDO** (J Kamaruddin) - Hampered at the 1400 metres when TEMPEST KHAN failed to handle the turn. Raced four wide without cover from near the 500 metres.

# Race 2 NZB INSURANCE PEARL SERIES RACE 1550

HARMONIA (K Hannan) - Slow to begin.

**DONTTELLTIMMY** (E Nicholas) - Slow to begin. Over-raced in the early and middle stages. Momentarily held up approaching the 100 metres.

**CHAMPAGNE LOLA** (T Newman) – Over-raced in the early and middle stages. Raced three wide without cover throughout.

**ELECTRIC TIME** (M Sanson) - Raced four wide without cover throughout.

**WEE RHONA** (C Lindsay) - When questioned regarding the performance Apprentice C Lindsay advised she was disappointed with the mare's effort and could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormality.

# Race 3 NZB INSURANCE PEARL SERIES MAIDEN 2YO RACE 1300

SPRING QUEEN (A Goindasamy) - Began awkwardly losing ground.

MOJO WARRIOR (H McNeill) - Began awkwardly losing ground.

**TEQUILA SUNSET** (C Barnes) - Began awkwardly losing ground.

**FINAL RED** (N Parmar) - Had to be steadied when improving onto heels approaching the 600 metres. Then held up for a distance approaching the 400 metres. Stewards enquired into the riding tactics adopted from 600 metres to the 400 metres with Apprentice N Parmar advising that he attempted to improve into a run between TEQUILA SUNSET and COSELLI which failed to eventuate. Jockey N Parmar's explanation was noted.

**ORGULLO** (S Spratt) – Laid in over the concluding stages.

**COSELLI** (C Grylls) – When questioned regarding the performance Jockey C Grylls advised he was disappointed with today's effort and could offer no explanation.

### Race 4 ITM/GIB 3YO QUALIFYING MAIDEN RACE 1300

**RADRADRA** (K Hannan) - Dislodged its rider during the preliminary before being recaptured. Underwent a pre-race veterinary examination and was cleared to start. Began awkwardly.

**SANDINO'S GIRL** (A Goindasamy) - Slow to begin.

DAME LILIBIC (E Nicholas) - Began awkwardly losing ground. Raced three wide without cover throughout.

**AVAYA** (K Asano) – Momentarily held up for clear running entering the home straight.

**EINSTIME** (H McNeill) - Co-trainer S Clotworthy advised Stewards that they would be reassessing the racing future of the gelding after today's run.

**LUCKY CHARM** (C Grylls) - Returned to the enclosure with blood present in the left nostril. Underwent a post-race veterinary examination which revealed a minor laceration to its nostril from being fractious in the gates.

### Race 5 PRYDES EASIFEED 1300

**SHOW COURAGE** (N Parmar) - Became fractious in its barrier and was removed to undergo a pre-race veterinary examination and was cleared to start. Over-raced in the early and middle stages when leading. Laid out in the home straight.

**TIDAL RUSH** (M Sanson) - Crowded shortly after the start losing ground.

**CORBATIN** (C Barnes) - Slow to begin then crowded shortly after. Trainer J Collett advised Stewards that he would be reassessing the geldings racing schedule after today's run.

**UP 'N' GONE** (C Grylls) - Slow to begin.

**BLUE SKY AT NIGHT** (T Thornton) - Began awkwardly. When questioned regarding performance Jockey T Thornton advised that the mare failed to travel throughout today's event.

FELIX FAURE (B Grylls) - Raced wide without cover from near the 800 metres.

**ELUSIVE NATION** (K Hannan) – Raced three wide without cover for the majority of the race.

MR UNIVERSE (R Elliot) – Laid out entering the home straight.

# Race 6 SADDLERY WAREHOUSE MAIDEN 970

The start of this race was delayed after STAR HEART was reluctant to parade to the barriers.

**STAR HEART** (H McNeill) – Slow to begin then made the bend awkwardly near the 600 metres losing all chance. Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**ROC ON HOME** (K Bakker) - Slow to begin. Shifted out contacting MISS BEE near the 300 metres losing ground.

**MISS BEE** (B Rogerson) - Began awkwardly. Raced wide for the majority of the race. Contacted by ROC ON HOME, becoming unbalanced approaching the 300 metres.

POKURU SHOW (J Kamaruddin) - Raced keenly in the early stages. Laid out near the 300 metres.

**K Bakker** (ROC ON HOME) - Issued with a warning after permitting her mount to shift out approaching the 300 metres contacting MISS BEE.

#### Race 7 WAIPA EARTHWORKS 2000

**EVE'S SONG** (N Parmar) - Late scratched on veterinary advice at 12.52 pm. Trainer S Logan was advised that a veterinary clearance would be required prior to the mare racing next.

**ORSOME DUDE** (N Hailey) - Steadied passing the 1900 metres to avoid heels of POSTER BOY with the saddle slipping forward then was taken wider on the track being pulled up by its rider.

**PLUSHENKO** (E Nicholas) - Crowded shortly after the start losing ground.

**POSTER BOY** (T Newman) - Shied at the shadows on the track leaving the home straight on the first occasion. Overraced in the middle stages.

**URBAN MYTH** (R Elliot) – Had to be steadied near the 1600 metres when over-racing and improved onto the heels of RISING ROAD. Raced three wide from near the 900 metres.

**JIMMY DEAN** (C Grylls) – Had to be briefly steadied approaching the 400 metres.

**THEGEEWAGON** (J Fillmore) – Laid in over the concluding stages.

**T Newman** (POSTER BOY) - Issued with a warning after permitting her mount to shift in when not sufficiently clear of ORSOME DUDE near the 1900 metres.

### Race 8 CAMBRIDGE EQUINE HOSPITAL MAIDEN 2000

**POW TONG** (C Grylls) – Reared over becoming cast in its barrier before being removed from its barrier and declared a late scratching on veterinary advice at 4.05 pm. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

YOU KNOW (J Fawcett) - Over-raced in the early to middle stages when the pace eased.

IN VOGUE (A Goindasamy) - Slow to begin. Had to be steadied near the 1500 metres when the pace eased.

**PRIMO VINO** (J Kamaruddin) – Had to be steadied near the 1500 metres when the pace eased.

**RARE COMPANY** (R Elliot) - Had to be steadied near the 1500 metres when the pace eased. Raced three wide without cover from near the 1200 metres.

JACK WESTEND (T Thornton) – Raced four wide without cover from near the 1200 metres.

**E Nicholas** (GOOD TIME GARRY) - Issued with a warning for unreasonably easing the pace of the race near the 1500 metres hampering YOU KNOW, IN VOGUE, PRIMO VINO and RARE COMPANY which all had to be steadied to varying degrees.

**K Hannan** (KAWATIRI) - Issued with a warning for unreasonably easing the pace of the race near the 1500 metres hampering YOU KNOW, IN VOGUE, PRIMO VINO and RARE COMPANY which all had to be steadied to varying degrees.
