Ashburton Racing Club - Thursday 16 March 2023

Race 4 - HYGAIN MAIDEN STAYERS MAIDEN 2200m

FAYE'S WARRIOR (T Moseley) – Trainer Mr P Harris advised Stewards that FAYE'S WARRIOR underwent a veterinary examination on Thursday 23 March which revealed bone chips to the left-fore knee. P Harris further advised that the mare has now been retired from racing and will be sent to stud.

Race 5 - BETTY WADLEY MEMORIAL 2200m

SEARCHLIGHT (J Fawcett) – Trainer Ms T Rae reported to Stewards that SEARCHLIGHT pulled up slightly sore in the front area. T Rae further advised that the mare has spent the last few days swimming and it is her intention to continue with its current preparation.

Wellington Racing Club - Saturday 18 March 2023

Race 8 – AL BASTI EQUIWORLD DUBAI NEW ZEALAND OAKS (G1)

J Laking (MEHZEBEEN) - Admitted a charge in that he struck his mount MEHZEBEEN 7 times (2 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$2,000.

Race 8 – AL BASTI EQUIWORLD DUBAI NEW ZEALAND OAKS (G1)

J Fawcett (MISCHIEF MANAGED) - Admitted a charge in that she struck her mount MISCHIEF MANAGED 7 times (2 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of J Fawcett's licence to ride in races from the conclusion of racing on Saturday 29 April until the conclusion of racing on Saturday 6 May, 5 national riding days.

RACE COMMENTS

Race 1 PUNTERS CHALLENGE 15 APRIL 1600m

ROYAL KHAN (J Kamaruddin) - Slow away.

BUGATTI (S Weatherley) - Slow away.

PRIMA DONNA (B May) - Crowded shortly after the start having to be steadied.

SANTISSIMA (L Callaway) - Steadied near the 1200 metres then being inclined to race keenly for a distance.

COME BACK TIGER (M Hudson) - Raced three wide without cover throughout.

DRAKE BAY (J Fawcett) - Over raced in the middle stages. Had difficulty obtaining clear running in the final straight.

JUST MAYBE (L Sutherland) - Checked when placed in restricted room near the 1000 metres.

SOMBRA DEAMOR (A Mudhoo) - Held up early in the straight. Crowded to the inside of PRIMA DONNA (B May) which lay in near the 200 metres. B May was advised to exercise greater care.

POWERFUL MOSS (D Montes de Oca) - Held up early in the final straight and was unable to obtain clear running until near the 250 metres. Lost the left front plate during the running.

T Moseley (COLOSSAL) - Admitted a charge in that he permitted his mount COLOSSAL to shift inwards when not sufficiently clear of JUST MAYBE which was checked near the 1000 metres. After considering submissions the Adjudicative Committee imposed a suspension of T Moseley's licence to ride in races from the conclusion of racing on Saturday 25 March until the conclusion of racing on Sunday 2 April, 4 national riding days.

Race 2 PAT REARDON FAMILY 1200m

WILD ROVER (S Weatherley) - Slow away.

ZOULANDER (J Fawcett) - Slow away.

THE MOTIVATOR (T Moseley) - Jumped away awkwardly after being fractious in the barriers.

ART DE TRIOMPHE (K Chowdhoory) - When questioned regarding performance, rider advised that the mare would benefit from today's race, coming back from a long lay off.

MAKE BELIEVE (K Mudhoo) - When questioned regarding performance, connections were of the opinion that being taken on in front had been detrimental to the mare's chances today. A post-race veterinary examination revealed the mare to have a slow recovery rate.

Race 3 COCHRANES FARM MACHINERY 1200m

SENTIENT - Declared a late scratching at 12.13pm due to transport difficulties.

SURCHARGE (J Fawcett) - Jumped away awkwardly and blundered.

WHERE'S WALLY (T Moseley) - Jumped away awkwardly.

MORE THAN WORDS (T Comignaghi) - Jumped away awkwardly losing ground.

GLAMOUR (M Hudson) - Began awkwardly making contact with MR HASS and losing ground with the rider becoming briefly unbalanced.

MR HASS (T Newman) - Blundered at the start and was then contacted shortly after by GLAMOUR which began awkwardly.

MISS BRITTANY (G Saejorhor) - Raced wide without cover throughout.

KIKIMORA (S Weatherley) - When questioned regarding performance, rider was of the opinion the filly would now be better suited over more ground and being ridden in a more forward position.

Race 4 PETERSENS JEWELLERS LADIES BRACELET 2YO 1000m

LUCKY STEP (L Callaway) - Slow to begin.

GWYNVER (K Mudhoo) - Began awkwardly losing ground.

MOGUL (B May) - Slow to begin and then hampered losing ground.

RADIANT REACH (T Moseley) - Slow to begin.

L Callaway (LUCKY STEP) - Issued with a warning after he omitted gear (stirrup irons) when weighing out.

Race 5 SELWYN RAKAIA VET SERVICES 3YO 1400m

CHARBANO (K Chowdhoory) - Slow to begin. Held up rounding the final turn and when attempting to obtain clear running near the 500 metres placed LIFESTYLE in restricted room. K Chowdhoory was advised to exercise greater care. Bumped with DODDLE for a distance passing the 200 metres.

LIFESTYLE (B May) - Slow to begin. Placed in restricted room near the 500 metres.

LET'S GO (K Mudhoo) - Slow to begin.

NIGHT RAIDER (J Mudhoo) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

GOLDIE'S CHANCE (T Moseley) - Raced wide in the early stages before improving forward from the 1000 metres to sit outside the leader near the 700 metres.

DECISION TIME (C Barnes) - Raced wide throughout.

MARYWEKA (L Sutherland) - Raced three wide without cover throughout.

DODDLE (S Weatherley) - Made contact with CHARBANO when dictated outwards by MARYWEKA (L Sutherland) approaching the 200 metres. L Sutherland was advised to exercise greater care. Contributing was some inward movement by CHARBANO which was laying in. DODDLE and CHARBANO then continued to come together for a distance.

Following the race, connections of the 2nd placed **DODDLE** and 4th placed **CHARBANO** viewed Stewards' film footage before electing not to proceed with objections.

Race 6 JOHNNY FRESH DARFIELD & YALDHURST HANDICAP 1400m

EPTIMUM (J Fawcett) - The bandage around the left fetlock was removed behind the barriers after becoming loose. Began awkwardly losing ground.

EMANON (D Montes de Oca) - Made contact with the front gate of its barrier stall which then opened marginally ahead of the remaining barriers. As a result EMANON jumped away awkwardly, with Stewards satisfied that EMANON had not gained any advantage.

SERIOUSLY (S Weatherley) - Slow to begin. Contacted by LORD DARCI approaching the 400 metres.

TYLER EIGHT (K Mudhoo) - Slow to begin. When questioned regarding performance, rider advised he had got further back than intended after jumping from the outside barrier and having to go back to obtain cover.

FRANKIE THE FOX (C Campbell) - Began awkwardly losing ground.

J Mudhoo (SUMMER FESTIVAL) - Was reminded of his obligation to ride his mounts out fully to the finish after briefly relaxing his ride when misjudging the finishing line. Stewards were satisfied that this had not compromised his finishing position in the race.

J Mudhoo (SUMMER FESTIVAL) - Admitted a charge in that he struck his mount SUMMER FESTIVAL 7 times (2 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of J Mudhoo's licence to ride in races from the conclusion of racing on Saturday 25 March until the conclusion of racing on Wednesday 5 April, 5 national riding days.

Race 7 SEATON FAMILY MEMORIAL HORORATA GOLD CUP 1800m

THE GROWLER (K Chowdhoory) - Slow away. Over raced in the middle stages.

SECOND THOUGHT (J Kamaruddin) - Slow away.

MISS TAVI (T Jonker) - Jumped away awkwardly.

TAKE THE DEEL (G Jogoo) - Jumped away awkwardly.

CAPO DELL IMPERO (T Moseley) - When questioned regarding performance, rider advised that after getting back the gelding had not been helped by the race being run at a slow tempo but had found the line well over the concluding stages.

G Jogoo (TAKE THE DEEL) - Issued with a warning after he used his whip on TAKE THE DEEL when the horse was out of contention.

Race 8 RACE A SUPER SETH FILLY WITH GO RACING & CARSTON 1600m

DA VINCI GIRL (Y Coonee) - Jumped away awkwardly getting its head up losing ground. Was then ridden along in the early stages in an attempt to recover before having to be steadied when improving onto heels near the 1400 metres and shift outwards, then racing wide without cover for the remainder of the race. Apprentice Y Coonee was shown video footage of his ride in the presence of the apprentice mentor and advised that he would be expected to show better judgement in future.

PROSERVE (K Chowdhoory) - Slow away.

LUCKY SIMON (S Weatherley) - Crowded shortly after leaving the barriers losing ground.

THE BOLD LIONESS (K Mudhoo) - Jumped away awkwardly.

VICTOR ROUGE (T Moseley) - Over raced in the early stages getting its head up and racing very ungenerously for a distance. Steadied when awkwardly placed near heels approaching the 400 metres.

TIFFEN (J Mudhoo) - The saddle shifted forward near the 1100 metres with the rider being placed at a disadvantage and the mare not being persevered with in the straight.

Y Coonee (DA VINCI GIRL) - Admitted a charge in that he struck his mount DA VINCI GIRL 8 times (3 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of Y Coonee's licence to ride in races from the conclusion of racing on Saturday 25 March until the conclusion of racing on Wednesday 5 April, 5 national riding days.

D Bothamley (NORTIBUTNICE) - Admitted a charge in that he struck his mount NORTIBUTNICE 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

B May (JON OL ROCCO) - Admitted a charge in that he struck his mount JON OL ROCCO 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of B May's licence to ride in races from the conclusion of racing on Wednesday 3 May until the conclusion of racing on Thursday 11 May, 6 national riding days.

Race 9 VALACHI DOWNS S.I T'BRED BREEDERS STAKES (G3) 1600m

FETTERCAIRN (B Murray) - Slow away.

NAMIBIA MISS (B May) - Slow away. Hampered near the 200 metres.

EARS BACK (J Fawcett) - Jumped away awkwardly getting its head up losing ground. Hampered near the 200 metres when MISS ELLA lay out. Crowded near the 100 metres when NAMIBIA MISS (B May) lay in under pressure. B May was advised to exercise greater care.

BURGIE (T Moseley) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Had to be steadied when improving onto heels rounding the bend near the 500 metres.

ELIZABETH ROSE (J Kamaruddin) - Over raced in the middle stages.

ROYCE ROCA (T Newman) - Raced wide without cover. Placed in restricted room when weakening rounding the final bend near the 500 metres and was then not persevered with in the straight finishing a distant last. Rider reported she felt there was something amiss with the gelding. A post-race veterinary examination did not reveal any obvious abnormality.

MISS ELLA (S Weatherley) - Rider reported that the mare had hung throughout. A post-race veterinary examination revealed the mare to have a poor rate of recovery.

J Kamaruddin (ELIZABETH ROSE) - Admitted a charge in that he struck his mount ELIZABETH ROSE 6 times (1 more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 10 SVS VETERINARY SUPPLIES 2000m

NOBLE KNIGHT (K Chowdhoory) - Jumped away awkwardly

TAVI WITH ME (T Newman) - Slow away.

POVERTY BAY (B May) - Over raced when wide in the early stages before obtaining cover near the 1400 metres.

YOUNEVERKNOW (J Kamaruddin) - Raced three wide without cover from the 1400 metres.
