GENERAL

Race 8 – MAJESTIC HORSE FLOATS 1400

SHOW D'OR (C Carmine)

K Hercock was incorrectly declared by connections on race morning as the replacement rider for J Parkes but being the trainer/owner of a runner in the race contravened the rules with the replacement rider being C Carmine.

Race 8 – LA BULL CAFE 1700 (1700 metres)

MOONLIGHT HUSTLER – Trainer K Hercock advised Stewards that the mare was found to have suffered lacerations to a hind leg consistent with being galloped on during the running yesterday. She also advised MOONLIGHT HUSTLER would be undergoing further veterinary attention next week.

RACE COMMENTS**Race 1 | BOWLS WELLINGTON RACEDAY 15 JULY MAIDEN 3YO 1200m**

TARAZETTO (C Butler) - Restrained at the start to take cover from a wide draw. When questioned C Butler advised the filly having its first race, raced greenly throughout and would take natural benefit with today's run.

SPENCER (C Barnes) - Raced keenly into the first turn.

MAGGIE MCMUFFIN (D Bradley) - Had to be restrained shortly after the start when LILI MARLENE (L Douglas) crossed when only marginally clear. L Douglas was shown footage of his ride and issued with a warning. Over-raced in the early and middle stages.

PRINCESSA GOLD (C Carmine) - Had to steady shortly after the start to avoid the heels of SPENCER, which shifted out marginally.

SWINDLE (K Hercock) - Shifted in under pressure over the final stages and made brief contact with LILI MARLENE. Connections of LILI MARLENE viewed footage of the final stages but elected not to proceed with an objection.

L Douglas (LILI MARLENE) - Issued with a warning after allowing his mount to shift in shortly after the start when not the required distance clear of MAGGIE MCMUFFIN which had to be steadied.

Race 2 | GRANT PLUMBING MAIDEN 1400m

FAUSTIAN BARGAIN (C Butler) - Slow away then tightened when MAIN STREET shifted in.

CEE ARE EL (M Hudson) - Raced four-wide throughout.

SPLIT (T Davies) - Raced three-wide throughout.

LOVEHELEN (L Sutherland) - Lugged out rounding the turn.

Race 3 | KING OF COMEDY @ NOVARA PARK N.I. CHALLENGE STAKES 1400m

MAKE TIME (L Sutherland) - Slow away.

SWEETJINEEN (C Barnes) - Over-raced near the 1200 metres and had to be continuously steadied.

BELARDO BOY (J Riddell) - Steadied 1200 metres when improving onto the heels of SWEETJINEEN.

KELLY COE (C Butler) - Raced four-wide throughout.

Race 4 | MARSH INSURANCE 1600m

MAOLLA MISS (L Sutherland) - Slow away.

ZOE SATIN (L Douglas) - Raced three-wide without cover.

T Davies (KAHU ROCK) - Admitted a charge in that she struck her mount KAHU ROCK 6 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

C Butler (HI YO SASS BOMB) - Admitted a charge in that she struck her mount HI YO SASS BOMB 6 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 25 June until the conclusion of racing on Wednesday, 5 July, 5 national riding days.

Race 5 | **LINCOLN FARMS 1200m**

PUKE PARK (Mahipal Singh) - Shifted out abruptly on jumping away simultaneously as MR FABULOUS jumped inwards, resulting in REIGN IT IN, DURHAM LAD and AMOSIA being checked.

REIGN IT IN (J Riddell) - Checked at start. Bumped 800 metres. Connections were advised a warning has been placed on the racing manners of REIGN IT IN.

DURHAM LAD (T Davies) - Checked at start.

AMOSIA (T Taiaroa) - Checked at start.

PRIORESS (M Singh) - Slow away.

TAVI WITH ME (C Barnes) - Crowded at the start then settled back.

MR FABULOUS (L Douglas) - Checked near the 800 metres when REIGN IT IN after receiving a bump from TANZANITE ROSE, shifted outwards into the line of MR FABULOUS despite the rider's efforts. Was not persevered with for the remainder. A post-race veterinary examination did not reveal any obvious abnormality.

GEE STRING (K Hercocock) - Lay inwards, making the bend near the 800 metres awkwardly, hampering ROCABABY, which had to steady.

ROCABABY (B Grylls) - Hampered 800 metres.

PEPEHA (L Sutherland) - Raced wide without cover throughout.

Race 6 | **NEW WORLD CHURTON PARK PARLIAMENTARY HANDICAP 2200m**

PRINCE LEO (L Sutherland) - Began awkwardly hampering DIVINE SPIRIT

DIVINE SPIRIT (C Barnes) - Hampered at the start

JUSTASKPERCY (C Butler) - Commenced to over-race after negotiating the crossing near the 1500 metres and improved rapidly up on to heels and had to be steadied. Raced wide for the majority.

ALL IN ALL (B Grylls) - Disappointed. B Grylls advised the gelding was unsuited to the holding track. Trainer J Zuppich undertook to monitor the progress of ALL IN ALL over coming days and report any anomalies to Stewards.

Race 7 | **WELLINGTON SEAMARKET 2100m**

DEEP BLUE (B Grylls) - Slow to begin.

LOVETTORLEAVEIT (C Butler) - Shifted outwards at the start crowding EL ATTITUDE, with both runners losing ground.

EL ATTITUDE (T Taiaroa) - Crowded at the start losing ground.

SMART ATTIRE (T Davies) - Slow to begin.

TRAMORE (C Lindsay) - Raced three-wide without cover throughout.

CROUCH (C Carmine) - Over-raced in the early stages having to be steadied.

MAKKALDEE (K Hercock) - When asked to comment on performance rider K Hercock advised that in her opinion the gelding had not handled today's holding track conditions.

LEGALLY BLONDE (C Barnes) - When asked to comment on the performance of a favoured runner, rider advised the mare had been disappointing but may not have handled the holding track conditions.

MATINEE (L Sutherland) - Slow away.

MONKEY TOWN (C Butler) - Shifted outwards passing the 1000 metres dictating MANOLO (T Taiaroa) outwards. Both riders were shown footage of their rides in the presence of the Apprentice Mentor.

MANOLO (T Taiaroa) - Dictated outwards 1000 metres. Raced wide throughout.

BADGERINGDAWITNESS (L Douglas) - Steadied passing the 1000 metres.

SHEZ SUPER (C Lindsay) - Rider reported the mare was not comfortable in today's track conditions.
