RACE COMMENTS

Race 1 | **IN TOUCH DECORATORS & BUCKLEY CONTRACTING MAIDEN HURDLE 3000**

WAIAGARA (S Fannin) - Put in a poor jump at the second fence dislodging the rider, who was uninjured.

CHEEKY AZZ (K Wiles) – Had to be steadied when over-racing early.

NO TEARS (B Lammas) - B Lammas was questioned into his ride and in particular his lack of vigour in the middle stages. B Lammas advised that his mount was hampered by the fallen rider at the second fence on the first round and then collided with the riderless horse when that runner shifted out abruptly at the fourth fence. B Lammas advised that his mount was unable to gain momentum, although its jumping was reasonable, he was unable to improve to any extent. B Lammas was advised that in similar circumstances he is expected to retire a runner when so far back and out of contention. Underwent a post-race veterinary examination which revealed a very slow recovery rate.

PONTARDAWE (H McNeill) - Put in a poor jump at the fence near the 600 metres when well back and out of contention and was retired from the race prior to jumping the second to last fence.

Race 2 | **MURRAY CONTRACTORS OPEN HURDLE 3000**

HAPPY STAR (S Fannin) - Raced keenly through the early and middle stage when leading. Hit the fence near the 600 metres. Misjudged the second to last fence. Misjudged the last fence.

MOTIVATION (J Power) - Jumped indifferently throughout and was not persevered with over the final stages when well back and out of contention. Underwent a post-race veterinary examination which did not reveal any abnormality.

TWEEDLEDEE (P Matthews) - Hit the fourth fence. Landed awkwardly after jumping the first fence in the back straight on the last round.

MIZZENA (N Downs) - Hit the fence near the 600 metres.

Race 3 | **BUSH GROUND SPREADERS MAIDEN 2200**

ALL OVER NOW (A Scott) - Slow to begin. Lost the off hind plate during the running.

IMA WONDER (M Davies) - Crowded at the start.

ZAC FLASH (V Mason) - Hampered shortly after the start when ZOEZ LEGACY shifted out abruptly.

ZOEZ LEGACY (S Mohammed) – Steadied near the 2100 metres to avoid the heels of COUNTRY BUMPKIN which shifted in when not fully clear. Rider E Quinn was advised to exercise greater care in similar circumstances.

BLACKCOMB (S Mynott) – Raced keenly in the early stages when being restrained.

SWEET TABOO (A McIntyre) - Hampered near the 1300 metres when OVERAGAIN shifted inwards.

E Taiaroa (OVERAGAIN) - Was shown footage of his ride and reminded of his obligations after allowing his mount to shift in crowding SWEET TABOO near the 1300 metres.

S Kumar Paswan (I'M CHUCK) - Issued with a warning with regard to his whip use in the home straight.

Race 4 | **TARARUA HELIWORK 2200**

SAILOR JACK (V Mason) - Slow to begin.

THE JAKKAL (N Jenkins) - Crowded at the start. Rider lost the use of her left iron for a short distance before regaining it near the 1800 metres.

MR FAHRENHEIT (E Woller) - Crowded at the start losing ground.

AONGATETE EXPRESS (S Mynott) - Slow to begin.

SUMMER WARRIOR (N Smith) - Steadied passing the 2100 metres when improving onto the heels of CALL ME JACK.

KID WARRIOR (C Wiles) – Lay in when placed under pressure in the final straight.

MISS INTERPRET (C Sharp) - Finished some distance last when not persevered with in the home straight. When questioned C Sharp considered something may be amiss with the mare. A subsequent veterinary examination revealed the mare to have suffered cardiac arrhythmia. Trainer R Manning was advised that the mare would not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

Race 5 | **WOODVILLE SERVICE CENTRE OPEN STEEPLECHASE 4000**

TITTLETATTLE (G Walsh) - Slow to begin.

NO TIP (J Power) - Jumped the second fence awkwardly. Rider J Power reported the gelding had felt sore on pulling up and dismounted. A subsequent veterinary examination revealed a tendon injury to the left front leg. Co-trainer P Nelson advised Stewards the gelding is retired. Connections were advised that a veterinary clearance is required if the gelding is to race again.

FLYINGWITHOUTWINGS (N Downs) - Raced keenly in the early stages when being restrained.

RAUCOUS (H McNeill) – Misjudged the first fence in the back straight.

THE ANARCHIST (E Farr) - Rider E Farr did not ride the gelding out fully over the concluding stages when obviously sore and dismounted on pulling up. Underwent a post-race veterinary examination which revealed a tendon injury to the left front leg. Connections were advised that a veterinary clearance is required prior to the gelding racing next.

Race 6 | **AWE MCNICOL TRANSPORT HIGHWEIGHT 1600**

BEAU GESTE (K Wiles) - Slow to begin.

HEY HEY HEY (E Farr) - Slow to begin. Hung inwards under pressure over the final stages.

DON'T ASK (S O'Malley) - When questioned into the disappointing run, rider S O'Malley advised the gelding travelled well throughout but when placed under pressure rounding the home turn, failed to run on and was disappointing. A subsequent veterinary examination did not reveal any obvious abnormality.

DEEP BLUE (S Karnicnik) – Had to change ground near the 250 metres to improve.

WANNABE 'N' VEGAS (K Macnab) - Was inclined to lug inwards under pressure in the home straight and had to be continuously straightened by the rider.

E Farr (HEY HEY HEY) - Issued with a warning after she struck her mount six times prior to the 100 metre mark with Stewards taking into account her clear recent record with regard to any breach of this whip rule.

Race 7 | **DAIRY POND SPREADERS HIGHWEIGHT 1600**

RISING RANSOM (N Downs) – Steadied near the 800 metres when in restricted room.

COURAGEOUS STEP (B Lammas) - Shifted out on the point of the home turn and bumped IFFRAAJABLE which was briefly unbalanced.

N Downs (RISING RANSOM) - Admitted a charge in that he struck his mount RISING RANSOM six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.
