RACE COMMENTS

Race 1 HOBSON HORSE COACHES & MOTOR HOMES 2018 LTD 1600m

OBRIGADO (D Parker) - Slow away.

HAPPY STAR (S Fannin) - Was obliged to race three-wide without cover so was taken forward towards the end of the back straight.

BAK DA MASTER (M Roustoby) - Lost the off side hind plate during the running.

S Fannin (HAPPY STAR) - Admitted a charge in that he struck his mount HAPPY STAR 7 times prior to the 100-metre mark, twice more than is permitted. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing today, Monday, 10 April until the conclusion of racing on Wednesday, 19 April, 1 national jumps/highweight riding day and in addition imposed a fine of \$200.

Race 2 BERNIE WALSH ALUMINIUM & GLASS 2200m

WAIPAPA (G Walsh) - Slow away, then being restrained in the early stages to obtain cover, getting its head up on a number of occasions. Checked when crowded passing the 200 metres.

ROAD DIVA (M Roustoby) - Slow away.

RONIN POROTENE (N Downs) - Crowded over the concluding stages.

GOBUYIT (L Douglas) - Steadied when crowded over the concluding stages. Contributing was some inwards movement from ABOVE SUSPICION (H McNeill). H McNeill was advised to exercise greater care.

LOCHWINNOCH (K Macnab) - Lay inwards under pressure in the straight.

N Downs (RONIN POROTENE) - Issued with a warning after permitting his mount to shift outwards under pressure near the 200 metres, dictating MORUS outwards crowding WAIPAPA which was checked. Contributing was some inwards movement from LOCHWINNOCH.

K Macnab (LOCHWINNOCH) - Issued with a warning after permitting her mount to shift inwards passing the 200 metres when not fully clear of WAIPAPA and continuing to shift inwards over the concluding stages crowding RONIN POROTENE on to GOBUYIT.

S Fannin (LUCKY VIKING) - Admitted a charge in that he struck his mount LUCKY VIKING 6 times prior to the 100-metre mark, one more than is permitted. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing Wednesday, 19 April to the conclusion of racing on Thursday, 20 April, 1 national jumps/highweight riding day.

Race 3 GLADIATORS DARTS TEAM MAIDEN 2200m

SEFTON (W Kennedy) - Slow away. Finished well back. Rider had no excuse.

RHODESIAN (H McNeill) - Slow away. Rider dropped his whip near the 600 metres.

PERCYTHEPERINCANTO (T Mitchell) - Slow away then over-raced when being restrained shortly after the start.

ROULADE (M Hashizume) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

LEGALLY BLONDE (C Barnes) - Raced three-wide without cover.

TAHI TAMA (M Singh) - Lay inwards passing the 200 metres.

Race 4 MACDOUGALLS AGRI SERVICES MAIDEN 1100m

J Lupton (BRAZINCO) - Fined \$50 under the Minor Infringement Schedule for the late declaration of rider.

YELSERP (M Hashizume) - Slow away.

GIA MARQUESA (C Grylls) - Jumped away awkwardly. When questioned regarding performance, rider advised the filly had raced very greenly.

GRAEME JOHN (W Kennedy) - Lay inwards early in the straight.

Race 5DANNEVIRKE CARRIERS 2YO MAIDEN 1100mSTIPULATOR (T Mitchell) - Slow away.

VAVOOM (K Hercock) - Crowded leaving the barriers losing ground. Had to be firmly restrained when improving onto the heels of QALI AL FARRASHA near the 700 metres. Struck a heel of CALL A FRIEND and blundered near the 600 metres.

HERBERT (H McNeill) - Raced three-wide without cover. Raced very greenly when placed under pressure in the straight.

QALI AL FARRASHA (C Grylls) - Raced greenly near the 500 metres, losing ground. Hampered passing the 200 metres when HERBERT ducked out under pressure. When questioned regarding performance rider advised that the filly had raced greenly in its race-day debut and would benefit from the experience.

Race 6 BRAESIDE FARM LTD 3YO MAIDEN 1200m

SILVER MUSK (A Mudhoo) - Slow away.

IDA MATILDA (A Goindasamy) - Slow away.

SAINT OLIVER (J Riddell) - Over-raced in the lead in the early stages.

NASSAU (T Mitchell) - Lay inwards early in the straight having to be corrected.

Race 7 MERRYLEES HOTEL – NIC & LEM HANDICAP 1400m

GLIDE QUEEN (T Taiaroa) - Refused to leave the barriers when the start was made losing its chance in the race. Trainer M Eales was advised GLIDE QUEEN must barrier trial to the satisfaction of Stewards prior to racing next.

SWING LOW (H McNeill) - Slow away. Hampered 200 metres. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

TRUSTWORTHY (C Barnes) - Hampered 200 metres.

SHARE POWER (A Goindasamy) - Jumped away awkwardly. Raced ungenerously for a distance passing the 1200 metres. Checked and dictated inwards 200 metres.

SEA MONARCH (J Chung) - Raced three-wide without cover. Lay inwards under pressure in the straight. J Chung was shown footage of his ride in the presence of the Apprentice Mentor after he allowed his mount to shift inwards passing the 200 metres, resulting in SHARE POWER being checked and then being dictated inwards, hampering SWING LOW and TRUSTWORTHY. Stewards took into account the tendency of SHARE POWER, which was racing greenly, to shift in and away from SEA MONARCH.

PLATINUM ASSAULT (J Riddell) - Held up approaching the 300 metres.

Race 8 DANNEVIRKE DAIRY SUPPLIES WOODVILLE-PAHIATUA CUP 1600m

HERSELF (T Taiaroa) - Slow away.

ALOFT (A Goindasamy) - Slow away.

ORLOV (R Elliot) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

RUBY ROCKS (A Mudhoo) - Raced three-wide without cover. A Mudhoo reported the mare is better suited to more rain-affected footing.

Race 9 RUAHINE PROPERTY WORKS MAIDEN 1600m

WALKINTHEPARK (M Hashizume) - Raced three-wide without cover.

STORMCAST (T Newman) - Raced four-wide without cover.

FREYJA'S GODDESS (M Singh) - Over-raced in the middle stages.

SORCHA (M McNab) - When questioned regarding performance rider could offer no excuse.

T Taiaroa (SHIMMERING) - Reminded of her obligation to ride her mount out fully to the finish.

K Hercock (SCRIPT) - Admitted a charge in that she struck her mount SCRIPT 6 times prior to the 100-metre mark, one more than is permitted. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 15 April until the conclusion of racing on Thursday, 20 April, 2 national riding days, and in addition imposed a fine of \$500.

Race 10 GOODMAN CONTRACTING LTD MAIDEN 1600m

SKY CRUZA (A Mudhoo) - Jumped away awkwardly hampering JAMAICAN EXPRESS.

JAMAICAN EXPRESS (M Hudson) - Hampered leaving the barriers losing ground. Lay inwards under pressure in the straight.

LONGBURN LAD (K Hercock) - Over-raced in the early and middle stages.

LINCOLN THE FOX (T Davies) - Raced three-wide without cover. Briefly steadied off heels near the 300 metres.

THE REPUBLICAN (W Kennedy) - After travelling mid-field dropped out over the final stages. Rider W Kennedy had not excuse.

BURLACE (C Barnes) - When questioned regarding the form reversal, Trainer K Gray advised the mare had failed to see out the distance at its most recent start and was better suited dropping back to the 1600 metres today.
