**RACE COMMENTS** 

Race 1 WORLD SOLAR / A B LIME HANDICAP (1600m)

TARAMEA LAD (K Williams) - Began awkwardly and shifted in abruptly losing considerable ground.

**ALBATROSS** (S Khetoo) - Crowded at the start losing ground.

TIFFEN (T Moseley) - Slow to begin.

**PONIARD** (T Comignaghi) - When questioned regarding the performance rider advised that the gelding had been flat from the 1000 metres and in her opinion may not have handled today's track conditions.

### Race 2 INSURANCE BROKERS ALLIANCE / LAWSON FORESTRY CONTRACTING (1600m)

LADY'S ROULLET (K Kalychurun) - Slow to begin.

SHE'S A CON (L Sutherland) - Slow to begin. Improved wide from the 1000 metres.

**INTERMINGLE** (D Montes de Oca) - Slow to begin. When questioned regarding the performance rider advised he was disappointed and could offer no tangible excuse.

**LUGGATE LAD** (C Campbell) - Crowded when tiring passing the 500 metres.

**LEO'S HIPPO** (R Beeharry) - Raced three wide without cover throughout. Lay in under pressure throughout the run home.

**L Sutherland** (SHE'S A CON) - Assisted by M Northcott, admitted a charge in that she struck her mount SHE'S A CON 6 times prior to the 100 metres (1 more than permitted). After viewing replays and considering submissions on penalty the Adjudicator suspended Miss Sutherland's rider's licence from the conclusion of racing on Thursday 20 April up to and including Thursday 27 April, 5 national riding days.

#### Race 3 EWAN ALLAN HONDA THORNBURY HANDICAP (1400m)

Trainer **P Harris** (CAPTAIN OUMUAMUA) - Issued with a warning when presenting the gelding with visor blinkers and not the notified blinkers.

**CAPTAIN OUMUAMUA** (T Moseley) - Fractious on the way to the start and was observed to have blood present in its mouth at the barriers, with a pre-race veterinary examination revealing the gelding to have injured a tooth and was cleared to race. The tongue tie was dislodged on the way to the barriers and could not be refitted prior to the start.

**ZOULANDER** (K Chowdhoory) - Bounded at the start and was then restrained to obtain cover shortly after.

**ZAC BLACK** (L Sutherland) - Raced three wide without cover until near the 900 metres.

**EMANON** (D Montes de Oca) - Lay out throughout the run home having to be straightened on a number of occasions.

#### Race 4 PANKHURST SAWMILLING / FISHER ALUMINIUM GUMMIES BUSH HANDICAP (1400m)

**FIRE 'N' REIGN** (K Kwo) - Underwent a pre-race veterinary examination at the request of the trainer and was cleared to start. Lost the off-hind racing plate during the running.

**BOB MARLIE** (G Jogoo) - Slow to begin.

**DECEPTIO VISUS** (L Callaway) - Lay in passing the 900 metres briefly placing an inside runner in restricted room.

**COSY NOOK** (D Montes de Oca) - Made contact with the running rail near the 900 metres losing some momentum when placed in restricted room by DECEPTIO VISUS which lay in at this point.

**PLATINUM ROAD** (K Williams) - Had to be restrained off heels passing the 350 metres when COSY NOOK (D Montes de Oca) shifted ground outwards. D Montes de Oca was advised to exercise greater care when shifting ground.

**KAPALKA** (T Comignaghi) - Rider dropped her whip passing the 300 metres. When questioned regarding the improved performance trainer M Pittman advised the gelding was ridden to suit today and races well on this track.

#### Race 5 KENNEDY BUILDING / RIVERTON BUTCHERY LONGWOOD HANDICAP (2147m)

CARLOS (S Khetoo) - Slow to begin.

MIA ROSSI (G Jogoo) - Slow to begin.

**SKYROCKETSINFLIGHT** (K Kalychurun) - Slow to begin.

TWILIGHT GEM (L Callaway) - Raced wide throughout.

MADISON ROSE (T Moseley) - Held up rounding the final bend.

**DORIS DAY** (L Sutherland) - When questioned rider could offer no explanation for the disappointing performance. Cotrainer K Tyler advised Stewards he would be reassessing the racing future of the mare.

### Race 6 DONALD WHITE HEDGE CUTTING HIGHWAY STAKES (2147m)

KILOWATT (S Khetoo) - Slow to begin.

**THE TUI TOILER** (G Jogoo) - Began awkwardly and shifted out crowding THE GROWLER. Over-raced in the early stages.

**THE GROWLER** (K Chowdhoory) - Crowded at the start and was slow to begin.

ZAMBEZI ZIPPER (L Sutherland) - Raced wide without cover from the 1000 metres.

**LEAVE IT TO ME** (T Moseley) - Lay in early in the run home having to be straightened. Shifted outwards across heels passing the 200 metres to find clear racing room.

**HUMBUCKER** (K Williams) - When asked to comment on the performance of favoured runner rider was of the opinion the gelding may have held its breath during the running.

## Race 7 SPEIGHTS FORDE-WINDERS SHEARING HANDICAP (1200m)

**T Comignaghi** (DIVINE REGULUS) was examined by St John Ambulance personnel around at the start after being kicked in the leg by a horse prior to entering the barriers. Miss Comignaghi was found to be uninjured in this incident and subsequently cleared to ride.

THE GOOD SHEPHERD (K Kalychurun) - Bounded at the start.

**RADIANT ROSIE** (B Rogerson) - Slow to begin.

GO LOTTE (S Khetoo) - Slow to begin.

GOODANYA (T Moseley) - Taken back from a wide draw shortly after the start.

**BENAUD** (D Montes de Oca) - Restrained in the early stages to obtain cover.

EARL OF ORKNEY (K Kwo) - Raced three wide without cover throughout.

**SO MUCH MOUR** (L Sutherland) - Briefly steadied to avoid the heels of EARL OF ORKNEY (K Kwo) which shifted ground outwards under pressure passing the 200 metres. K Kwo was advised to exercise greater care when shifting ground.

#### Race 8 ROSIE BROWN TRAINING / FORD AUTO SERVICES (1200m)

**WHATA SHAMBLES** (S Khetoo) - Late scratching at 3.31pm by order of the Stewards after becoming very fractious and rearing prior to parading to the start with the rider advising Stewards he did not want to ride the mare. Connections were advised WHATA SHAMBLES must barrier trial to the satisfaction of Stewards prior to racing next. Trainer G Gibson advised Stewards he would give consideration to sending the mare for a spell prior to going to the trials.

**BUDAI** (L Sutherland) - Bounded at the start losing ground.

THE KINGS GIRL (K Kwo) - Began awkwardly making contact with SANDY SHORE.

SANDY SHORE (L Callaway) - Contacted on jumping.

CHOUX MACHER (B Murray) - Over-raced in the early stages.

**MAGGIE MAY** (D Montes de Oca) - Raced wide throughout. Lay in throughout the run home having to be straightened on a number of occasions.

**ZIRCON** (G Jogoo) - When questioned regarding the disappointing performance rider advised in his opinion the filly had failed to handle today's track conditions.

**D Montes de Oca** (MAGGIE MAY) - Admitted a charge that he failed to ride his mount out over the final 50 metres of the race when there was a reasonable chance of finishing in 4<sup>th</sup> placing. After viewing replays and considering submissions on penalty the Adjudicator suspended Mr Montes de Oca's rider's licence from the conclusion of racing on Saturday, 15 April up to and including Saturday 29 April, 2 weeks.

### Race 9 NZB INSURANCE PEARL SERIES (1200m)

**ADIKTIV PASSION** (T Moseley) - Slow to begin. Contacted and hampered passing the 600 metres when NINETEENSIXTYTWO (S Khetoo) shifted ground. S Khetoo was shown a replay of this incident for educational purposes and advised he must exercise greater care when shifting ground.

MIDNIGHT JANE (B Rogerson) - Slow to begin.

**LUGANO'S ACE** (L Callaway) - Briefly placed in restricted room passing the 1000 metres when runners either side shifted ground marginally.

**SACRED KITTY** (K Kwo) - Over-raced in the early stages.

**NINETEENSIXTYTWO** (S Khetoo) - Shifted ground outwards passing the 600 metres contacting ADIKTIV PASSION which was hampered.
