Race 2 ALPHA FIRST MORTGAGE INVESTMENTS 2200

ROCCIA (V Colgan) – Co-trainer Mr. R Wellwood advised Stewards, the stable was satisfied with the post-race condition of the mare, and it is the stables intention to nominate ROCCIA for the Waikato RC meeting on Saturday 15 April.

Race 7 NZ THOROUGHBRED BREEDERS' STAKES 1600 (G1)

MUSTANG VALLEY (J Riddell) – Trainer Mr. A Forsman reported to Stewards, he was satisfied with the post-race condition of MUSTANG VALLEY, however, has now been sent for a spell.

Race 1 APPARELMASTER WAIKATO 2100

ENCIERRO (W Kennedy) – Over-raced in the early stages. When questioned regarding the performance rider reported that in his opinion the gelding failed to stay the distance.

CREAM (L Satherley) - Knuckled leaving the barriers and shifted outwards shortly after the start briefly unbalancing its rider. Raced keenly through the middle stages when leading and commenced to weaken from the 500 metres. When questioned regarding the performance rider reported that the mare pulled up short in its action. Underwent a post-race veterinary examination which found the mare to have a slow post-race recovery. Stewards will follow up the recovery of the mare with trainer A Sharrock in the coming days.

THE MAYOR (T Mitchell) - Steadied near the 1900 metres when placed to the inside of CREAM.

OSAKA (J Kamaruddin) - Lay in when placed under pressure over the concluding stages.

Race 2 POWER FARMING – WE LOVE FARMERS 2400

SHOCKALLIA (A Goindasamy) - Began awkwardly.

I'M RONALDO (L Douglas) - Slow to begin. Over-raced in the early stages.

SHEEZE A BREEZE (S Spratt) — Over-raced through the early stages. Raced three wide without cover before being allowed to stride forward to lead near the 1000 metres.

KIWI MAN (L Satherley) - Raced greenly in the early stages despite the efforts of its rider. As a result, SHEEZE A BREEZE had to briefly steadied and HERE'S JOHNNY was crowded. Stewards took into account that there was an easing of the pace which contributed to the incident. Again, raced greenly passing the 2100 metres shifting out and away from the heels of KHAN HUNTER which resulted in SHEEZE A BREEZE and ROCKET LAD being forced wider on the track for a short distance. Lay out when placed under pressure over the concluding stages.

CASCATELLA (T Abel) – Over-raced through the early and middle stages.

ROCKET LAD (T Thornton) - Raced wide without cover in the early stages. Raced three wide without cover from the 1000 metres.

RISING ROAD (J Kamaruddin) - Weakened from near the 600 metres and was not persevered with in the final straight when out of contention. Underwent a post-race veterinary examination which revealed the mare to have suffered cardiac arrhythmia. Trainer S Marsh was advised that RISING ROAD will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

SILK 'N' DALE (W Kennedy) - Rider reported that the mare failed to stay the distance after receiving an economical run.

ROCCIA (M Hashizume) - When questioned regarding the improved performance co-trainer R Wellwood reported that the mare had appreciated a change in the training regime and the removal of blinkers today.

S Spratt (SHEEZE A BREEZE) - Issued with a warning after she struck her mount SHEEZE A BREEZE six times prior to the 100-metre mark with Stewards taking into account her clear recent record with regard to a breach of this whip rule.

D Prastiyou (HERE'S JOHNNY) - Admitted a charge in that he struck his mount HERE'S JOHNNY six times prior to the 100-metre mark with the Adjudicator imposing a fine of \$250.

Race 3 WEBSITE ANGELS 2YO 1100

CANNON HILL (V Colgan) - Began awkwardly.

FULL TILT (W Pinn) – Began awkwardly losing ground. Made the bend leaving the back straight awkwardly. Held up entering the final straight having to shift ground outwards to obtain clear running near the 350 metres. When questioned regarding the performance rider reported that the filly raced greenly throughout.

VIVA VIENNA (W Kennedy) – Began awkwardly briefly unbalancing its rider.

DIOR SAUVAGE (L Satherley) - Raced three wide without cover throughout.

FARRAVALLO (S Spratt) - Over-raced in the early stages when leading. When questioned regarding the performance rider reported that after over-racing when being taken on in front the effort had taken its toll at the finish.

GLAMOUR TYCOON (B Grylls) - Shifted out and away from VIVA VIENNA passing the 150 metres.

Race 4 TUATAHI FIRST FIBRE 3YO 1200

WESTWOOD (W Pinn) - Began awkwardly making contact with HANALEI.

PETRUCCI (W Kennedy) - Began awkwardly losing ground.

RUBELLITE (M Hashizume) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

HANALEI (D Prastiyou) - Contacted by WESTWOOD at the start then briefly raced in restricted room. Rider reported that the filly never travelled throughout the running.

I CHOOSE YOU (J Kamaruddin) - Steadied off the heels of KANA when that runner was racing ungenerously near the 800 metres.

KANA (T Mitchell) – Over-raced in the early stages and skied its head when being restrained near the 800 metres. Shifted in approaching the 150 metres making contact with PUKETIRO having to be briefly steadied.

PUKETIRO (V Colgan) – Contacted by KANA approaching the 150 metres when going for a run between WESTWOOD and KANA.

Race 5 RYCO 24/7 SPRINT 1200

NAVALHA (J Kamaruddin) – Began awkwardly losing ground before being restrained to obtain cover in the early stages after jumping from the outside barrier.

MR UNIVERSE (R Beemud) - Began awkwardly contacting the barriers losing ground. Briefly contacted passing the 150 metres.

HIGHLIGHTER (W Pinn) – Began awkwardly shifting out contacting ON THE PROWL. Improved onto heels near the 500 metres having to be steadied.

ON THE PROWL (T Mitchell) – Contacted by HIGHLIGHTER shortly after the start and raced in restricted room shortly afterwards, losing ground.

BEA A ROCA (T Thornton) - Jumped inwards shortly after the start contacting GWEN'S DAUGHTER.

GWEN'S DAUGHTER (A Goindasamy) – Contacted by BEA A ROCA at the start and raced in restricted room shortly afterwards, losing ground. Steadied off heels passing the 800 metres. When questioned regarding performance the rider could offer no explanation.

PISCO SOUR (W Kennedy) – Raced wide without cover throughout.

ORANGE PEARL (M Sanson) - Raced wide in the early stages before being allowed to stride forward and settle outside the leader passing the 900 metres.

HERO WORSHIP (J Allen) - Lay out when placed under pressure passing the 150 metres briefly making contact with MR UNIVERSE. Apprentice rider J Allen was shown the video replays in the presence of the Riding Mentor for educational purposes.

Race 6 TRAFFIC MANAGEMENT WAIKATO LTD 1400

AOTEA LAD (J Allen) - Began awkwardly.

MILLEFIORI (J Kamaruddin) – Began awkwardly. Improved onto and clipped the heels of AOTEA LAD approaching the 800 metres and blundered. Apprentice rider J Kamaruddin was shown the video replays in the presence of the Riding Mentor for educational purposes. Stewards took into account that there was a slight easing of pace which contributed to the incident.

WINNING FOR ALL (B Grylls) – Over raced in the early stages when being restrained.

LILLY THUNDER (M Hashizume) - Improved onto the heels of TIGHTLIGN approaching the winning post which resulted in the mare sustaining a laceration to the off-front leg. Received veterinary treatment following the race.

Race 7 PROFITABLE TRADIE 1400

ROC CHA (R Beemud) – Reared as the start was effected. Raced in restricted room shortly afterwards when RUDYARD shifted out making contact. Raced three wide without cover throughout. Not persevered with over the final 200 metres when out of contention.

RUDYARD (V Colgan) - Shifted out leaving the barriers contacting ROC CHA. Raced keenly in the early stages.

CULLINAN (W Kennedy) - Slow to begin.

ORLEANS BELLE (M Hashizume) – Began awkwardly contacting SUPER LOVE DRAGON shortly after the start. Raced four wide without cover throughout.

SUPER LOVE DRAGON (A Goindasamy) – Bounded as the start was effected then was contacted by ORLEANS BELLE and raced in restricted room shortly afterwards. Held up for clear running for a distance passing the 700 metres.

ODINPOWER (L Satherley) – Shifted out shortly after the start making contact with CINDY FALLS forcing SUPER LOVE DRAGON to race in restricted room. Raced keenly in the early stages. Not persevered with over the final 200 metres when out of contention. When questioned, rider reported that the gelding resented the Norton bit.

CINDY FALLS (J Kamaruddin) - Placed in restricted room near the 400 metres before shifting ground inwards to obtain clear running.

Race 8 LODGE REAL ESTATE MILE 1600

MADAME LE FAY (T Mitchell) - Slow to begin.

LOFTYS GIFT (S Spratt) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

BARI (T Abel) - Rider briefly lost the use of her off-side iron shortly after the start. Raced wide in the early stages before being allowed to stride forward to settle outside the leader near the 1000 metres.

UDERZO (W Kennedy) – Raced wide before striding forward to lead approaching the 1200 metres. Hung outwards throughout and in particular in the final straight despite the efforts of its rider. As a result, BLUE MOON shifted out and away from UDERZO passing the 250 metres which in turn hampered ENCHANTED ELLE with OUTBACK OPAL then shifting outwards making contact with MAOLLA MISS.

BLUE MOON (M Hashizume) – Lay outwards when placed under pressure over the concluding stages.

REGAZZO (A Goindasamy) – Held up for clear running rounding the final bend.

MAOLLA MISS (W Pinn) - Lay in when placed under pressure approaching the 400 metres making contact with OUTBACK OPAL.

OUTBACK OPAL (T Thornton) – Had to be steadied off heels approaching the 400 metres when MAOLLA MISS lay in under pressure.

ZEITAKU (J Allen) - Rider dropped her whip approaching the 100 metres.

ZANTABULOUS (J Kamaruddin) — When questioned regarding the performance rider reported that the filly failed to handle the track conditions and resented the kickback.
