### RACE COMMENTS

#### Race 1 | BIRCHLEIGH POLO CLUB MAIDEN HURDLE 2500m

**JAN'S GIANT** (B Lammas) - Restrained at the start and then hampered when TAHUROA HEIGHT shifted inwards. Jostled with WAIAGARA near the 600 metres.

**WAIAGARA** (D Parker) - Inclined to run down its fences throughout. Near the winning post on the first occasion shifted in and made contact with the running rail, briefly becoming unbalanced. Came together and jostled with JAN'S GIANT for a distance near the 600 metres when attempting a run.

**HARRY HARRISON** (P Matthews) - Hit the second fence in the back straight on the last occasion.

**TAHUROA HEIGHT** (M Roustoby) - Misjudged the second-to-last fence and blundered on landing, losing ground.

**OXYGEN** (S Karnicnik) - Shifted in under pressure over the final stages making contact with the running rail.

**Race 2** | **BEST FORSYTH ELECTRICAL MAIDEN HURDLE 2500m**

**MAYOR OF WEBER** (A Roustoby) - Landed awkwardly jumping the first fence and blundered. Raced keenly when being restrained in the early stages. Retired from the race prior to jumping the first fence in the back straight near the 1300 metres. Rider reported that the gelding had been making abnormal breathing noises and had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

**QUAFF** (M Roustoby) - Retired from the race near the 800 metres when well back and out of contention. Underwent a post-race veterinary examination which did not reveal any abnormality.

**MYSTERY BAR** (B Lammas) - Lay outwards approaching the fence near the 600 metres hampering **RED 'N' SURF** and **SHOCKING PENNY**. Retired from the race prior to jumping the final two fences. Underwent a post-race veterinary examination which did not reveal any abnormality.

**RED 'N' SURF** (D Parker) - Hampered near the 600 metres.

**SHOCKING PENNY** (E Farr) - Hampered near the 600 metres.

**LORD SPENCER** (S Karnicnik) - Misjudged the final fence.

**IAN'S LEGACY** (P Matthews) - Rider dropped her whip near the 100 metres.

**Race 3** | **TE WHANGAI ROMNEYS HAWKE'S BAY HURDLE 3100m (Prestige Jumping Race)**

**THE MIGHTY SPAR** (D Parker) - Hit the fifth fence.

**JAKAMA KRYSTAL** (E Farr) - Hit the fence near the 600 metres and landed awkwardly.

**OBRIGADO** (S Karnicnik) - Misjudged the second-last fence.

**Race 4** | **BETTA ASBESTOS CONSULTANCY HANDICAP 2100m**

**MAUNA LOA** (A Goindasamy) - Raced three-wide without cover throughout.

**DAWN JESSIE** (J Chung) - Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**J Allen** (AOTEA LAD) - Admitted a charge in that she struck her mount 9 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing today, Saturday, 1 July, until the conclusion of racing on Saturday, 8 July, 5 national riding days.

**B Grylls** (SPEED CALL) - Admitted a breach of Rule 636(1)(d) in that she failed to ride her mount out fully to the finish and was beaten for fourth position. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 8 July until the conclusion of racing on Saturday, 22 July, 2 weeks.

**Race 5** | **I SEE RED SYNDICATE MAIDEN STEEPLECHASE 4000m**

**DRUMSTORM** (G Walsh) - Raced keenly in the early stages.

**NO TEARS** (N Downs) - Jumped indifferently in the early stages.

**Race 6** | **AHD – ANIMAL HEALTH HAWKE’S BAY STEEPLECHASE 4800m (Prestige Jumping Race)**

**TITTLTATTLE** (G Walsh) - Slow to begin.

**IZYMYDAAD** (B Lammas) - Put in a poor jump at the first fence in the front straight with a round to go, dislodging its rider. B Lammas was attended to by ambulance personnel and was unable to be removed from the track, with the field being flagged around the last fence. B Lammas was subsequently assessed by ambulance personnel and found to be uninjured.

**DONARDO** (H McNeill) - Retired from the race when well back and out of contention prior to jumping the fence near the 500 metres.

**ZEDMAN** (K Wiles) - Retired from the race after jumping the fence near the 1400 metres. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**SHACKELTONS EDGE** (D Parker) - Put in a poor jump at the fence near the 750 metres.

**Race 7** | **TARADALE CLUB HANDICAP 1200m**

**OLD TOWN ROAD** (J Riddell) - Scratched at 12:30pm on veterinary advice. Connections were advised a veterinary clearance is required prior to OLD TOWN ROAD racing next.

**LINGJUN HERO** (L Sutherland) - Raced keenly in the early stages when being restrained.

**MANRICO** (J Chung) - Raced three-wide without cover throughout.

**Race 8** | **TIMS CONSTRUCTION HANDICAP 1600m**

**MANOLO** (T Taiaroa) - Slow away.

**SHE’S MISS GEVIOUS** (T Mitchell) - Raced four-wide without cover for the majority of the race.

**BADGERINGDAWITNESS** (L Douglas) - Steadied when in restricted room approaching the 800 metres. Held up for some distance near the 500 metres and the early part of the home straight until being angled outwards near the 250 metres.

**LIQUID LES** (C Lindsay) - Had to be steadied when placed in restricted room just prior to the winning post when MANOLO (T Taiaroa) shifted inwards slightly. T Taiaroa was advised to exercise greater care in similar circumstances.

**LINGJUN XIONGFENG** (C Lammas) - When questioned regarding performance rider advised the entire had failed to handle today’s track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 9** | **TEAM WEALLEANS TAURANGA CLASSIC 1400m (Listed Race)**

**PRIORESS** (M Singh) - Steadied from a wide draw to obtain cover early. When questioned regarding performance the rider advised that the mare had failed to handle today’s track conditions.

**ONEROA** (A Goindasamy) - Slow to begin.

**ONE DREAM ONE SOUL** (J Chung) - Raced wide without cover throughout. When questioned regarding performance the rider advised that in his opinion the mare would be better suited to a step-up in distance.

**FLOWER OF WANAKA** (L Sutherland) - When questioned regarding performance the trainer advised that she had been satisfied by the mare's trial performances leading into today, adding that FLOWER OF WANAKA had been suited by the track conditions and the pace of the race.

**Race 10** | **KING OF COMEDY @ NOVARA PARK HANDICAP 1400m**

**BALALAIKA** (C Barnes) - Crowded shortly after the start having to be steadied.

**REINE D'AMOUR** (M Singh) - Crowded shortly after the start having to be steadied. Inconvenienced 150 metres.

**THE FIRST LINK** (K HercocK) - Crowded shortly after the start having to be steadied.

**CARIGNAN** (L Sutherland) - Raced wide throughout. When questioned regarding performance the rider advised that the gelding had settled further back than intended and ran home fairly in the final straight. A post-race veterinary examination did not reveal any abnormality.

**HERO WORSHIP** (T Taiaroa) - Shifted outwards under pressure in the home straight inconveniencing REINE D'AMOUR near the 150 metres. T Taiaroa was shown footage of her ride in the presence of the Apprentice Mentor and advised she is expected to straighten her mount sooner than she did on this occasion.
