RACE COMMENTS

Race 1 HAWKES BAY AUTUMN STAKES MEMBERS DAY 29 APRIL MAIDEN 1600m

MR BULLY TEE (M McNab) - Slow to begin.

GOOD TIME GARRY (A Mudhoo) - Shifted out abruptly shortly after the start tightening outside runners.

TEMPEST (C Grylls) - Tightened shortly after the start.

DON PAULY (S McKay) - Tightened then checked shortly after the start losing ground.

TIME TO WONDER (H McNeill) - Restrained behind runners to obtain cover shortly after the start.

DEEP PURPLE (D Bradley) - Raced three-wide without cover throughout.

GIA MARQUESA (K Asano) - Raced keenly through the early and middle stages. Hampered 350 metres. Returned to the enclosure with blood present in the mouth. Underwent a post-race veterinary examination which revealed a minor laceration to the right side of its mouth.

RACCOURCI (T Newman) - Held up early in the final straight. Steadied when DEEP PURPLE (D Bradley) shifted in near the 200 metres. D Bradley was advised to exercise care.

CHARLIE CHUCKLE (J Riddell) - Held up rounding the final bend and only obtaining clear running near the 350 metres.

J Riddell (CHARLIE CHUCKLE) - Admitted a charge of careless riding in that he permitted CHARLIE CHUCKLE to shift outwards when not sufficiently clear of GIA MARQUESA which was hampered near the 350 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence from the conclusion of racing on Sunday, 23 April, until the conclusion of racing on Friday, 28 April, 4 national riding days.

A Mudhoo (GOOD TIME GARRY) - Was shown footage of his ride in the presence of the Apprentice Mentor and issued with a warning after allowing his mount to shift outwards at the start causing tightening to TEMPEST and DON PAULY, which was checked. A Mudhoo was advised he is expected to straighten his mount sooner than he did on this occasion.

Race 2 THANK YOU RESOURCE FOR YOUR HELP 2YO 1300m

SALTCOATS (K Asano) - Over-raced getting its head up on a number of occasions through the early and middle stages.

RENEGADE REBEL (H McNeill) - Ran wide on the final bend.

Race 3 HES EARTHMOVING HANDICAP 2100m

HANAKIN (T Davies) - Raced three-wide without cover throughout.

TAKE THAT (T Taiaroa) - Slow to begin. Raced wide without cover throughout. Finished well back. When questioned T Taiaroa recommended a tongue tie be applied at its next start.

VIDIANO (K Asano) - Hampered when the pace eased near the 1300 metres. Held up for some distance passing the 400 metres.

VIOLETTA (M McNab) - Hampered when the pace eased near the 1200 metres. Returned to the enclosure with blood present in the nasal area and following a veterinary inspection VIOLETTA was confirmed to have bled from both nostrils. Connections were advised VIOLETTA shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian with a veterinary clearance provided.

FLYING SURF (J Chung) - Held up passing the 400 metres.

JACK THE LASS (S McKay) - Received veterinary treatment at the tie-ups following the race.

B Rogerson (ALL THE RAGE) - Issued with a warning after slowing the pace to a degree which placed runners in behind in difficulty going into the back straight near the 1400 metres. B Rogerson was shown footage of her ride in the presence of the Apprentice Mentor and advised to show better judgment.

Race 4 | **VINTECH POVERTY BAY CUP 2500m**

NEST EGG (M McNab) - Slow to begin.

FLYING MEG (T Taiaroa) - Began awkwardly losing ground.

VERISMO (S McKay) - Slow to begin.

SOUTHROAD (C Grylls) - Held up rounding the home turn and raced in restricted room over the concluding stages.

Race 5 | **VET SERVICES HAWKES BAY HANDICAP 1400m**

MONZA (T Taiaroa) - Fractious in its barrier and as a result was slow away. Hung throughout and ran off rounding the final bend placing the rider at a disadvantage. Underwent a post-race veterinary examination did not reveal any obvious abnormality. Connections were advised MONZA must trial to the satisfaction of Stewards prior to racing next.

KOPUA (J Chung) - Slow to begin.

CANNY MAN (C Grylls) - Hampered shortly after the start losing ground.

FARAGLIONI (A Mudhoo) - Raced three-wide without cover throughout.

SUMI (T Davies) - The saddle shifted forward in the back straight when over-racing placing the rider at a disadvantage for the remainder.

Race 6 | **POWER TURF SPRING HANDICAP 1200m (Listed Race)**

GOSPODIN (J Riddell) - Removed from its barrier after making contact with the front gate, undergoing a veterinary examination and cleared to start.

NOD OF THE HEAD (T Taiaroa) - Crowded shortly after the start when runners either side shifted ground and as a result lost ground. Steadied when improving on to heels rounding the home turn. Held up for some distance between the 150-100 metres.

PIN ME UP (C Grylls) - Slow to begin. Dictated wide rounding the home turn. Disappointed, finishing well back. C Grylls had no excuse. A post-race veterinary examination did not reveal any obvious abnormality. Connections advised the future of PIN ME UP would be reconsidered.

MISS CARTIER (H McNeill) - Began awkwardly losing ground.

PURE INCANTO (K Hercock) - Raced keenly through the early and middle stages.

NOT GUILTY (M McNab) - Raced three-wide without cover throughout.

OLD TOWN ROAD (D Bradley) - Hampered when rounding the home turn.

J Riddell (GOSPODIN) - Issued with a warning after permitting GOSPODIN to shift outwards rounding the home turn, dictating OLD TOWN ROAD outwards, forcing PIN ME UP over extra ground.

Race 7	POWER FARMING HAWKE'S BAY CUP HANDICAP 2200m (Listed Race)

The start of this race was delayed approximately 3 minutes at the request of the TAB due to the delay at Riccarton Park.

FIERCE FLIGHT (M McNab) - Slow to begin. Ducked in abruptly, having to be straightened by its rider approaching the 150 metres.

LINCOLN KING (B Rogerson) - Slow to begin.

THE MIGHTY SPAR (C Grylls) - Jumped away awkwardly losing ground.

WAIKAKE (S McKay) - Restrained behind runners shortly after the start to obtain cover. Checked 600 metres.

SUPER SID (D Bradley) - Raced three-wide without cover before improving to sit outside the leader near the 1100 metres.

HIT THE ROAD JACK (H McNeill) - Rider reported the gelding had hung outwards throughout the running.

H McNeill (HIT THE ROAD JACK) - Admitted a charge of careless riding in that he permitted HIT THE ROAD JACK to shift outwards when not sufficiently clear of WAIKAKE, which was checked approaching the 600 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Wednesday, 3 May, until the conclusion of racing on Sunday, 7 May, 4 national riding days.

Race 8	EAST COAST RURAL SUPPORT TRUST HANDICAP 1400m

SCREAMIN EAGLE (H McNeill) - Began awkwardly crowding HE'S BESET.

HE'S BESET (M McNab) - Crowded shortly after the start losing ground.

LORD VALENTINE (D Bradley) - Slow to begin.

MOZZIE (J Riddell) - From its wide barrier draw was restrained behind runners to obtain cover shortly after the start.

WET 'N' WILD (C Grylls) - Hampered 800 metres.

LIQUID LES (K Hercok) - Checked concluding stages.

GIACOMO (S McKay) - Tightened over the final stages when ROCONONO (K Asano) shifted in.

STRANGE LOVE (T Taiaroa) - Commenced to hang in the run along the back straight and despite the rider's efforts shifted in hampering WET 'N' WILD near the 800 metres. STRANGE LOVE continued to hang throughout the remainder of the race to such an extent the rider T Taiaroa could not ride her mount out fully to the finish. Shifted in near the finish, hampering LIQUID LES, which was checked. Connections were advised a warning is placed against the racing manners of STRANGE LOVE.

K Asano (ROCONONO) - Issued with a warning after permitting ROCONONO to shift in over the final stages tightening GIACOMO. Stewards took into account simultaneous outward movement from SCREAMIN EAGLE which made contact with the hind quarters of ROCONONO when assessing the interference.
