## **GENERAL**

### Race 5 - STAPHANOS AT NOVARA PARK CHAMPAGNE STAKES

**JUST ONE** (M Hashizume) - Due to a technical error the colt was initially given a rating of 47, however this was amended on Thursday 20 April. The correct rating is 45.

TCO2 testing was carried out on all runners in Race 7.

A hair sample was taken from WHITE NOISE in Race 8.

#### **RACE COMMENTS**

#### Race 1 JAMIESON PARK 2100

**CHASE 'N' GOLD** (T Mitchell) - Contacted shortly after the start by MADAME LE FAY losing ground. Raced three wide without cover from the 1400 metres. When questioned regarding the improved performance trainer K Grass reported that the gelding appreciated the heavy track conditions.

**MADAME LE FAY** (M McNab) – Jumped awkwardly making contact with CHASE 'N' GOLD. Raced wide without cover in the early stages before being allowed to stride forward to settle outside the leader near the 1400 metres.

**THATSALLSHEWROTE** (W Kennedy) – Slow to begin. Held up rounding the final bend. When questioned regarding the performance rider reported the mare failed to handle the heavy track conditions.

**ARJAY'S FLIGHT** (C Grylls) – Over-raced in the early stages and made the crossing awkwardly. Raced in restricted room over the concluding stages when runners either side shifted ground slightly.

**WITHALLMYHEART** (J Riddell) - Had to be steadied off heels rounding the first bend just prior to racing over the crossing. Lay out slightly over the concluding stages.

**VERSTAPPEN** (S Spratt) - Raced three wide in the early stages before being allowed to stride forward to settle outside the leader near the 1600 metres. When questioned regarding the performance rider reported that the mare failed to handle the heavy track conditions.

**BURCHA** (M Hashizume) - Lay inwards slightly over the concluding stages.

Following the running of Race 1, the track was downgraded to Heavy 10.

### Race 2 THE WESTBURY CLUB 1200

**STAR TREASURE** (T Moodley) – Began awkwardly losing ground.

MERCURIAL (C Lindsay) - Knuckled shortly after the start.

**JOHNY JOHNY** (J Allen) – Raced wide throughout when leading. Lay out when placed under pressure over the concluding stages.

T & M Carter (JOHNY JOHNY) - Issued with a warning for presenting JOHNY JOHNY late into the parade ring.

# Race 3 BARFOOT & THOMPSON MAIDEN 1400

**RUSTIC** (V Colgan) - Began awkwardly losing ground.

MISAPPROPRIATE (A Lawson-Carroll) – Began awkwardly losing ground.

MISCREANT (C Grylls) – Raced wide without cover throughout. Lost the near front plate during the running.

**FOREVERY YOUNG** (J Kamaruddin) – Raced keenly in the early stages.

**COMPOSURE** (T Thornton) - Raced wide with cover throughout.

**HEY GIRLFRIEND** (M Hashizume) - When questioned regarding the performance rider reported that the mare failed to handle the heavy track conditions.

**KAIMAI QUEEN** (T Mitchell) - Finished a distant last. When questioned regarding the performance rider reported that the mare failed to handle the heavy track conditions.

### Race 4 HAUNUI FARM 1200

CHAMPAGNE LOLA (T Moodley) – Jumped awkwardly making contact with AQUA MAN.

**AQUA MAN** (A Lawson-Carroll) – Contacted by CHAMPAGNE LOLA at the start losing ground. Raced wide without cover throughout.

**DAPPER LAD** (W Kennedy) – Raced keenly in the early stages.

**KINGFISHER** (C Grylls) - Raced keenly near the 800 metres having to be steadied off heels. When questioned regarding the improved performance rider reported that the gelding appreciated the heavy track conditions.

SYMPHONY OF LOVE (W Pinn) - Lay out throughout the final straight.

**LUXURIANT** (O Bosson) - When questioned regarding the performance rider reported that the mare failed to handle the heavy track conditions.

Following the running of this race rider O Bosson advised Stewards he was feeling unwell and was stood down from his remaining ride. O Bosson is to provide a medical clearance prior to riding next.

# Race 5 STAPHANOS AT NOVARA PARK CHAMPAGNE STAKES 1600 (Listed Race)

**ATLANTIC CHARM** (T Newman) - Declared a late scratching at 2.08 pm due to the farrier being unable to attach both hind plates.

**JUST ONE** (M Hashizume) – Shifted out shortly after the start making contact with HE REIGNS. Raced wide without cover throughout.

**HE REIGNS** (J Kamaruddin) - Became unbalanced shortly after the start when contacted by JUST ONE, losing ground.

**TO CATCH A THIEF** (C Grylls) – Briefly held up passing the 700 metres. Lay out when placed under pressure approaching the 200 metres making contact with LOCH KATRINE.

**TAHITINUI** (T Thornton) – Over-raced in the middle stages having to be steadied off the heels of THE PRINCIE ONE approaching the 1000 metres.

**THE PRINCIE ONE** (W Pinn) - Shifted out when placed under pressure in the home straight. When questioned regarding the performance rider reported that the filly failed to handle the heavy track conditions.

**LOCH KATRINE** (M McNab) – Contacted approaching the 200 metres. Lay out when placed under pressure over the final 100 metres.

**THE MATADOR** (W Kennedy) - Lay out when placed under pressure over the final 200 metres.

**DISTINGUISHED** (S Spratt) - When questioned regarding the performance rider reported that the gelding failed to handle the heavy track conditions.

**O Bosson** (THE PRINCIE ONE) - Trainer M Walker advised Stewards at 7.07 am on race morning that rider O Bosson was unable to make the contracted weight on THE PRINCIE ONE being replaced by W Pinn. After considering submissions, O Bosson was fined \$300 by the Adjudicative Committee.

### Race 6 VRC TROPHY 1500

LORD VALENTINE (S Spratt) - Slow to begin.

**SPORTING CHANCE** (C Grylls) – Contacted leaving the barriers. Raced wide without cover throughout.

HASSTOBEYOU (W Kennedy) - Began awkwardly contacting SPORTING CHANCE shortly after the start.

**ROYAL ROC** (S Weatherley) – Began awkwardly contacting the barriers.

**HEART OF GOLD** (T Moodley) - Reared as the start was effected losing ground. Raced in restricted room shortly afterwards being contacted by ASK MUM, becoming unbalanced and losing ground.

**ASK MUM** (W Pinn) - Crowded shortly after the start when SPORTING CHANCE shifted in, losing ground. Shifted outwards to obtain clear running passing the 400 metres.

**DUSTY ROAD** (T Mitchell) – Over-raced in the early stages.

**NEIGHBOURHOOD** (J Kamaruddin) - Raced wide without cover throughout.

### Race 7 TRELAWNEY STUD CHAMPIONSHIP STAKES 2100 (G3)

**KENTUCKY ROSE** (T Newman) – Jumped outwards shortly after the start then over-raced in the early stages when improving forward to settle outside the leader. Lay out when placed under pressure over the final 200 metres.

**ARBY** (S Weatherley) – Slow to begin. When questioned regarding the performance rider reported that the gelding failed to handle the heavy track conditions.

**UNTETHERED** (K Asano) – Began awkwardly crowding HUMBOLDT shortly after the start.

**HUMBOLDT** (J Riddell) – Crowded shortly after the start when UNTETHERED began awkwardly.

JAFFIRA (J Kamaruddin) – Raced wide without cover. Over-raced through the early and middle stages.

SASSYNESS (W Pinn) - Raced wide without cover throughout.

**IMARICHGIRL** (C Grylls) - When questioned regarding the performance rider reported that the filly failed to handle the heavy track conditions.

#### Race 8 MANCO EASTER HANDICAP 1600 (G3)

WHITE NOISE (M McNab) - Began awkwardly shifting out shortly after the start.

**GINO SEVERINI** (J Riddell) - Crowded shortly after the start when WHITE NOISE shifted out.

**THUNDER** (L Satherley) - Slow to begin.

**THE PERFECT PINK** (K Asano) – Shifted in shortly after the start crowding TAVATTACK.

**TAVATTACK** (C Grylls) – Crowded shortly after the start when THE PERFECT PINK shifted in losing ground. Raced wide without cover throughout. Had to be steadied passing the 100 metres when HABANA lay out when placed under pressure.

**HABANA** (W Kennedy) – Over-raced through the early and middle stages. Lay out when placed under pressure passing the 100 metres.

**FASHION SHOOT** (W Pinn) - Raced keenly through the middle stages.

**NO LOITERING** (A Goindasamy) – Lost the off-fore hind plate during the running.

**L O'Sullivan & A Scott** (UDERZO) - Issued with a warning for a late declaration of rider. In taking this course of action Stewards took into account that the gelding was late scratched due to the track downgrade at 1.48 pm.

**W Pinn** (THUNDER) - Admitted a charge in that he broke a riding engagement on THUNDER with W Pinn being fined \$200 under the minor infringement schedule. THUNDER was subsequently ridden by L Satherley.

### Race 9 ELLERSLIE EVENT CENTRE 1600

ON THE RIVET (A Lawson-Carroll) - Slow to begin.

JUJU POP (J Kamaruddin) – Shifted out shortly after the start crowding LOT OF ZEES.

**LOT OF ZEES** (T Abel) – Crowded shortly after the start when JUJU POP shifted out, losing ground.

**CHARRED** (L Satherley) - Began awkwardly.

BLUE SKY AT NIGHT (T Thornton) - Over-raced in the early stages.

KID WARRIOR (C Lindsay) - Over-raced in the early stages. Raced wide without cover throughout.

**PACHECO** (J Riddell) - Shifted ground outwards passing the 400 metres to obtain clear running.

A Lawson-Carroll (ON THE RIVET) - Admitted a charge in that he struck his mount ON THE RIVET seven times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

**J Kamaruddin** (JUJU POP) - Admitted a charge in that he struck his mount JUJU POP six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of J Kamaruddin's licence to ride in races from the conclusion of racing on Saturday 29 April up to and including racing on Wednesday 3 May, 2 national riding days, and in addition imposed a fine of \$500.
