GENERAL

L Douglas advised stewards he was unable to attend the meeting today due to transport difficulties and was replaced on his 2 rides as per schedule above.

Race 7, TOWN CRYER - C Grylls was given permission to ride 1kg over the carded weight.

Trainer R Bergerson issued with a warning under Rule 537(a) for failing to declare riders for his runners in Race 1 (TIVACI PRINCESS) and Race 4 (REIGN IT IN).

RACE COMMENTS

Race 1 | **TUI BACKING A WINNER SINCE 1889 1200m**

CALEDONIE (T Newman) - Hampered at the start losing some ground when inside runners shifted out.

JUDGE KELLIE (K Hercock) - When asked to comment on the performance rider was of the opinion the filly had not handled today's Heavy track conditions.	
Race 2	POWER FARMING MANAWATU LTD 2100m
BLUE ON BLACK (J Chung) - Raced keenly in the early stages.	
MAHOE (C Barnes) - Rider reported that she felt something was amiss with MAHOE so did not persevere with the gelding in the final straight. A post-race veterinary examination did not reveal any obvious abnormalities. Trainer K Gray advised Stewards he would be sending the gelding for a spell.	
Race 3	RUSH EXCAVATION 2100m
MAZZINI (A Goindasamy) - Began awkwardly and was further hampered when crowded shortly after the start, losing ground.	
DIOSA LUNA (R Elliot) - Over-raced for a distance passing the 1600 metres. Under pressure passing the 600 metres finishing well back. When questioned regarding performance, rider could offer no tangible excuse. Trainer C Cole advised Stewards he would be reassessing the racing future of the mare.	
POITIN (K Asano) - Raced wide without cover throughout.	
MATT CAIN (K Hercock) - Lost the near-side hind plate during the running.	
Race 4	THE PAVEMASTERS TROPHY 1200m
REIGN IT IN (M McNab) - Slow to begin.	
POLLY PLUM (C Grylls) - Had to be briefly steadied when crowded for room passing the 950 metres when FIBONACCI was dictated inwards slightly by BLUE VEIN (M Hudson). M Hudson was advised to exercise greater care.	
BLUE VEIN (M Hudson) - Raced three-wide without cover throughout. Inconvenienced 125 metres and 50 metres.	
BRADMAN (W Pinn) - Lay outwards under pressure over the concluding stages and near the 125 metres shifted out inconveniencing BLUE VEIN. Shifted out near the 50 metres, again inconveniencing BLUE VEIN. W Pinn was advised to exercise care and straighten his mount sooner than he did on this occasion.	
Race 5	HR JONES CELEBRATING 75 YEARS MAIDEN 1200m
ZIVJELI (J Kamaruddin) - Slow to begin. Had to be angled across heels near the 150 metres to obtain clear racing room.	
DONNYBROOK (J Riddell) - Taken back from a wide drawn to obtain cover shortly after the start.	
LINKIN PARK (L Satherley) - Over-raced in the early stages and when racing greenly near the 1000 metres shifted out inconveniencing FAUSTIAN BARGAIN prior to being straightened by its rider.	
FAUSTIAN BARGAIN (M Hudson) - Inconvenienced 1000 metres.	
SUCH IS LIFE (T Newman) - Got its head up on a number of occasions when being restrained to obtain cover in the early stages.	
GOHUGO (K Hercock) - Raced below market expectations. Rider could offer no tangible excuse.	
Race 6	P&C INSURANCE BROKERS MAIDEN 1600m

SILVER MUSK (T Taiaroa) - Slow to begin.

MILLY MILLS (C Barnes) - Began awkwardly shifting out making contact with **BOOMTOWN BOY**.

BOOMTOWN BOY (J Riddell) - Contacted at the start.

DASH OF RED (J Chung) - Raced greenly through the early stages.

KANUKA (R Elliot) - Slow to begin. Held up rounding the final bend and when taking a marginal run to the outside of **STORMCAST**, which shifted outwards, made contact with **PERCYTHEPERINCANTO** which was briefly unbalanced near the 350 metres. After interviewing riders and viewing replays Stewards were of the opinion that no rider was at fault and took the matter no further.

PERCYTHEPERINCANTO (A Mudhoo) - Briefly unbalanced 350 metres.

POMALO (K Asano) - Over-raced in the early stages, getting its head up on a number of occasions when being restrained to gain cover.

J Riddell (**BOOMTOWN BOY**) - Stewards inquired into the manner in which J Riddell used his whip in the home straight and could not be conclusively satisfied that he had breached the rules.

Race 7	MANAWATU ITM ANZAC MILE 1600m (Listed Race)

TOWN CRYER (C Grylls) - After initially being slow to begin was taken forward through the early stages to lead.

LLANACORD (L Satherley) - Raced in restricted room, having to steady passing the 900 metres when **SYNCHRONIZE** and **KICK ON** both shifted ground marginally.

SYNCHRONIZE (W Pinn) - Briefly held up passing the 500 metres. When asked to comment on performance, rider was of the opinion the mare had not seen out today's distance in the Heavy track conditions.

KICK ON (R Elliot) - Rider reported the gelding had not handled today's Heavy track conditions.

SEAJETZ (D Prastiyou) - When asked to comment on the performance rider advised the gelding had failed to travel through the running and had been disappointing.

Race 8	FLIPP TRANSPORT 1400m

TEXTBOOK (C Barnes) - Slow to begin.

SAPPORO (C Grylls) - Slow into stride then tailed the field throughout despite the efforts of the rider. Rider reported the gelding displayed an irregular breathing pattern. Underwent a post-race veterinary examination which revealed an increased respiratory noise. Stewards will follow up with connections in coming days.

ZEEFA ZED (K Hercock) - Raced keenly in the early stages.

UNSCRIPTED (W Pinn) - Raced wide without cover throughout.
