RACE COMMENTS

Race 1 NEW ZEALAND EQUINE ACADEMY 3YO 1400m

INCA BELLE (M McNab) - Shifted outwards across the heels of THE RACKETEER near the 1100 metres inconveniencing POUR THE WINE and RUBELLITE. Had to be briefly steadied near the 200 metres when THE RACKETEER lay out.

POUR THE WINE (W Pinn) - Inconvenienced near the 1100 metres.

RUBELLITE (C Lammas) - Inconvenienced near the 1100 metres then being inclined to over race through the middle stages. Finished last. When questioned, rider could offer no explanation.

THE RACKETEER (S Weatherley) - Lay out rounding the final bend and in the straight.

Race 2 WESTBROOK CELLAR DOOR WAIMUKU 1200m

MAGDALA (M Sanson) - Slow away.

TAHUROA HEIGHT (C Lindsay) - Began awkwardly.

SIDE EYE (T Mitchell) - Raced wide in the early stages. Briefly steadied off heels near the 100 metres when runners on either side shifted ground.

DOUBLE TAKE (K Bakker) - Restrained in the early stages to obtain cover after jumping from an outside barrier.

BELLA LUCE (M Hashizume) - Held up early in the final straight.

RAGAMUFFIN (J Kamaruddin) - Lay in when placed under pressure near the 100 metres inconveniencing SIDE EYE.

MOLLYS GAME (A Lawson-Carroll) - Briefly shifted out when placed under pressure near the 100 metres inconveniencing SIDE EYE.

GUNNAR (T Moodley) - Lay out when placed under pressure over the final 100 metres.

Race 3 AVONDALE CLASSIC 1200m

SURF QUEEN (T Thornton) - Hampered leaving the barriers.

BEVANDA (L Satherley) - Jumped away awkwardly hampering SURF QUEEN. Raced three wide without cover.

ORCHESTRAL (M Hashizume) - Slow away.

KHAMASEEN (W Pinn) - Slow away.

MOLLY BLOOM (C Grylls) - Slow away. Inconvenienced near the 75 metres when DANCING DREAM lay out when placed under pressure.

JUST A FLOOZIE (M McNab) - Raced keenly in the early stages.

DANCING DREAM (T Newman) - Lay out when placed under pressure over the final 200 metres. When questioned, rider reported that the filly felt indifferent in its action after the finish. A post-race veterinary examination revealed a minor abrasion to the right hind fetlock.

R Elliot (ORCHESTRAL) - Was unable to make the contracted weight for ORCHESTRAL, being replaced by M Hashizume and fined \$100 under the Minor Infringement Schedule.

Race 4 AVONDALE SUNDAY MARKETS 1400m

PRISMATIC (J Allen) - Jumped away awkwardly.

CAMAROSA (T Newman) - Slow away.

WAIMOKU FALLS (M McNab) - Hampered shortly after the start. When questioned regarding the performance rider reported that the mare got back in the running on a slow tempo and failed to respond when placed under pressure. M McNab added that the mare would be better suited over more ground.

MATAI (C Barnes) - Hampered shortly after the start. Over raced in the early stages on a slow tempo.

GIANT GEM (T Mitchell) - Raced three wide without cover.

LANDRY (K Asano) - Steadied off heels approaching the 600 metres due to the slow tempo.

CINDY FALLS (J Kamaruddin) - Lay out when placed under pressure passing the 100 metres having to be corrected by its rider.

THE FIRST LINK (C Lammas) - When questioned regarding the performance rider reported he was satisfied with the gelding's fresh up effort and expected it would derive benefit from today's race.

Race 5 CONTESSA VANESSA AT ALWYN BLOODSTOCK MAIDEN 1200m

PUKANA (T Moodley) - Contacted leaving the barriers unbalancing its rider. Improved onto the heels of FERNANDEZ near the 200 metres having to shift ground outwards to obtain clear running.

TAWI (T Thornton) - Jumped outwards at the start making contact with PUKANA.

MR MOJO RISIN' (M Hashizume) - Began awkwardly losing ground. Held up rounding the final bend.

SHOWME DA MOOLAH (T Abel) - Slow to begin.

FERNANDEZ (W Pinn) - Raced three wide without cover throughout.

TIMELESS (V Colgan) - Had to be steadied near the 400 metres when MR MOJO RISIN' (M Hashizume) shifted ground outwards when not fully clear. M Hashizume was advised to exercise greater care when racing in similar circumstances.

BOUNTY OF THE SEA (C Barnes) - Lay outwards near the 400 metres briefly inconveniencing OPHELIA.

OPHELIA (K Asano) - Briefly inconvenienced near the 400 metres.

SUPER WRAITH (T Mitchell) - Shifted outwards when placed under pressure over the final 50 metres.

T Moodley (PUKANA) - Issued with a warning after permitting his mount PUKANA to shift outwards when not fully clear of MR MOJO RISIN' which shifted out and away inconveniencing BOUNTY OF THE SEA and OPHELIA near the 300 metres.

T Mitchell (SUPER WRAITH) - Admitted a charge in that she struck her mount SUPER WRAITH 7 times (2 more than permitted under the rules) prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of T Mitchell's licence to ride in races from the conclusion of racing on Saturday 29 April until the conclusion of racing on Sunday 7 May, 6 national riding days. Stewards directed T Mitchell to continue meeting with an NZTR appointed Rider Skills Review panel for remedial training under the provisions of Rule 343 given her poor record in relation to this category of the whip rules.

Race 6 NZB INSURANCE PEARL SERIES F&M MAIDEN 1200m

MY EXPLOSIVE (T Moodley) - Jumped away awkwardly losing ground. Briefly inconvenienced approaching the 100 metres when ANNA TAIT lay out.

PINKYBAR (C Barnes) - Restrained to obtain cover in the early stages after jumping from a wide barrier.

COSMETIC VIRTUE (A Lawson-Carroll) - Restrained to obtain cover in the early stages after jumping from an outside barrier.

JAARFFI (C Grylls) - Raced ungenerously in the early and middle stages. Held up early in the straight and did not obtain clear running until near the 200 metres. Lay out when placed under pressure passing the 50 metres. When questioned regarding the seemingly improved performance, the trainer reported that the filly derived benefit from its debut race and a recent trial.

MIDORIYAMA (C Lindsay) - Raced three wide without cover throughout.

STAR EXPRESS (T Newman) - Raced wide without cover throughout.

ANNA TAIT (L Satherley) - Lay outwards and raced greenly in the final straight when placed under pressure.

MS CANDEE LANE (T Thornton) - Had difficulty obtaining clear running until near the 150 metres.

Race 7QM DEVELOPMENTS LTD MAIDEN 1600mBUBBLE TROUBLE (A Goindasamy) - Slow to begin losing several lengths.

XRATED (R Elliot) - Crowded leaving the barriers having to be steadied losing ground. Held up for a distance passing the 600 metres.

AGERA (M McNab) - Raced wide in the early stages before being allowed to improve forward to lead near the 900 metres.

FOODIE BROTHERS (T Moodley) - Raced keenly in the early stages.

MALDINI (V Colgan) - Over raced in the early and middle stages.

MR MONDELLO (A Lawson-Carroll) - Raced three wide without cover.

POW TONG (C Lammas) - Had to be steadied off heels near the 700 metres. Had some difficulty obtaining clear running early in the final straight.

Race 8 NZB INSURANCE PEARL SERIES MAIDEN 1600m

TRUE NORTH (T Thornton) - Slow away.

REINSTATEMENT (S Weatherley) - Slow away. Held up for clear running rounding the final bend and in the early stages of the final straight.

A MANDARIN (T Moodley) - Jumped away awkwardly losing ground. Raced ungenerously near the 700 metres losing ground. Lay out when placed under pressure over the concluding stages.

SHIMMERING (C Lammas) - Raced three wide without cover.

FEIJOA (L Satherley) - Commenced to give ground from the 600 metres and finished a distant last. When questioned regarding the performance rider could offer no explanation.

ANELA (A Goindasamy) - Commenced to lay outwards rounding the final bend. Continued to lay out in the final straight despite the efforts of its rider, shifting outwards abruptly from the 200 metres. A warning was placed on ANELA's racing manners.
