RACE COMMENTS

Race 1 CAMPBELL INFRASTRUCTURE MAIDEN HIGHWEIGHT 1950

SISTER JANE (S Karnicnik) – Began awkwardly. Raced clear in the lead through the middle stages. When questioned regarding the improved performance trainer reported that the mare appreciated the addition of a tongue tie on today and a step up in distance.

WHISKEY TANGO (K Macnab) – Slow to begin then restrained to the rear of the field. Lay inwards in the early stages of the final straight.

TE ATATU MEMPHIS (E Farr) – Over-raced through the early and middle stages. Made the bend leaving the straight on the first occasion awkwardly.

AFTERALLTHISTIME (D Parker) – Raced three wide without cover until near the 1600 metres.

Race 2 MACMILLAN ACCOUNTANTS HIGHWEIGHT 1950

THE COSSACK (S Phelan) - Slow to begin.

GIN GIN (N Downs) - Began awkwardly making contact with KOOLASCUZ. Over-raced in the early and middle stages. Unplaced favourite. When questioned, rider reported that the mare would be better suited ridden further back in the field.

RUN JAKKO RUN (S Fannin) – Began awkwardly making contact with KOOLASCUZ. Raced three wide without cover from near the 1200 metres. When questioned regarding the performance rider reported that he was disappointed with the gelding's effort and could offer no explanation.

KOOLASCUZ (E Farr) – Raced in restricted room shortly after the start when RUN JAKKO RUN began awkwardly.

MY MAEBELLINE GIRL (K Joyce) – Raced ungenerously shortly after the start when being restrained.

TAKEITEASY (A Roustoby) – Over-raced through the early and middle stages.

DAYDREAM BELIEVER (M Cropp) – Held up rounding the final bend.

CIVIL UNREST (D Parker) - Lay out under pressure rounding the final bend.

M Roustoby (BAK DA MASTER) - Issued with a warning for failing to ride his mount out to the end of the race. Stewards on this occasion were satisfied it had not compromised his finishing position (third place).

Race 3 TW MOORE MAIDEN 3YO 1230

FREDERICK (C Lindsay) – Slow to begin. Went off stride approaching the 150 metres.

ARDEE SEVEN (T Mitchell) - Jumped outwards at the start crowding HAT TRICK. Raced three wide without cover throughout. Inconvenienced approaching the 150 metres.

NISHANE (C Barnes) – Began awkwardly jumping inwards. Over-raced in the early stages.

HAT TRICK (M McNab) – Raced in restricted room shortly after the start when crowded. Over-raced through the early and middle stages. Raced three wide with cover. Unplaced favourite. When questioned, rider reported that he was disappointed with the colt's effort and could offer no explanation.

GHAZZAH (C Lammas) - Raced wide in the early stages. Steadied off heels near the 700 metres. When questioned regarding the performance rider reported he was disappointed with the gelding's effort and could offer no explanation.

DELOREAN (V Colgan) - Held up rounding the final bend. Shifted outwards passing the 200 metres when not fully clear of CHESTER BOY which was inconvenienced. Continued to shift out approaching the 150 metres when not fully

clear of ARDEE SEVEN which was inconvenienced. Rider V Colgan was advised he must exercise greater care when shifting ground.

CHESTER BOY (K Hercock) - Inconvenienced approaching the 200 metres.

Following the running of this race, the track was upgraded to Soft 7.

Race 4 LANCE LAWSON 1400

MARY LOUISE (C Butler) - Dropped the rider during the preliminary and completed a full circuit of the track before being late scratched at 1.56 pm by order of Stewards. C Butler was uninjured. As a result, this race ran approximately 4 minutes late.

EL COOLIO (D Prastiyou) - Began awkwardly. Over-raced through the middle stages.

CORBATIN (C Lammas) - Slow to begin.

CLEESE (S Spratt) - Raced three wide without cover throughout. Lost the off-front plate during the running.

BROOKBOURNE (B Rogerson) – Improved onto heels rounding the final bend, having to be steadied.

BEAU ARCHERS ROSE (C Lindsay) – Raced in restricted room inside the final 50 metres when MANRICO lay in under pressure.

MANRICO (T Newman) - Lay inwards when placed under pressure inside the final 50 metres placing BEAU ARCHERS ROSE in restricted room. Rider T Newman was advised that she must exercise greater care when shifting ground.

S Spratt (CLEESE) - Issued with a warning for failing to ride her mount out to the end of the race. Stewards on this occasion were satisfied it had not compromised her finishing position (fourth place).

Race 5 SWEENEY TOWNSEND INSURANCE BROKERS 1230

VALETTI (M Sanson) – Began awkwardly losing ground. Dictated inwards passing the 800 metres.

SUPER TIME (T Newman) – Knuckled leaving the barriers losing ground. Raced ungenerously through the middle stages when being restrained to take a trail near the 800 metres.

MARTELL (C Lammas) – Bounded as the start was effected losing ground. Checked passing the 800 metres losing ground. Held up for clear running until approaching the 150 metres.

PAUL DAVID (C Grylls) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Unplaced favourite. When questioned, rider reported that the gelding had come to the end of its preparation. Trainer C Cole confirmed that the gelding would now be spelled.

ROC CHA (J Kamaruddin) – Raced three wide without cover throughout.

MERLOTTI (M McNab) - Had to be steadied off heels passing the 800 metres. Held up rounding the final bend and early in the final straight.

ATTRIBUTE (A Lawson-Carroll) - Had to be steadied off heels near the 250 metres when MARTELL shifted ground outwards when not fully clear. Rider C Lammas was advised he must exercise greater care when shifting ground. When assessing this matter, Stewards took into account slight inward movement from MERLOTTI which contributed to the incident.

J Allen (DRAGON BISCUIT) – Issued with a warning in the presence of the Riding Mentor after weighing in 0.6 kgs more than the weight at which she weighed out at.

A Lawson-Carroll (ATTRIBUTE) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not fully clear of VALETTI which in turn was dictated inwards checking MARTELL near the 800 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Wednesday 3 May up to and including racing on Wednesday 10 May, 5 national riding days.

Race 6 NZB INSURANCE PEARL SERIES MAIDEN 1400

CHARDONNAY (K Bakker) – Raced three wide without cover throughout. Commenced to give ground passing the 600 metres. Underwent a post-race veterinary examination which revealed no abnormalities.

MIDNIGHT BELLE (J Kamaruddin) – Began awkwardly losing ground. Dropped its rider passing the finishing line. J Kamaruddin was uninjured. Stewards excused apprentice J Kamaruddin from weighing in pursuant to [Rule 647(1)].

SANTENAY (S McKay) - Slow to begin.

GATO MONTES (B Rogerson) - Over-raced through the early stages.

BARCELONA (V Colgan) - Over-raced through the early and middle stages.

CALL ME BILLIE (K Hercock) - Over-raced through the middle stages.

CHANTARI BAY (T Newman) - Lay out when placed under pressure over the concluding stages and briefly came together with BELLADONNA LILY. When questioned regarding the improved performance trainer reported that the mare had been slow to begin in recent starts and appreciated being able to lead and dictate the tempo today.

C Lammas (MARUSYA) - Issued with a warning for failing to ride his mount out to the end of the race. Stewards on this occasion were satisfied it had not compromised his finishing position (third place).

S Marsh (MIDNIGHT BELLE) - Admitted a charge in that he failed to declare a rider for MIDNIGHT BELLE by the required time being fined \$100 under the minor infringement schedule.

Race 7 HAVE YOUR FUNCTION AT ARAWA PARK 1400

INVINCIBEEL (J Kamaruddin) - Began awkwardly losing ground.

IMAGE OF YOU (M McNab) - Slow to begin.

SOCIAL DISTANCE (S Weatherley) – Began awkwardly losing ground. Held up rounding the final bend then had difficulty obtaining clear racing room throughout the final straight.

STYLISH OFFICER (L Satherley) – Raced keenly through the early and middle stages when leading. Lay out when placed under pressure in the early stages of the final straight briefly inconveniencing WEE RHONA.

ABLE WHITE (W Pinn) – Raced three wide without cover throughout.

HAYATE (J Allen) - Steadied off heels approaching the 800 metres.

WEE RHONA (C Lindsay) - Raced in restricted room early in the final straight. Had difficulty obtaining clear racing room for the remainder of the race.

OPAEA JOE (B Grylls) - Raced in restricted room passing the 100 metres when runners to its outside shifted ground slightly.

Race 8 ARAWA PARK HOTEL ROTORUA MAIDEN 1400

JAZAN (S Weatherley) - Slow to begin.

KHUTULUN KHAN (J Kamaruddin) – Slow to begin. Raced three wide without cover.

DIAMOND JAK (K Hercock) - Raced ungenerously during the running proving to be a difficult ride. Had to be steadied off heels approaching the 1000 metres when over-racing.

MERSEY BEAT (C Barnes) - Over-raced through the early and middle stages. Had to be steadied leaving the 800 metres when the tempo eased.

ONLYWORDS TO TRADE (D Prastiyou) - Improved onto heels passing the 800 metres having to be steadied.

MUSCOVADO (W Pinn) - Not persevered with from the 200 metres when out of contention.

EXCELSIOR (C Grylls) – When questioned regarding the performance rider reported that he was disappointed with the filly's effort and could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities.
