SUPPLEMENTARY

RACE COMMENTS

Race 1 SADDLERY WAREHOUSE MAIDEN 1550

SANDINO'S GIRL (A Goindasamy) - Began awkwardly losing ground. Raced ungenerously near the 1300 metres having to be firmly restrained.

PREFERENTIAL (S Spratt) - Began awkwardly losing ground.

ELUSIVE CAPITAL (T Mitchell) - Over-raced approaching the 1300 metres having to be steadied off heels.

JAMAICA FAREWELL (T Newman) – Raced three wide without cover throughout. Rider T Newman reported that the filly had held its breath during the running.

LANSBURY (C Grylls) – Raced four wide without cover throughout.

Race 2 WAIPA EARTHWORKS 1550

BRECKON POWER (K Hannan) - Slow to begin. Steadied off heels approaching the 600 metres. Held up for a distance rounding the final bend.

CHAMPAGNE LOLA (T Newman) – Restrained to obtain cover in the early stages after jumping from the outside barrier.

FELIX FAURE (J Doyle) – Raced wide without cover in the early and middle stages.

SIDE EYE (T Mitchell) - Raced wide without cover in the early and middle stages.

AFTER PARTY (S Spratt) - Held up for the majority of the final straight.

SHOOTIN TO SAKS (L Satherley) - Had to be steadied when placed in restricted room near the 650 metres to the inside of HAMMER TIME which shifted in slightly away from SIDE EYE. Both N Hailey and T Mitchell were advised to exercise care in similar circumstances. When questioned regarding the performance the rider advised that after receiving interference near the 650 metres, the gelding had failed to respond when placed under pressure. Underwent a post-race endoscopic examination which did not reveal any abnormality.

FARRENC (C Grylls) - When questioned regarding the performance the rider advised that the mare had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 3 HAPPY 50TH BIRTHDAY DEREK COLLETT MAIDEN 1300

CANDYFLIP (M Sanson) - Began awkwardly losing ground.

FAIRYTALE TYME (L Satherley) - Began awkwardly making contact with STAR TRAIL.

STAR TRAIL (A Goindasamy) - Contacted leaving the barriers. Raced wide in the early stages before improving forward to sit outside the leader near the 900 metres.

GEE VEE CRYSTAL (V Colgan) - Began awkwardly then crowded leaving the barriers. Over-raced approaching the 1000 metres having to be steadied off heels.

RIDGEVIEW MANDY (J Fawcett) - Made the bend approaching the 1000 metres awkwardly, shifting outwards.

KENOBI (W Kennedy) - Over-raced near the 1000 metres having to be steadied off heels.

GOOD BROTHERS (E Nicholas) - Raced in restricted room for a short distance entering the final straight.

Race 4 STRATTON FENCING MAIDEN 1300

WISEMEN'S DIVA (J Fawcett) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

OUR MILLY BEE (C Grylls) – Began awkwardly losing ground.

MISTA STITCH (L Satherley) - Slow to begin. Made the bend near the 1100 metres awkwardly, losing ground.

REGAL WARRIOR (C Lindsay) – Raced three wide without cover throughout.

Race 5 GROUP ONE PORTABLE STRUCTURES 1300

ALPHA CHARLIE (W Kennedy) - Began awkwardly losing ground. Lay in when placed under pressure entering the final straight then improved onto heels having to be steadied over the concluding stages. When questioned W Kennedy explained that he had attempted to improve around the field entering the final straight, however the gelding had lay in and shifted ground inwards despite his efforts, so he had elected to ride ALPHA CHARLIE forward after changing his whip to the left hand. ALPHA CHARLIE then ran on when placed under pressure, however improved onto heels over the concluding stages and was reluctant to shift ground outwards. Stewards noted W Kennedy's comments.

UP 'N' GONE (C Grylls) - Slow to begin.

HASSTOBEFAST (M McNab) - Had to be steadied when placed in restricted room between DEAR OH DEAR which shifted out, and MR UNIVERSE which shifted inwards over the concluding stages. Both R Elliot and J Fawcett were advised to exercise care.

WINDSPEED (C Lindsay) – When questioned regarding the performance the rider advised that the mare had failed to respond when placed under pressure.

Race 6 CAMBRIDGE EQUINE HOSPITAL 970

PAPENHUYZEN (R Elliot) - Began awkwardly.

MAGIC TOUCH (D Cooper) - Began awkwardly.

KA YING LUCKY (M McNab) - Began awkwardly. Had to be steadied off heels near the 650 metres then held up for clear running until approaching the 100 metres.

DIGNITOSA (C Grylls) - When questioned regarding the performance the rider advised that the filly had raced wide without cover in the early and middle stages and in his opinion would derive benefit from today's race.

WITH YOU (K Hannan) – Returned to the enclosure with blood present in the right nostril. Underwent a post-race veterinary examination which revealed a minor laceration inside the right nostril.

Race 7 PRYDE'S EASIFEED 2000

MILLENNIUM DAWN (J Doyle) - Slow to begin.

WAIHI WARRIOR (C Grylls) – Jumped outwards at the start crowding TE POROPITI.

TE POROPITI (R Elliot) - Crowded leaving the barriers. Lost contact with the body of the field in the early stages then became tailed off and was not persevered with thereafter. When questioned regarding the performance the rider advised that the gelding had felt indifferent in its action in the early stages and had failed to hit out. Underwent a post-race veterinary examination which did not reveal any abnormality. Co-trainer G Rogerson advised that the gelding would not be persevered with as a racing proposition from their stable. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

BIEDERMEIER (L Satherley) - Raced wide in the early stages before being restrained to obtain cover.

EVE'S SONG (T Mitchell) – Raced keenly in the early stages having to be restrained off heels.

RISING ROAD (W Kennedy) - Raced keenly in the early stages having to be restrained off heels.

VIPER (A Lawson-Carroll) – Raced three wide without cover throughout.

HARMONIA (M McNab) – Raced keenly in the middle stages. Had some difficulty obtaining clear running early in the final straight before improving into restricted room passing the 75 metres then had to be steadied over the concluding stages after improving onto heels.

Race 8 NEMS MEDICAL MAIDEN 2000

LADY ROSETTI (K Hannan) - Refused to jump out of the barriers when the start was effected losing all chance and was retired from the race. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

SO THE FOX (J Doyle) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

TEMPEST KHAN (D Cooper) – Over-raced in the early stages when leading. Stewards questioned the riding tactics adopted in the early and middle stages when racing keenly in the lead. D Cooper, assisted by riding mentor N Harris, explained that his mount had over-raced when being steadied in the early stages and had continued to do so when being challenged for the lead through the middle stages. Stewards noted D Cooper's explanation and advised that he would be expected to show better judgement in the future.

KAWATIRI (M McNab) - Improved onto heels passing the 1300 metres having to be steadied.

PRIZE PRINCE (L Satherley) – Raced wide without cover throughout.

UHTRED (C Barnes) - Improved onto heels passing the 1300 metres having to be steadied. Forced wider rounding the final bend.

RARE COMPANY (R Elliot) - Forced wider rounding the final bend. Checked near the 100 metres.

MR PHOTOGENIC (C Grylls) - Forced wider rounding the final bend.

NORTHERN RAIDER (N Hailey) – Hung out rounding the bend forcing UHTRED, MR PHOTOGENIC and RARE COMPANY wider then shifted outwards in the final straight, when placed under pressure, into the line of RARE COMPANY which had to be checked to avoid heels near the 100 metres. Connections were advised that the gelding would be required to barrier trial left-handed to the satisfaction of Stewards prior to racing next. Stewards questioned the riding tactics adopted in the early and middle stages when racing keenly outside the lead. N Hailey, assisted by riding mentor N Harris, advised that his mount had over-raced when racing outside the leader and when he had attempted to improve forward, the leader had improved forward inside him. Stewards noted N Hailey's explanation and advised that he would be expected to show better judgement in the future.

TIMBA (S Spratt) - When questioned regarding the performance the rider could offer no excuse.

THATSAWRAP (B Rogerson) - When questioned the rider advised that the gelding had felt lame in the right foreleg over the concluding stages, so she did not persevere. Underwent a post-race veterinary examination which revealed a suspected tendon injury to the right foreleg and minor lacerations on the gelding's fetlocks. Connections were advised that a veterinary clearance would be required prior to racing next.

D Cooper (TEMPEST KHAN) - Issued with a warning for the manner in which he eased the pace passing the 1300 metres dropping back onto KAWATIRI which had to be steadied.

N Hailey (NORTHERN RAIDER) - Issued with a warning for the manner in which he eased the pace passing the 1300 metres dropping back onto UHTRED which had to be steadied.

N Hailey (NORTHERN RAIDER) - Admitted a charge of careless riding in that he permitted his mount to shift out when not sufficiently clear of RARE COMPANY which had to be checked near the 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of N Hailey's licence to ride in races from the conclusion of racing on Saturday 22 July up to and including racing on Friday 28 July, 4 national riding days.
