Race 9 - HAVE YOUR FUNCTION AT ARAWA PARK 1560

GALLIVANTER (T Newman) – Trainer S Cole advised Stewards that the mare has had a freshen up and been seen by a chiropractor. They are happy with how she is progressing and will continue with her preparation, racing again next Saturday.

Race 10 - NZB INSURANCE PEARL SERIES MAIDEN 1230

ANNA TAIT (L Satherley) – Trainer J Morell advised Stewards that the mare pulled up fine and that he believes she did not handle the days track conditions. She has been sent for a freshen up and will be back in work in a month's time.

RACE COMMENTS**Race 1 RUAKAKA RACES 5 AUGUST MID WINTER XMAS MAIDEN 1600**

GINTYS STAR (J Fawcett) - Contacted by MATAI BAY shortly after the start, knuckling and becoming unbalanced, losing ground.

MATAI BAY (W Kennedy) – Began awkwardly jumping inwards contacting GINTYS STAR. Lay in when placed under pressure in the final straight.

KEREOPA (M Cropp) – Raced keenly in the early stages when sitting outside the leader.

Race 2 ITM/GIB PROGRESSIVE WINTER CHAMPIONSHIP FINAL 1600

MANDALO (T Newman) - Slow to begin.

MISTER PUCCI (J Fawcett) – Restrained from its wide barrier to obtain cover. Raced four wide without cover form near the 700 metres.

CANULOVEMEAGAIN (L Satherley) - Over-raced in the early stages.

URBAN MYTH (R Elliot) – Raced three wide without cover throughout.

GOOD DAY (J Doyle) – Over-raced in the middle stages.

SILK 'N' DALE (S Spratt) – Raced keenly in the middle stages. Had some difficulty obtaining clear running early in the final straight.

Race 3 CROFT POLES 1200

NEW YORK JAZZ (N Hailey) - Restrained from its wide barrier to obtain cover. Over-raced in the middle stages.

NARINCE (T Newman) - Restrained from its wide barrier to obtain cover.

COVENANT (E Nicholas) - Began awkwardly losing ground then over-raced in the early and middle stages. Raced three wide without cover from near the 800 metres.

DANCARINA (M McNab) – Over-raced in the early and middle stages when sitting outside the leader. Lay in when placed under pressure in the home straight.

MANRICO (J Fawcett) - Over-raced in the middle stages.

Following the running of this race W Kennedy advised Stewards that he was feeling unwell being attended to by St John Ambulance personnel and stood down from his remaining rides. W Kennedy is to provide a medical clearance prior to riding next.

Race 4 ITM/GIB 2YO WINTER CHAMPIONSHIP FINAL 1200

WHISKEY N' RYE (A Goindasamy) – Slow to begin then crowded shortly after.

DANCING DREAM (K Hannan) – Over-raced in the early and middle stages when sitting outside the leader.

ORGULLO (M McNab) – Over-raced in the early and middle stages.

TIDE AND TIME (A Lawson-Carroll) – Had to be steadied approaching the 800 metres when improving onto the heels of ORGULLO.

ATLANTIC CHARM (J Doyle) - Improved into restricted room to the inside of TIDE AND TIME which shifted inwards slightly passing the 800 metres having to be firmly restrained. A Lawson-Carroll was advised to exercise care in similar circumstances.

Race 5

ITM/GIB WHANGAREI GOLD CUP STAYERS' FINAL 2100

TYNESIDER (M Sanson) – Bounded in the air as the start was effected, losing ground.

HIT THE ROAD JACK (E Nicholas) - Restrained shortly after the start to obtain cover. Raced keenly in the early to middle stages. Improved onto heels over the concluding stages having to be steadied.

NEW ARRANGEMENT (C Barnes) – Raced keenly in the early and middle stages.

ENCHANTED ELLE (K Hannan) – Raced four wide without cover until near the 1500 metres.

CURRENT SURGE (T Mitchell) – Raced three wide without cover from the 900 metres. Improved onto heels over the concluding stages having to be steadied.

CRUISEY LASS (T Newman) - Held up in the early stages of the final straight.

ONEZEDBEE (L Satherley) - Had difficulty obtaining clear running for the majority of the final straight.

BRIAN LAMONT (J Allen) – Held up for clear running until approaching the 150 metres.

PACHECO (J Doyle) - Raced in restricted room over the concluding stages.

Race 6

HAPPY 70TH MURRAY 1200

KELLY OSBORNE (L Satherley) – Began awkwardly losing ground. Over-raced in the early stages. Lost contact with the body of the field leaving the 800 metres and was eased out of the race. Connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

SPECIAL PRIVILEGE (J Doyle) - Crowded shortly after the start losing ground.

NO AGENDA NIGEL (N Hailey) – Raced wide without cover throughout. Rider dropped his whip near the 600 metres.

SYMPHONY OF LOVE (J Fawcett) – Over-raced in the middle stages.

HAYLEY (E Nicholas) – Raced three wide without cover throughout.

NO TIME TO JAZZ (M Sanson) - Improved onto heels approaching the 200 metres having to shift ground inwards to improve.

SLIPPER ISLAND (M McNab) - When questioned regarding the performance the rider advised that the colt had travelled comfortably throughout and sprinted well early in the final straight, however came to the end of its run near the 150 metres and in his opinion would derive benefit from today's race.

<p>MIGHTY BRIGHT (M McNab) – Slow to begin. When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p>HEART OF ALLADIN (J Fawcett) - Over-raced in the middle stages when the tempo came out of the race.</p> <p>PIPPY (T Newman) - Over-raced in the middle stages when the tempo came out of the race.</p> <p>DELOREAN (T Mitchell) – Raced three wide without cover throughout. When questioned regarding the improved performance the trainer advised that the step up in distance and racing right-handed had benefitted the filly.</p> <p>T Mitchell (DELOREAN) - Admitted a charge in that she struck her mount seven times prior to the 100 metres. After considering submissions the Adjudicator imposed a suspension of T Mitchell’s licence to ride in races from the conclusion of racing on Sunday 23 July up to and including racing on Wednesday 2 August, 5 national riding days.</p>

Raced three wide without cover from near the 700 metres.</p> <p>DIAMOND GIRL (T Newman) - Began awkwardly losing ground.</p> <p>CAKEBYTHEOCEAN (T Mitchell) – Over-raced in the early to middle stages when sitting outside the leader.</p> <p>FOLLOW YOUR DREAMS (A Lawson-Carroll) - Over-raced in the middle stages. Attempted a marginal run to the inside of ORANGE PEARL passing the 150 metres before having to be steadied and shift ground outwards to improve.</p> <p>RUBYSHOWOFF (E Nicholas) – Raced three wide without cover throughout.</p> <p>TU MEKE POTAE (J Fawcett) - Briefly held up entering the final straight.</p>
