Apprentice T Davies did not attend the meeting after a race fall at Otaki yesterday and was replaced as above.

#### **RACE COMMENTS**

#### Race 1 NORM BEVAN MEMORIAL MAIDEN STEEPLECHASE 4000m

**DRUMSTORM** (G Walsh) - Badly misjudged the start fence on the second occasion and fell. Rider G Walsh was uninjured. DRUMSTORM underwent a post-race veterinary inspection which did not reveal any abnormality.

**JAN'S GIANT** (D Parker) - Raced keenly in the middle stages. Misjudged the final fence then being further inconvenienced on landing. Required post-race veterinary attention after pulling up 4/5 lame in the right foreleg. Connections were advised that a veterinary clearance is required prior to JAN'S GIANT racing next.

MONITOR (S Karnicnik) - Crowded jumping the fence near the 1200 metres and blundered on landing.

PASSWORD (J Power) - Ran down the final fence, inconveniencing JAN'S GIANT.

**NO TEARS** (K Wiles) - Jumped indifferently in the early stages and tailed the field throughout before being retired from the race prior to the fence near the 800 metres. Following the race, a veterinary examination confirmed NO TEARS to have bled from both nostrils. Connections were advised NO TEARS shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1,000 metres in the presence of a Veterinarian with a veterinary clearance provided.

J Power (PASSWORD) - Issued with a warning after making a celebratory gesture prior to the winning post.

### Race 2 WELCOME WELLINGTON BOWLERS MAIDEN HURDLE 2500m

INVISIBLE SPIRIT (S Mynott) - Misjudged the third fence.

**RED 'N' SURF** (D Parker) - Badly misjudged the fence passing the 1200 metres, losing ground. Retired from the race after jumping the fence near the 1000 metres with the rider reporting he felt there may be something amiss with the gelding. Underwent a post-race veterinary examination which did not reveal any abnormality.

**FABULOUS NANCY** (E Farr) - Put in a poor jump at the fence passing the 1200 metres. Retired from the race prior to the final fence. Underwent a post-race veterinary examination which did not reveal any abnormality.

**BLACKCOMB** (K Wiles) - Put in a poor jump at the fence near the 700 metres. Retired from the race prior to the second-last fence.

**KENTUCKY BOY** (P Matthews) - When questioned regarding performance rider advised that the gelding had not felt entirely comfortable in today's track conditions.

**METALLO** (J Power) - Lost the left front plate during the running.

## Race 3 CODY SINGER MEMORIAL MAIDEN HURDLE 2500m

WAIAGARA (D Parker) - Crowded shortly after leaving the barriers.

LORD SPENCER (S Karnicnik) - Put in a poor jump at the first fence. Hit the final fence.

**OCEANS AWAY** (G Walsh) - Retired from the race prior to the third-last fence.

**DUCK ROAD** (H McNeill) - Misjudged the second-last fence and blundered badly on landing, almost dislodging its rider. Underwent a post-race veterinary examination due to having blood present in the left nostril, which was found to be due to external trauma.

**HARRY HARRISON** (E Farr) - Retired from the race prior to the third-last fence. When questioned regarding performance rider advised the gelding had found today's track conditions too testing. Underwent a post-race veterinary inspection which did not reveal any abnormality other than the gelding had lost the right front plate.

IAN'S LEGACY (P Matthews) - Lost the right front plate during the running.

# Race 4 HYDRA-CELL PUMPS LTD WELLINGTON HURDLE 3400m (Prestige Jumping Race)

**ODYSSEUS** (N Downs) - Inclined to over-race in the early to middle stages having to be firmly restrained going into the first turn when placed in restricted room to the inside of NEDWIN (J Power). ODYSSEUS was then inclined to get its head up for a distance when being steadied. Hit the fence near the 1400 metres. Hampered by the fallen runner after jumping the third-last fence.

**BERRY THE CASH** (P Matthews) - Badly misjudged the third-last fence and fell. Rider P Matthews was examined by St John personnel and found to be uninjured. A post-race veterinary examination revealed a minor laceration to the right fore cannon area.

**NEDWIN** (J Power) - Had a tendency to run down its fences. Badly misjudged the fence near the 1000 metres and fell, hampering SULIMAN, DES DE JEU and CARNABY. Rider J Power was uninjured. NEDWIN received post-race veterinary treatment for general soreness. Connections were advised that veterinary clearance would be required prior to NEDWIN racing next.

SULIMAN (H McNeill) - Unbalanced when contacted by the fallen NEDWIN near the 1000 metres.

**DES DE JEU** (E Farr) - Hampered by the fallen runner near the 1000 metres.

**CARNABY** (D Parker) - Hampered by the fallen runner near the 1000 metres. Lost the right front plate during the running.

**J Power** (NEDWIN) - Issued with a warning after permitting his mount to shift inwards going into the first turn when not fully clear, placing ODYSSEUS in restricted room.

**D** Parker (CARNABY) - Admitted a charge in that he used his whip excessively prior to the 100 metres. After hearing submissions, the Adjudicative Committee suspended D Parker's licence to ride in races from the conclusion of racing today, Saturday 15 July until the conclusion of racing on Saturday 29 July, 1 national jumps riding day, and in addition imposed a fine of \$700.

Race 5 SUPER STAR SEA KING DUKE OF GLOUCESTER CUP 2100m (Amateur Riders)

**TAVI WITH ME** (N Smith) - Crowded leaving the barriers.

**TRAMORE** (A Scott) - Steadied to obtain cover after jumping from the outside barrier.

HEY HEY HEY (M Davies) - Slow away.

OVERAGAIN (E Taiaroa) - Lost the right front plate during the running.

# Race 6 MARSH INSURANCE HANDICAP 1100m

**ALJAY** (L Sutherland) - Crowded shortly after the start. When questioned regarding performance rider advised that the gelding had found today's track conditions too holding and is better suited over more ground.

**LOVE STORM** (C Butler) - Rider advised that the mare had not felt entirely comfortable in today's track conditions and was also stepping in class.

SANIBEL (K Hercock) - Inclined to lay inwards under pressure in the final straight.

# Race 7 GRANT PLUMBING WELLINGTON STEEPLECHASE 5500m (Prestige Jumping Race) TITTLETATTLE (G Walsh) - Slow away.

**ARGYLL** (E Farr) - Fell at the fence near the 700 metres, severely hampering THE COSSACK and to a lesser degree WEST COAST. Rider E Farr was uninjured. ARGYLL was immediately attended to by the on-course veterinarian and found to be deceased from a suspected heart aneurysm.

**THE COSSACK** (J Power) - Put in a poor jump at the second of the double near the 1200 metres on the first occasion. Severely hampered by fallen runner 700 metres.

WEST COAST (S Fannin) - Hampered by fallen runner 700 metres.

**S Fannin** (WEST COAST) - Admitted a charge in that he used his whip in an action which raised his arm above shoulder height. After viewing footage and hearing submissions the Adjudicative Committee imposed a fine of \$1,700.

**S Fannin** (WEST COAST) - Admitted a charge in that he made a celebratory gesture prior to the winning post with the Adjudicative Committee imposing a fine of \$300.

#### Race 8

# NOVARA PARK WHYTE HANDICAP 1600m

**CARPE DIEM** (J Chung) - Lay outwards under pressure in the straight inconveniencing KAHU ROCK near the 350 metres. J Chung was advised to exercise care. CARPE DIEM continued to lay outwards and when correcting his mount Apprentice Chung dropped his right rein near the 200 metres, having to re-gather.

KAHU ROCK (B Rogerson) - Inconvenienced 350 metres.

**DIVINE SPIRIT** (C Lindsay) - When questioned regarding performance rider advised that the mare had travelled comfortably enough but had been quickly beaten when placed under pressure and had felt indifferent in its action on pulling up. A post-race veterinary examination did not reveal any abnormality.

**ROAD DIVA** (D Bradley) - When questioned regarding performance rider advised that the mare was stepping up in grade today and in his opinion had failed to back up from racing the previous Saturday.

# Race 9 NATURAL LIVING HOMES ASBESTOS REMOVAL 1400m

**SHE'S MISS GEVIOUS** (L Sutherland) - Raced keenly in the early stages.

**BALALAIKA** (T Taiaroa) - Tailed the field throughout, finishing a distant last. When questioned regarding performance rider advised that the mare had failed to handle today's testing track conditions. A post-race veterinary examination did not reveal any abnormality.

# Race 10 DICK HUNT "THE JUDGE" HAPPY RETIREMENT 1400m

**STALLONE** (C Lindsay) - Slow away. Raced wide throughout.

**ZOE SATIN** (K Hercock) - When questioned regarding performance rider advised that the mare had travelled well but floundered when placed under pressure in today's testing track conditions.
