Race 6 - CAMBRIDGE EQUINE HOSPITAL 1400

R Patterson (THE FEARLESS ONE) - Admitted a charge under [Rule 616(2)] in that he presented THE FEARLESS ONE to race with a tongue tie that was not notified being fined \$50 under the minor infringement schedule.

RACE COMMENTS

Race 1 HARCOURTS HAMILTON RENTALS HURDLE 2800

HERE'S JOHNNY (S Karnicnik) - Slow to begin. Jumped indifferently throughout.

AQUILO (M Roustoby) - Slow to begin. Lost the left front plate during the running.

TWEEDLEDEE (P Matthews) – Raced ungenerously in the early stages when being restrained.

ENGLISH GAMBLER (D Parker) – Ran down its fences through the middle stages when clear in the lead.

P Matthews (TWEEDLEDEE) - Issued with a warning for making a celebratory gesture prior to the winning post with Stewards taking into account her clear recent record with regards to a breach of this rule.

S Karnicnik (HERE'S JOHNNY) - Admitted a charge in that he failed to retire his mount from the race when the horse was out of contention. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 2 IRWIN'S TRUCK & BUS SALES MAIDEN 1400

MY EXPLOSIVE (T Moodley) - Slow to begin. Over-raced approaching the 1000 metres having to be steadied off heels.

COSMETIC VIRTUE (S Spratt) – Raced three wide without cover throughout.

HE'S CLASSIC (K Bakker) - Began awkwardly.

FARAG (A Goindasamy) – Restrained to obtain cover in the early stages after jumping from the outside barrier. Held up rounding the final bend.

SHEZ CLASS (O Bosson) – Raced wide in the early stages before improving forward to sit outside the leader passing the 800 metres.

MISCREANT (C Grylls) - Over-raced in the middle stages having to be steadied off heels. Returned to the enclosure with blood present in both nostrils. Trainer reported that MISCREANT was confirmed to have bled. MISCREANT shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a veterinarian.

HAMMER TIME (J Allen) – Lay out rounding the final bend having to be corrected by its rider.

WHATANIGHT (W Kennedy) - Improved onto heels over the concluding stages having to be steadied.

B Wallace & G Cooksley (HE'S CLASSIC) - Issued with a warning after presenting HE'S CLASSIC to race in plates which were excessively worn.

Race 3 KEN & ROGER BROWNE MEMORIAL STEEPLECHASE 3900

THE COSSACK (D Parker) - Slow to begin. Inconvenienced leaving the front straight when SUFFICE TO SAY lay out.

LEICA WARRIOR (E Farr) - Over-raced in the early stages.

SUFFICE TO SAY (S Karnicnik) - Made the bend awkwardly leaving the front straight inconveniencing THE COSSACK.

DAL KILCHOAN (P Matthews) - Lay out under pressure over the concluding stages.

Race 4 ADRIAN & ASSOCIATES INSURANCE 1400

MR UNIVERSE (R Elliot) - Began awkwardly losing ground. Lay in when placed under pressure over the concluding stages.

MONTANA MIST (B Rogerson) - Began awkwardly losing ground.

MARY LOUISE (C Butler) - Raced three wide without cover throughout.

ZEITAKU (J Allen) – Raced in restricted room passing the 100 metres.

Race 5 SHAW'S WIRE ROPES SPRINT 1200

LA BELLA BEALS (W Kennedy) - Began awkwardly losing ground.

STAR TREASURE (S Spratt) - Began awkwardly. When questioned regarding the performance the rider advised that the gelding had been unsuited by today's track conditions.

MERCURIAL (C Grylls) – Raced wide without cover throughout. Lay in when placed under pressure near the 350 metres having to be corrected by its rider.

GOSPODIN (J Riddell) - Had to be steadied near the 300 metres when CRYSTALLIZE shifted outwards when not fully clear. T Moodley was advised to exercise care in similar circumstances.

Race 6 WAIKATO EQUINE VETERINARY CENTRE 2YO 1200 (Listed Race)

TOWER FLYPASS (C Grylls) - Began awkwardly.

MADAM PENNINO (A Goindasamy) - Crowded leaving the barriers. Over-raced in the early stages having to be steadied off heels.

SOLIDIFY (R Elliot) – Slow to begin. Over-raced in the early stages having to be steadied off heels.

GLAMOUR TYCOON (M McNab) – Raced wide without cover throughout.

VIVA VIENNA (W Kennedy) – When questioned regarding the performance the rider advised that the filly failed to handle today's track conditions.

Race 7 CAMBRIDGE STUD 1200

FLIP 'N' EASY (C Grylls) – Knuckled on jumping away.

INDEEM (M Sanson) - Slow to begin.

POUR THE WINE (W Kennedy) - Began awkwardly. When questioned regarding the performance the rider advised that the filly failed to handle today's track conditions.

NAVALHA (J Allen) - Slow to begin.

FREEZE FRAME (O Bosson) – Restrained to obtain cover in the early stages after jumping from the outside barrier. Lay inwards when placed under pressure near the 200 metres.

DAPPER LAD (J Riddell) – Raced keenly in the early stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

DRUM MAJOR (B Rogerson) – Raced wide without cover throughout.

ROC CHA (K Asano) – Lay in when placed under pressure near the 200 metres.

J Riddell (DAPPER LAD) - Issued with a warning after weighing in 0.7 kgs over the weight at which he weighed out at.

Race 8 BETAVET MILE 1600

OSAKA (W Kennedy) - Began awkwardly losing ground.

SENOR UNO (K Asano) - Raced keenly in the early stages. Lay out when placed under pressure passing the 100 metres having to be corrected by its rider.

GEE CEE (S Spratt) – Raced wide without cover throughout.

ENCIERRO (M McNab) - When questioned regarding the performance the rider advised that the gelding failed to handle today's track conditions.

LADY KOVAL (C Grylls) - Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 9 SILVERTON ALEXANDER VALUERS MILE 1600

DESERT MYSTIC (W Kennedy) - Began awkwardly losing ground. Had some difficulty obtaining clear running early in the final straight.

SUPER LOVE DRAGON (J Kamaruddin) - Began awkwardly.

QUEEN SARABI (K Asano) - Slow to begin.

PRISMATIC (O Bosson) - Began awkwardly.

SHOCKING PENNY (B Grylls) – Raced keenly in the early stages.

BOURBON CHIQUE (C Grylls) – Had to be steadied off heels passing the 1200 metres.

SOCIAL DISTANCE (S Weatherley) – Had to be steadied off heels passing the 1200 metres when racing keenly.

MUSE (S Spratt) - Raced keenly in the middle stages.

DIGGER (D Prastiyou) - Steadied when placed in restricted room to the inside of BILLY BUNTER which shifted abruptly in and away from DONTTELLTIMMY passing the 200 metres.

BILLY BUNTER (V Colgan) – Shifted inwards abruptly away from DONTTELLTIMMY passing the 200 metres having to be corrected by its rider. Steadied when placed in restricted room near the 50 metres.
