GENERAL

B Murray - Admitted a charge of misconduct in that he misconducted himself using inappropriate language in the weighing area when weighing in following Race 5.

B Murray - Admitted a further charge of misconduct in that he misconducted himself in the Jockeys Room when confronting a fellow rider following the running of Race 5.

After hearing all relevant evidence and submissions the Adjudicative Committee reserved their decisions on penalty relating to both charges.

Race 4 - TIMARU TOWN & COUNTRY CLUB DASH 1200m

LADYSWEY (T Moseley) – Trainer Mr M Jones advised Stewards that upon return to the stable LADYSWEY presented with a cough and was placed on a 3-day course of antibiotics. M Jones further advised it is his intention to continue with the mare's current preparation and he has also reapplied the blinkers for LADYSWEY'S next race day start.

Race 6 - MCINTOSH CATERING MILE MAIDEN 1600m

AEQUALIS (T Comignaghi) – Co-trainer Ms K Murphy reported to Stewards that AEQUALIS underwent a veterinary examination which included blood tests on Friday 28 April which revealed no abnormalities. K Murphy further advised it is the stable's intention to carry on with AEQUALIS's current preparation.

Race 8 - IN MEMORY OF OTHE ANZAC WAR HORSES HANDICAP 1600m

SHARPDRESTMAN (L Douglas) – Trainer Ms M Cunneen advised Stewards that SHARPDRESTMAN will undergo a veterinary examination early next week which will include an endoscopic examination. Stewards will do a further follow up with M Cunneen after the completion of the examination. M Cunneen further advised that after the veterinary examination the gelding will be sent for a spell and will no longer be considered as a racing proposition from her stable.

RACE COMMENTS

Race 1 RICCARTON PARK FUNCTION CENTRE GREAT AUTUMN HCP 2600m

MISS TAVI (K Williams) - When adjusting her gear prior to the start, rider K Williams became aware that a towel with which she had weighed out had not been placed on the mare. MISS TAVI returned to the enclosure having to be resaddled after K Williams had reweighed, resulting in a delay to the start of approximately 3 minutes.

PRINCE ALBY (K Mudhoo) - Began awkwardly then was further hampered losing ground. Lay inwards under pressure in the straight.

MADISON ROSE (T Moseley) - Slow to begin.

DUNHILL (L Douglas) - Was dismounted by its rider after pulling up following the race, being immediately attended to by the on-course veterinarian with the horse ambulance deployed. DUNHILL was found to have suffered a tendon injury to the left foreleg, with a veterinary certificate of fitness now required prior to racing again. In the circumstances rider L Douglas was exempted from weighing in.

L Prendergast (MISS TAVI) - Admitted a charge of neglect in saddling in that she omitted a towel when saddling and was fined \$150 under the Minor Infringement Schedule.

Race 2 MID WINTER CHRISTMAS – 24 JUNE 1800m

RED SUNDAY (C Barnes) - Slow to begin. Underwent a post-race veterinary examination after the rider reported the gelding had felt indifferent in its action trotting back to the enclosure following the race, which did not reveal any obvious abnormality.

CLASSIC DIVA (K Williams) - Began awkwardly hampering TAIMATE DIVA.

TAIMATE DIVA (K Chowdhoory) - Hampered at the start losing ground then over raced through the early stages.

VAGUE (G Jogoo) - Crowded shortly after the start losing ground when runners to either side shifted ground. Raced keenly through the early and middle stages. Lay inwards under pressure in the straight.

TOP GUY (T Newman) - Restrained behind runners to obtain cover shortly after the start.

ESTABLISHMENT (K Mudhoo) - From a wide draw was restrained behind runners to obtain cover shortly after the start.

T Moseley (COLOSSAL) - Admitted a charge in that he failed to ride his mount out to the end of the race when there was a reasonable chance of finishing in a higher placing (5th). After considering submissions the Adjudicative Committee imposed a fine of \$300.

Race 3 ANGUS MEATS 2000m

PROSERVE (W Pinn) - Slow to begin. Briefly held up near the 350 metres before shifting inwards across the heels of FLOAT to obtain clear running. Was inclined to shift ground under pressure in the straight.

GABBY DIAZ (C Campbell) - Began awkwardly losing ground.

PACKING TAVI (T Jonker) - Slow to begin. Inconvenienced near the 450 metres when MISS ONAKI (T Moseley) shifted outwards to obtain clear running. T Moseley was advised to exercise greater care.

UGO (K Chowdhoory) - Over raced when being restrained in the early to middle stages.

DEMAND RESPECT (L Sutherland) - Held up early in the straight then having to be further restrained near the 300 metres when ROYAL KHAN shifted inwards away from PROSERVE which had improved quickly to its inside.

BAILADOR (K Mudhoo) - Steadied when placed in restricted room near the 200 metres.

Race 4 DAVID EMERSON ACCOUNTANT & BUSINESS CONSULTANT 1200m

CHARBANO (W Pinn) - Slow to begin. Held up early in the straight. Shifted inwards abruptly after being struck with the whip near the 100 metres, making contact with SECRETXPRESS.

BLUE VEIN (M Hudson) - Blundered shortly after the start.

LADYSWEY (T Moseley) - Came together with TOWN BELT at the start.

TOWN BELT – Came together with LADYSWEY at the start.

LIPA MALA (L Douglas) - Jumped away awkwardly then being restrained to obtain cover shortly after the start.

SECRETXPRESS (T Newman) - Hampered and unbalanced when contacted near the 100 metres.

L Sutherland (WHERE'S WALLY) - Admitted a charge in that she struck her mount WHERE'S WALLY six times (one more than permitted) prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of L Sutherland's licence to ride in races from the conclusion of racing on Saturday 13 May until the conclusion of racing on Wednesday 24 May, 6 national riding days.

Race 5 BERKLEY STUD CHAMPAGNE STAKES 1200m

ILLICIT DREAMS (T Newman) - Began awkwardly making contact with CU CHULAINN.

CU CHULAINN (W Pinn) - Contacted at the start. Was inclined to lay outwards under pressure in the straight then becoming awkwardly placed near the heels of ILLICIT DREAMS which lay in just short of the finish resulting in CU CHULAINN being checked.

PENVOSE LAD (K Chowdhoory) - Jumped away awkwardly shifting outwards abruptly crowding CLASSY MISS. When over racing shortly after the start shifted outwards to avoid the heels of MOTIONTIME passing the 1000 metres making contact with SEMPER SUPRA, with those two runners then continuing to come together on a number of occasions.

CLASSY MISS (D Montes de Oca) - Crowded then contacted at the start losing ground. Raced greenly throughout.

SEMPER SUPRA (B Murray) - Contacted at the start. Contacted by PENVOSE LAD passing the 1000 metres with those two runners continuing to come together on a number of occasions. Checked near the 450 metres. Received post-race veterinary attention for minor lacerations to the left front pastern and fetlock.

MOGUL (K Williams) - Began awkwardly losing ground.

MOTIONTIME (C Barnes) - Lost the off-side front plate during the running.

T Comignaghi (GET FUNKY) - Admitted a charge of careless riding in that she permitted her mount GET FUNKY to shift outwards near the 450 metres when not sufficiently clear of SEMPER SUPRA which was checked. After considering submissions the Adjudicative Committee imposed a suspension of T Comignaghi's licence to ride in races from the conclusion of racing on Sunday 14 May until the conclusion of racing on Wednesday 24 May, 5 national riding days.

Race 6 JANET FRANCIS 1200m

TADITA (T Comignaghi) - Began awkwardly losing ground.

MAKABAR (D Montes de Oca) - Slow to begin and was then crowded shortly after the start.

DIVINE DIVE (K Mudhoo) - Began awkwardly.

BENAUD (W Pinn) - Slow to begin. Held up for the majority of the final straight.

EXPRESS COUP (K Chowdhoory) - Began awkwardly losing ground. Raced wide throughout.

GOLDEN HARVEST (Y Coonee) - Began awkwardly losing ground. Had difficulty obtaining clear running in the straight until near the 200 metres. Rider dropped his whip near the 250 metres.

LA BELLA NERA (G Jogoo) - Shifted outwards shortly after the start crowding RUSSIAN FABLE.

RUSSIAN FABLE (T Newman) - Crowded at the start losing ground.

SO NATURAL (Y Atchamah) - Slow to begin. Raced wide throughout.

SACRED GIANT (K Williams) - When questioned regarding performance, the rider advised that after travelling well during the early and middle stages the gelding had come to the end of its run over the concluding stages and would derive benefit from today's race resuming from a spell.

Race 7 DAPHNE BANNAN MEMORIAL GREAT EASTER STAKES 1400m

FIVE PRINCES (R Beeharry) - Returned to the enclosure during the preliminaries due to a stirrup iron coming undone and requiring attention. As a result the race ran two minutes late.

OKAY PAL (W Pinn) - Slow away.

VEGAS STRIP (T Newman) - Steadied shortly after the start.

OUR ECHO (T Moseley) - Raced three wide without cover.

D Montes de Oca (EMANON) - Admitted a charge of careless riding in that he permitted his mount EMANON to shift outwards passing the 350 metres when not sufficiently clear of OKAY PAL which was checked and dictated outwards onto ROYCE ROCA which was also checked. After considering submissions the Adjudicative Committee imposed a suspension of D Montes de Oca's licence to ride in races from the conclusion of racing on Wednesday 10 May until the conclusion of racing on Saturday 20 May, 7 national riding days.

Race 8 NORWOOD FARM MACHINERY 1600m

THE MOTIVATOR (D Tait) - Dropped its head at the start and began awkwardly losing ground.

HIGHLAND FLING (K Mudhoo) - Slow to begin.

KOTIRO TERE (T Newman) - Slow to begin. Rider reported that the mare had hung outwards throughout the race.

SANTISSIMA (L Callaway) - Began awkwardly making contact with ROYAL VALOUR becoming unbalanced, then when recovering was briefly steadied to avoid the heels of POWERFUL MOSS which was shifting inwards abruptly when not fully clear.

ROYAL VALOUR (T Moseley) - Contacted at the start.

JAY BEE GEE (M Hudson) - Crowded to the outside of SANTISSIMA shortly after the start losing ground. Raced wide throughout. When questioned regarding performance, the rider advised that after suffering interference at the start the gelding had got further back than intended and had been unable to recover.

ANNELIESE (C Campbell) - Steadied to avoid heels passing the 1400 metres. Shifted inwards abruptly after being struck with the whip near the 300 metres having to be straightened.

HEY SOUL SISTER (B Murray) - Raced three wide without cover.

KOTIRO TERE (T Newman) - Raced wide throughout.

BUGATTI (L Douglas) - Held up early in the straight.

AYREON (W Pinn) - Made contact with POWERFUL MOSS when improving into a tight run near the 300 metres.

D Montes de Oca (POWERFUL MOSS) - Issued with a warning after angling his mount POWERFUL MOSS inwards after jumping from a wide barrier when not fully clear of SANTISSIMA which was steadied to avoid heels.
