RACE COMMENTS

Race 1 PROVENANCE RESTAURANT MAIDEN 1400m

LONGBURN LAD (J Parkes) - Jumped away awkwardly.

BIDEYOURTIME (L Sutherland) - Slow away.

DASH OF RED (J Chung) - Lay inwards under pressure in the straight.

Race 2 HOULT CONTRACTORS 1400m

SWING LOW (M Singh) - Slow away. A post-race veterinary examination did not reveal any obvious abnormalities. Trainer T Mason was spoken to regarding the mare's poor performance and advised Stewards that SWING LOW has now been retired. Connections were also advised that if the mare was to be persevered with as a racing prospect, SWING LOW would be required to trial to the satisfaction of Stewards, and produce a vet clearance prior to that trial.

PLATINUM SIXTY SIX (W Pinn) - Slow away.

Race 3 MARTIN COLLINS NEW ZEALAND 1000m

MARMELLOS (K Asano) - Jumped away awkwardly and blundered.

FREE SPIRIT (T Taiaroa) - Slow away.

THATZ DAISY (M Hudson) - Lay outwards rounding the final turn.

Race 4 PARADIGM CIVIL LIMITED MAIDEN 1000m

ZOOM (T Taiaroa) - Jumped away awkwardly.

LINCOLN VALLEY (T Davies) - Raced three-wide without cover and was inclined to lay outwards rounding the bend.

LOOSE BELT (W Pinn) - When questioned regarding poor performance rider reported that the filly hung throughout. Connections were advised a warning has been placed against the filly's racing manners. Underwent a post-race veterinary examination which did not reveal any obvious abnormalities.

W Pinn (LOOSE BELT) - Issued with a warning under Rule 340 for the use of inappropriate language prior to returning to the enclosure.

Race 5 MANAWATU ITM 2140m

PLATINUM ASSAULT (W Pinn) - Over-raced in the early stages.

HARRY HARRISON (T Taiaroa) - Raced three-wide without cover for the majority of the race.

JUSTASKPERCY (L Sutherland) - Briefly steadied passing the 1400 metres when the pace eased.

MAZZINI (K Asano) - Raced wide from near the 1000 metres.

MATT CAIN (M Hudson) - Lay inwards under pressure in the straight.

K Hercock (WENEEDASHOCK) - Admitted a charge in that she struck her mount WENEEDASHOCK 6 times prior to the 100-metre mark, one time more than permitted. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 13 May until the conclusion of racing on Wednesday, 17 May, 2 national riding days and in addition imposed a fine of \$500.

Race 6 COURTESY FORD MANAWATU MAIDEN 1700m

LINCOLN THE FOX (M Hudson) - Raced keenly in the early stages when being restrained.

JAZZ IT UP (M Singh) - Raced wide without cover for the majority of the event.

RACCOURCI (W Pinn) - Lay inwards under pressure throughout the final straight.

STORMCAST (K Asano) - Shifted out abruptly approaching the 100 metres, having to be corrected by its rider.

SOUND TRACK (L Sutherland) - When questioned regarding the poor performance of SOUND TRACK, rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormalities.
