RACE COMMENT	S
Race 1	VAN DYK'S 1215

**RAMIREZ** (J Fawcett) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

**KEEPZ OCCURRING** (T Moodley) - Began awkwardly making contact with POUVOIR. Raced keenly through the middle stages.

**POUVOIR** (M Sanson) - Contacted leaving the barriers.

**SUPER WRAITH** (T Mitchell) - Improved onto heels passing the 100 metres having to shift inwards to improve.

**HUZZAH** (M McNab) - When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions and was of the opinion that it would benefit from a step up in distance.

Race 2SHERLOCK CONTRACTING 3YO 1400ACCIDENTAL TOURIST (M McNab) - Slow to begin.

CARIGNAN (R Elliot) - Steadied when placed in restricted room passing the 1200 metres.

**DUSTY ROAD** (K Hannan) - Steadied when placed in restricted room passing the 1200 metres. When questioned regarding the performance the rider advised that the gelding had not travelled comfortably throughout and had failed to respond when placed under pressure.

**KABUGEE** (W Kennedy) - Improved onto heels near the 500 metres having to be steadied.

STYLIANI BELLE (L Satherley) - Had some difficulty obtaining clear running entering the final straight.

**OUR TURN** (W Pinn) - When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**J Kamaruddin** (INCA BELLE) - Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of LEEDOX which was forced inwards onto STYLIANI BELLE which shifted in and away when racing greenly placing CARIGNAN and DUSTY ROAD in restricted room with both runners having to be steadied passing the 1200 metres.

## Race 3 ARAWA PARK HOTEL ROTORUA 1215

**RUBELLITE** (C Lammas) - Crowded shortly after the start having to be steadied when runners either side shifted ground.

**PRIORESS** (J Riddell) - Began awkwardly losing ground.

**SHE'S A SHOWOFF** (J Allen) - Began awkwardly. Underwent a post-race veterinary examination which revealed the mare to be 2/5 lame in the left hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

ELECTRIC TIME (M Hashizume) - Raced three wide without cover throughout.

**LUXURIANT** (M McNab) - When questioned regarding the performance the rider reported that the mare had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

CANNY MAN (A Lawson-Carroll) - Slow to begin.

CLEESE (K Hannan) - Hampered leaving the barriers.

SPORTING CHANCE (C Grylls) - Held up approaching the 250 metres having to shift inwards to obtain clear running.

#### Race 5 CAMPBELL INFRASTRUCTURE ROTORUA CUP 2200 (Listed Race)

FINEST WINE (L Satherley) - Began awkwardly losing ground.

LAVITA VISHVI (J Fawcett) - Began awkwardly losing ground.

**THE MIGHTY SPAR** (J Kamaruddin) - Bounded at the start losing ground. Raced keenly near the 1700 metres having to be steadied off heels.

FAR SITE (A Goindasamy) - Steadied off heels in the early stages.

**ENCHANTED ELLE** (M McNab) - At time of acceptances Stewards granted permission for M McNab to ride the mare 1 kg over at 54 kgs. Raced keenly through the middle stages. When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

**SULIMAN** (T Thornton) - Raced in restricted room approaching the 100 metres.

**SAINT ALICE** (W Kennedy) - When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

#### Race 6 DONNA FLEMING MEMORIAL 2200

GOODO JO (J Kamaruddin) – Bounded at the start losing ground.

CHASE 'N' GOLD (T Mitchell) - Slow to begin.

**KOOLASCUZ** (C Lammas) - Slow to begin. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**TAIKA** (T Newman) - Steadied off heels shortly after the start losing ground. Raced keenly in the early and middle stages.

PACHECO (J Riddell) - Over-raced in the early stages.

**RAAJOICES** (W Kennedy) - Came together with LATE TO THE PARTY approaching the 100 metres and again just prior to the winning post.

**LATE TO THE PARTY** (R Elliot) - Came together with RAAJOICES approaching the 100 metres and again just prior to the winning post.

**DAYDREAM BELIEVER** (M Hashizume) - Underwent a post-race veterinary examination including an endoscopic examination which did not reveal any abnormality.

**OSELETA** (W Pinn) - Slow to begin.

IMA ROCA BEE (J Fawcett) - Slow to begin.

SYNCHRONIZE (W Kennedy) - Began awkwardly losing ground. Steadied to avoid heels near the 1300 metres.

**SANIBEL** (R Elliot) - Steadied to avoid heels near the 1300 metres dropping back onto SYNCHRONIZE which also had to be steadied.

**SWEETJINEEN** (J Riddell) - Raced keenly when being restrained for a distance passing the 1200 metres.

**MISS CARTIER** (S Weatherley) - When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormality.

**M McNab** (SUMI) – Issued with a warning after permitting his mount to shift outwards when not sufficiently clear of SANIBEL which had to be steadied to avoid heels near the 1300 metres. Also inconvenienced as a result was SYNCHRONIZE.

## Race 8 ROTORUA CLUB 1400

THE MASTER (M Hashizume) - Slow to begin.

THE FIRST LINK (C Lammas) - Slow to begin. Steadied when placed in restricted room approaching the 100 metres.

BEAU ARCHERS ROSE (A Lawson-Carroll) - Slow to begin.

**STYLISH OFFICER** (L Satherley) - Over-raced through the early and middle stages causing the rider some difficulty.

**KIVA HAN** (T Moodley) - Apprentice rider T Moodley advised that the saddle slipped forward entering the final straight. Dislodged its rider on pulling up with T Moodley managing to maintain control of the mare.

NIGELLA LANE (M McNab) - Lay in when placed under pressure passing the 200 metres.

ABOVE THE CLOUDS (W Pinn) - Inconvenienced approaching the 200 metres when NIGELLA LANE lay in.
