RACE COMMENTS

Race 1 | **YARA FERTILISER MAIDEN 2100m**
I'M CHUCK (J Parkes) - Restrained to the rear from its wide draw.

OVERAGAIN (K Hannan) - Began awkwardly.

THE IMMIGRANT (W Kennedy) - Bumped at the start.

NONCHALANT (V Colgan) - Appeared to lose its footing rounding the bend near the 1600 metres and as a result ran wider.

KARA ZOR EL (B Grylls) - Over-raced in the early stages.

KAZADEROSE (T Mitchell) - Raced wide without cover throughout. Went off stride passing the 75 metres. Was dismounted on returning to scale and was attended to by the on-course veterinarian, which found the mare to have suffered a ruptured tendon to the left foreleg. Connections were advised that KAZADEROSE will require a veterinary clearance prior to racing next.

Following this race, a number of riders expressed concern regarding the safety of the track, in particular the footing rounding the bends near the 1600 metres and 1400 metres. A Track Safety Review Panel consisting of Stipendiary Stewards, Club Officials, Jockeys, Trainers and an NZTR Representative was convened and following a track inspection the remainder of the race meeting was abandoned due to the unsafe nature of the track.
