CARLOS (S Khetoo) - When questioned regarding performance, rider advised that the gelding failed to handle today's very testing track conditions.

T Jonker (THISTLE) - Issued with a warning after using her whip on a runner that was clearly winning.

## Race $3 \quad$ CROMBIE LOCKWOOD INSURANCE MAIDEN 1200m

DRAMATIC SOPRANO (Y Atchamah) - Slow away.

LOOK AT MEE (D Montes de Oca) - Slow away.

EYE SPY (K Rathoar) - Slow away. Hung outwards throughout, running wide rounding the final turn.
IN DISGUISE (T Jonker) - Raced three wide without cover.
PROPER TWELVE (B May) - When questioned regarding performance, rider advised that the gelding had failed to handle today's very testing track conditions.

## Race $4 \quad$ DUNEDIN CITY MOTORS 1200m

DARCI VINO (T Moseley) - Jumped away awkwardly then being further hampered when crowded. When questioned regarding performance, rider was of the opinion the gelding would benefit from the race after being fresh up today. A post-race veterinary examination did not reveal any obvious abnormality.

GRAND EXPRESS (K Kwo) - Jumped away awkwardly crowding DARCI VINO. Had to be steadied near the 1000 metres to avoid the heels of LUGANO'S ACE (L Callaway) which shifted inwards when not fully clear.

ARCEUS (S Khetoo) - Had to be steadied off the heels of GRAND EXPRESS near the 1000 metres. Lay in under pressure in the straight.

LUGANO'S ACE (L Callaway) - Commenced to over race when being restrained near the 1000 metres. Hampered passing the 200 metres when RUSSIAN FABLE (Y Atchamah) lay in after being struck with the whip. Apprentice $Y$ Atchamah was advised to exercise greater care.

LIPA MALA (K Chowdhoory) - Raced wide without cover.
ROBBIE BURNS (K Williams) - Lost the left front plate during the running.
RUSSIAN FABLE (Y Atchamah) - Rider reported the mare had not felt comfortable in today's track conditions.
TELEKINETIC (D Montes de Oca) - Required post-race veterinary attention, having to be treated after being found to be suffering the thumps.

L Callaway (LUGANO'S ACE) - Issued with a warning after permitting his mount LUGANO'S ACE to shift inwards when not fully clear of GRAND EXPRESS near the 1000 metres.

## Race 5 RUGBY AT THE RACES - SUNDAY 4 ${ }^{\text {TH }}$ JUNE MAIDEN 1400m

AUTHORITY (K Chowdhoory) - Slow away. Held up when disappointed for a run near the 300 metres, having to steady and shift outwards across heels to obtain clear running.

CLAIRE'S PAL (B May) - Briefly steadied when awkwardly placed near the 350 metres.
MININJAGIRL (L Callaway) - Lay in under pressure in the straight inconveniencing SO GRACEFUL near the 250 metres.
SO GRACEFUL (T Moseley) - Inconvenienced near the 250 metres when MININJAGIRL lay in.
MR GEE (K Williams) When questioned regarding performance, rider was of the opinion the gelding had not been suited by the holding nature of today's track conditions.

## Race 6 PROPERTY BROKERS 1400m

BELLA DORA (K Chowdhoory) - Slow to begin.
HALLELUJAH BROTHER (B May) - Jumped away awkwardly.

SURCHARGE (K Williams) - Crowded to the inside of HALLELUJAH BROTHER (B May) near the 1300 metres. B May was advised to exercise greater care. When questioned regarding performance rider advised that being unable to get to the lead today had been detrimental to the geldings chances.

STOP YELLING (G Jogoo) - Raced three wide without cover. Relegated from first placing following an inquiry after causing interference near the 50 metres.

BUDAI (S Khetoo) - Contacted and unbalanced near the 50 metres when STOP YELLING shifted outwards, being promoted from second placing following an inquiry.

Following the running of the race a protest was lodged by the Stipendiary Stewards alleging interference inside the final 100 metres by the first placed horse STOP YELLING (G Jogoo) to the second placed horse BUDAI (S Khetoo). After considering submissions the Adjudicator upheld the protest relegating STOP YELLING to second placing with final placings now being $1^{\text {st }}(2)$ BUDAI, $2^{\text {nd }}(3)$ STOP YELLING, $3^{\text {rd }}(9)$ PANDDE, $4^{\text {th }}(5)$ BACK HUT.

G Jogoo (STOP YELLING) - Admitted a charge of careless riding in that he permitted his mount STOP YELLING to shift outwards making contact causing interference to BUDAI near the 50 metres. After considering submissions the Adjudicator imposed a suspension of G Jogoo's licence to ride in races from the conclusion of racing on Sunday 4 June until the conclusion of racing on Sunday 11 June, 5 national riding days.
