<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>WANGANUI INSURANCE BROKERS 1340m</b>
<p><b>TRUSTWORTHY</b> (C Grylls) - Crowded shortly after the start when runners to its inside shifted ground.</p> <p><b>ROSIELICIOUS</b> (T Thornton) - Restrained behind runners to obtain cover shortly after the start. Held up rounding the final bend and was unable to obtain clear running until passing the 200 metres.</p> <p><b>BARRI HYDE</b> (A Bohorun) - Raced three-wide without cover throughout.</p> <p><b>HAKA BOOGIE</b> (L Sutherland) - Raced wide without cover throughout.</p> <p><b>COVENANT</b> (N Hailey) - Made contact with the running rail near the 1000 metres when racing keenly.</p> <p><b>SHOW D'OR</b> (J Parkes) - Commenced to give ground early in the final straight and was not persevered with for the remainder of the race. When questioned regarding performance rider advised the gelding failed to handle the Heavy track conditions, which he described as holding. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p><b>C Lindsay</b> (SHEZ SUPER) – Issued with a warning after she struck her mount SHEZ SUPER 6 times prior to the 100-metre mark with Stewards taking into account her clear recent record with regard to any breach of a whip rule.</p>	
<b>Race 2</b>	<b>LIQUORLAND WHANGANUI 1340m</b>
<p><b>KUSUDA</b> (C Barnes) - Crowded shortly after the start when runners either side shifted ground.</p> <p><b>TANZANITE ROSE</b> (C Butler) - Crowded shortly after the start, losing ground, when runners to the inside shifted outwards.</p> <p><b>BOLD BELLE</b> (K Hercock) - Raced keenly through the early and middle stages. Placed in restricted room, having to be steadied and was then forced on to FARAGLIONI, which was contacted when LIQUID LES (T Davies) shifted in when not fully clear, passing the 1200 metres. T Davies was advised to exercise care.</p> <p><b>FARAGLIONI</b> (J Parkes) - Contacted 1200 metres.</p> <p><b>LOVE STORM</b> (T Taiaroa ) - Lay outwards under pressure passing the 100 metres.</p> <p><b>ZOEY SATIN</b> (J Kamaruddin) - Lay outwards under pressure passing the 100 metres, dictating MAKE TIME wider on the track. J Kamaruddin was shown footage of his ride in the presence of the Apprentice Mentor and advised he is expected to straighten his mount sooner than he did on this occasion.</p> <p><b>ROCABABY</b> (A Bohorun) – Disappointed. Underwent a post-race veterinary examination which revealed the filly to be lame. Connections were advised ROCABABY will require a veterinary clearance prior to racing next.</p> <p><b>J Kamaruddin</b> (ZOEY SATIN) - Admitted a charge in that he struck his mount ZOEY SATIN 6 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.</p> <p><b>T Taiaroa</b> (LOVE STORM) - Admitted a charge in that she struck her mount LOVE STORM 6 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.</p>	
<b>Race 3</b>	<b>PROPERTY BROKERS 1340m</b>
<p><b>IMA ROCA BEE</b> (K Hercock) - Restrained behind runners to obtain cover shortly after the start.</p>	

**BELARDO BOY** (L Sutherland) - Raced keenly through the early and middle stages. When questioned regarding performance rider advised the gelding had raced keenly throughout the running but failed to respond when placed under pressure. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**KELLY COE** (J Chung) - Held up rounding the final bend.

**Race 4** | **JOHN TURKINGTON FORESTRY LTD CASTLETOWN STAKES 1200m (Listed Race)**

**MEDATSU** (J Kamaruddin) - Began awkwardly losing ground.

**CHARMER** (C Barnes) - Slow to begin then hampered, losing ground.

**PLATINUM DESIGNS** (J Riddell) - Began awkwardly losing ground.

**T Thornton** (DISCOVERY BAY) - Spoken to regarding her whip use in the home straight.

**Race 5** | **DAVE HOSKIN CARRIERS 3YO 1600m**

**DUPUG** (T Taiaroa) - Crowded at the start, losing ground.

**CARIGNAN** (L Sutherland) - Raced keenly through the early and middle stages. Held up early in the final straight having to shift inwards to obtain clear running passing the 200 metres.

**T Taiaroa** (DUPUG) - Shown footage of her ride in the presence of the Apprentice Mentor and reminded of her obligations to ride her mount out fully to the finish when she was observed to relax her ride over the concluding stages, holding fourth placing by a small margin.

**Race 6** | **AGC TRAINING STAKES WFA 1600m (Listed Race)**

**HACKSAW RIDGE** (T Thornton) - Raced keenly through the early and middle stages.

**TIMES TICKING** (J Riddell) - Was not persevered with in the final straight and finished some distance last. When questioned J Riddell advised the gelding travelled well in the early and middle stages but when placed under pressure approaching the home turn was unable to quicken. Stewards ordered a post-race veterinary examination which revealed the gelding to have suffered cardiac arrhythmia. Trainer A McGregor was advised that **TIMES TICKING** will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000-metres.

**Race 7** | **TECH RUGBY CENTENARY 1600m**

**J-L Lupton** (LOST CAUSE) - Trainer J-L Lupton was fined \$200 under Rule 534(2)(b) for failing to scratch her runner by the required time.

**ALWAYS MORE** (C Carmine) - Lunged at the gates, then removed from its barrier to undergo a pre-race veterinary examination and cleared to run.

**WAIAGARA** (T Taiaroa) - Slow to begin.

**WAY ABOVE** (L Sutherland) - Slow to begin.

**TRAMORE** (C Grylls) - Slow to begin.

**Race 8** | **THE GEORGE ROBINSON MEMORIAL FOXTON CUP 2040m**

**KAHU ROCK** (T Davies) - Jumped away awkwardly hampering **LEGALLY BLONDE**.

**LEGALLY BLONDE** (C Barnes) - Hampered at the start.

**LORD SPENCER** (T Thornton) - Raced wide throughout.

**THOMAS AQUINAS** (B Grylls) - When questioned regarding performance B Grylls advised THOMAS AQUINAS was never comfortable in the Heavy going.

**T Davies** (KAHU ROCK) - Admitted a charge in that she struck her mount KAHU ROCK 6 times prior to the 100-metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.
