### RACE COMMENTS

Race 1	CSI OWNERS & TRAINERS & TIMARU ARMY CADETS MAIDEN 1200m

**RAGHALLAIGH** (B May) - Declared a late scratching on veterinary advice at 2.08pm after rearing over several times on the way to the birdcage. Connections were advised that RAGHALLAIGH must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**PARKHILL BELLE** (R Mudhoo) - The start of this race was significantly delayed by 14 minutes after PARKHILL BELLE became fractious in its barrier dislodging the rider and becoming cast underneath the gates. After a delay PARKHILL BELLE was able to be freed being declared a late scratching at 2.21pm on veterinary advice. Connections were advised that PARKHILL BELLE must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next, with trainer J Blackadder indicating that the mare would not be persevered with as a racing proposition from his stable. After being freed the mare was noticeably lame requiring the horse ambulance to be deployed, with PARKHILL BELLE being lame in the left hind leg with superficial wounds to the cannon and stifle area, receiving the appropriate veterinary treatment. A veterinary clearance would be required if PARKHILL BELLE were to race again.

**MURDER SHE WROTE** (K Mudhoo) - Declared a late scratching at 2.21pm on veterinary advice after being kicked when in an adjacent barrier to PARKHILL BELLE.

**BROTHER WILL** (J Laking) - Jumped away awkwardly losing ground.

**TELLME YOU LOVEME** (C Barnes) - Slow away.

**CHIPPEWA** (R Beeharry) - Raced three wide without cover throughout.

**C Campbell** (SAVVY STAR) - Issued with a warning after he struck his mount SAVVY STAR six times prior to the 100 metre mark, with Stewards taking into account C Campbell's clear recent record with regard to a breach of this section of the whip rule.

**C Campbell** (SAVVY STAR) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicator imposed a fine of \$500.

**AORANGI ASSASSIN** (Y Atchamah) - Slow to begin.

**FIONNUALA** (K Kwo) - Slow to begin.

**SYMPATHIQUE** (G Jogoo) - Over raced and had to be restrained off heels passing the 1100 metres.

**GLOBAL STAR** (R Beeharry) - Over raced getting its head up on a number of occasions passing the 800 metres.

**COCKAHOOP** (L Callaway) - Raced keenly in the lead through the middle stages. When questioned regarding performance rider advised that after over racing the gelding had failed to finish the race off. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**TURF WAR** (T Moseley) - Had some difficulty obtaining clear running early in the final straight.

**CATALINA BAY** (D Montes de Oca) - Lay in under pressure in the final straight

**SENTIENT** (R Beeharry) - Slow to begin.

**PAPAGENA** (S Toolooa) - Slow to begin.

**EMANON** (D Montes de Oca) - Raced three wide without cover throughout. Raced greenly having to be straightened in the run home.

**SO NATURAL** (Y Atchamah) - Had to be steadied when improving onto the heels of **RADIANT ROSIE** passing the 600 metres.

**MAKE BELIEVE** (L Allpress) - Eased down by its rider in the final straight who advised that the mare had felt indifferent in its action. A post-race veterinary examination did not reveal any obvious abnormality.

The track was upgraded to Good 3 following Race 3.

**IT'S THE VIBE** (R Mudhoo) - Slow to begin.

**HIGH PINS** (L Callaway) - Raced three wide without cover throughout.

**MARCHING ON TAVI** (K Chowdhoo) - Held up rounding the final turn until the latter stages of the run home.

**MOKOPEKA** (C Campbell) - Held up rounding the final turn.

**MADISON ROSE** (T Moseley) - Held up rounding the final turn from the 600 metres until passing the 350 metres.

**RUBY SUNRISE** (K Williams) - When questioned regarding performance, rider advised that the mare had been caught wide and was of the opinion it may not have backed up from three previous runs during the month of December.

**BELLA DORA** (S Toolooa) - Slow to begin and trailed the field throughout. When questioned regarding performance rider advised that the mare had been outpaced throughout after resuming from a spell and is better suited to rain affected footing.

**ALTA BELLA** (R Mudhoo) - Slow to begin.

**IN VEGAS** (K Mudhoo) - Crowded leaving the barriers after being fractious.

**JUST MAYBE** (K Williams) - Over raced when being restrained to obtain cover in the early stages.

**JUST A PROMISS** (T Moseley) - Had a tendency to lay inwards throughout the race.

**WAIHORA MIST** (L Callaway) - Had to shift ground outwards across heels to obtain clear running near the 200 metres.

**ROYCE ROCA** (J Laking) - When asked to comment on the disappointing performance, rider could offer no tangible excuse.

**TAKE THE DEEL** (Y Atchamah) - Slow to begin.

**SERIOUSLY** (T Moseley) - Had to be firmly restrained when becoming awkwardly placed near the heels of CHOKITO near the 1400 metres.

**ELIZABETH ROSE** (K Chowdhury) - Over raced through the early and middle stages. When questioned regarding performance rider was unable to offer any excuse but felt the mare is better suited over more ground.

**ZADANE** (G Jogoo) - Raced wide without cover.

**HARBOURSIDE** (L Allpress) - Over raced when being restrained going into the turn near the 1300 metres, continuing to over race through the middle stages.

**CAMINO ROCOSO** (J Laking) - Held up rounding the final turn and in the early stages of the run home.

**EXCHANGE** (J Lowry) - Held up rounding the final turn and through the early and middle stages of the run home, only obtaining clear running near the 150 metres.

**MONZA CIRCUITO** (R Mudhoo) - Shifted ground outwards and had to be corrected a number of times in the run home.

**T Moseley** (SERIOUSLY) - Admitted a charge in that he struck his mount SERIOUSLY six times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

**KING OF THE DANCE** (R Beeharry) - Underwent a pre-race veterinary examination being declared a late scratching on veterinary advice at 5.28pm.

**EKSTREMEMISS** (G Jogoo) - Over raced through the middle stages getting its head up on a number of occasions.

**C Barnes** (RED RUFUS) - Admitted a charge in that she struck her mount RED RUFUS nine times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of C Barnes' licence to ride in races from the conclusion of racing on Tuesday 3 January until the conclusion of racing on Thursday 12 January, 7 national riding days, and in addition imposed a fine of \$250.
