#### GENERAL

**K Mudhoo** (IN VEGAS) - Admitted a breach of Rule 330(3)(c) in that he failed to make the contract weight for IN VEGAS in Race 9 and was replaced by L Sutherland due to no other senior rider being able to make the weight. K Mudhoo was fined \$200 under the Minor Infringement Schedule.

**K Mudhoo** (CLASSIC DIVA) - Replaced K Williams on CLASSIC DIVA in Race 10 due to K Williams' own horse JUST MAYBE gaining a start from the ballot on the morning of the races requiring her to ride that horse.

**J Lowry** – Replaced on his rides in Races 4 (PROPER TWELVE), 5 (ATLANTIC CITY) and 7 (MAYOR OR NORWOOD) after being unable to make the contract weight and was replaced as per Summary above. J Lowry was fined \$200 under the minor infringement schedule.

#### RACE COMMENTS

##### Race 1 | LOVERACING.NZ MAIDEN 1200m

**IT'S NOT UNUSUAL** (T Moseley) – Declared a late scratching at 12.05pm at the barriers on Veterinary advice after it got stuck under the gates when trying to burrow beneath them. All other runners in the gates were unloaded until IT'S NOT UNUSUAL was freed from the gates and returned to the birdcage. The connections were advised that IT'S NOT UNUSUAL must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. The start was accordingly delayed approximately 8 minutes. A post-race veterinary examination revealed only minor scrapes and abrasions.

**KIKIMORA** (K Chowdhoo) - Began awkwardly losing some ground. Raced in restricted room rounding the bend near the 500 metres. Held up in the run home only gaining clear racing room inside the final 100 metres.

**LILITH** (R Beeharry) - Slow to begin.

**ELANIA** (R Mudhoo) - Shifted inwards at the start crowding **FIRST LIEUTENANT** which was crowded losing ground. Steadied when placed in restricted room by **DECISION TIME** which shifted in before being straightened by its rider near the 1000 metres. Rider dropped his whip passing the 250 metres.

**FIRST LIEUTENANT** (J Laking) - Crowded at the start losing ground. Over raced in the early stages and near the 1000 metres had to be steadied away from heels.

**TAVANASIA** (B Rogerson) - Shifted inwards at the start crowding inside runners.

**NIGHT MIST** (C Barnes) - Crowded at the start.

**DELPHILLIUS** (L Allpress) - Crowded at the start.

**VAUDEVIRE** (K Mudhoo) - Had some trouble gaining clear racing room early in the run home.

**CAPITAL EXPENSE** (B Murray) - Gave ground over the concluding stages with the rider not persevering with the mare in the final straight. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection **CAPITAL EXPENSE** was confirmed to have bled. **CAPITAL EXPENSE** shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Due to the delay in the previous race, this race ran approximately 2 minutes late.

**RADIANT REACH** (K Williams) - Began awkwardly losing ground.

**TRADER** (C Campbell) - Bucked several times after jumping losing ground and then over raced through the early and middle stages. Over raced approaching the 600 metres having to be steadied off heels. The connections were advised that **TRADER** must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**MOTIONTIME** (R Mudhoo) - Over raced through the early stages.

<b>Race 3</b>	<b>RANGIORA EQUINE SERVICES 1200m</b>

**MR HASS** (C Barnes) - Shifted in at the start crowding **BEAU STITCH** and **SECRETXPRESS** which both lost some ground. Raced keenly through the early stages.

**BOOT IT SCOOTER** (J Kamaruddin) - Began awkwardly and was then crowded and contacted by **GLAMOUR** losing some ground. Held up by a tiring runner passing the 200 metres having to shift ground outwards to find clear racing.

**GLAMOUR** (J Fawcett) - Shifted out at the start crowding and contacting **BOOT IT SCOOTER**.

**TWIN SHOT** (B Rogerson) - Crowded at the start having to be steadied.

**BEAU STITCH** (B Murray) - Crowded at the start losing ground. Underwent a post-race veterinary examination which revealed superficial cuts to both stifles.

**SECRETXPRESS** (L Allpress) - Crowded at the start losing ground. Raced wide through the early to middle stages when leading. Rider reported that the filly had suffered a laceration during the running. A post- race veterinary examination revealed a small wound to the right hind coronary band.

**GNASHER** (T Moseley) - Not persevered with in the run home, with the rider reporting that the gelding had felt awkward in its action. A post-race veterinary inspection revealed a severe tendon injury to the left front leg. Connections were advised a veterinary clearance is required prior to racing again.

**SOMBRA DEAMOR** (A Mudhoo) - Steadied near the 100 metres when improving onto heels.

**H Kamaruddin** (MISS DUNSFORD) - Issued with a warning after using the whip in 2 consecutive strides on his mount MISS DUNSFORD passing the 150 metres.

**H Kamaruddin** (MISS DUNSFORD) - Admitted a charge of using the whip in 2 consecutive strides on his mount MISS DUNSFORD inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$150.

**H Kamaruddin** (MISS DUNSFORD) - Admitted a charge in that he struck his mount MISS DUNSFORD 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of H Kamaruddin's licence to ride in races from the conclusion of racing on Wednesday 15 February until the conclusion of racing on Saturday 25 February, 7 national riding days.

<b>Race 4</b>	<b>ALISTAIR GRAY MEMORIAL MAIDEN 1400m</b>

**VINDICATOR** (K Williams) - Slow to begin. Was obliged to improve wide passing the 500 metres.

**BROOKLYN DAN** (B Murray) - Began awkwardly.

**ROYAL VALOUR** (C Barnes) - Crowded at the start.

**KOTIRO TERE** (J Fawcett) - Raced three wide throughout.

**SIR ALBERT** (L Allpress) - Crowded and checked near the 1200 metres.

**SISTER SARAH** (L Callaway) - Crowded and checked near the 1100 metres.

**PROPER TWELVE** (J Laking) - Rider reported he had had a comfortable ride in front but when placed under pressure had failed to respond and was disappointing.

**MADAME GISELLE** (K Chowdhoo) - Had to be steadied off heels passing the 700 metres.

**LUCKY SIMON** (T Moseley) - Raced in restricted room near the 600 metres when MADAME GISELLE lay in before being straightened by its rider.

**K Kwo** (SASSMAN) - Admitted a charge of careless riding in that he permitted his mount SASSMAN to shift inwards when not sufficiently clear of SASSY CHOUXS which was dictated inwards onto SISTER SARAH which was checked near the 1100 metres. After considering submissions the Adjudicative Committee imposed a suspension of K Kwo's licence to ride in races from the conclusion of racing on Saturday 18 February until the conclusion of racing on Wednesday 1 March, 6 national riding days.

**A Mudhoo** (SASSY CHOUXS) - Admitted a charge of careless riding in that he permitted his mount SASSY CHOUXS to shift inwards when not sufficiently clear of SIR ALBERT which was crowded and checked passing the 1200 metres. After considering submissions the Adjudicative Committee imposed a suspension of A Mudhoo's licence to ride in races from the conclusion of racing on Saturday 11 February until the conclusion of racing on Sunday 19 February, 4 national riding days.

There was a delay in announcing the official placings due to the photo finish equipment failing.

The track was upgraded to Good 4 retrospective to Race 4.

<b>Race 5</b>	<b>FIONA STUART MEMORIAL MAIDEN 1600m</b>

**HEADS UP** (C Campbell) - Began awkwardly losing ground. Unable to obtain clear running throughout the run home.

**ECCELLENZA** (B Murray) - Slow to begin.

**VICKEZZROSE** (H Kamaruddin) - Began awkwardly losing considerable ground (5L). Bumped and unbalanced passing the 700 metres. Raced greenly passing the 400 metres. The connections were advised that VICKEZZROSE was under a barrier manners warning.

**IT'S THE VIBE** (D Montes de Oca) - Bucked for several strides shortly after the start. Improved quickly onto the heels of the runner in front passing the 700 nears having to be steadied away from heels shifting out abruptly. Connections were advised the gelding must barrier trial to stewards satisfaction before racing again.

**SEVEN ELEVEN** (K Chowdhury) - Made the bend near the 700 metres awkwardly shifting outwards to avoid heels.

**MOKOPEKA** (J Mudhoo) - Raced three wide without cover throughout.

**MCDREAMY** (L Sutherland) - Over raced through the middle stages.

**IT'S BELSANTO** (K Mudhoo) - Raced greenly throughout and near the 700 metres shifted out contacting VICKEZZROSE was briefly forced over extra ground.

**ATLANTIC CITY** (R Mudhoo) - Unable to obtain clear running until inside the final 100 metres when shifting outwards across heels.

**ZARAVELA** (C Barnes) - Crowded and checked near the 250 metres.

**TAIMATE ROSE** (K Williams) - Crowded and checked near the 250 metres.

**O'DUA** (B Rogerson) - Crowded and placed in restricted room near the 250 metres.

**K Mudhoo** (IT'S BELSANTO) - Issued with a warning after allowing his mount IT'S BELSANTO to shift outwards contacting VICKEZZROSE which was dictated wider on the track. When assessing this penalty Stewards took into account the racing manners of IT'S BELSANTO.

**J Mudhoo** (MOKOPEKA) - Admitted a charge of careless riding in that he permitted his mount MOKOPEKA to shift inwards when not sufficiently clear of ZARAVELA and TAIMATE ROSE which were crowded and checked near the 250 metres. After considering submissions the Adjudicative Committee imposed a suspension of J Mudhoo's licence to ride in races from the conclusion of racing on Saturday 11 February until the conclusion of racing on Thursday 23 February, 6 national riding days.

<b>Race 6</b>	<b>MICK AND MELBA MURFITT MEMORIAL 1100m</b>
<p><b>IHU</b> (B Rogerson) - Reared and dislodged its rider just prior to entering the barriers but was quickly remounted. Began awkwardly.</p> <p><b>OKAY PAL</b> (K Chowdhoo) - Very slow to begin (approximately 5L). The connections were advised that the gelding was under a barrier manners warning. Jostled with BURGUNDY ROSE for a distance passing the 400 metres.</p> <p><b>OUR GIRL GILLY</b> (J Fawcett) - Began awkwardly.</p> <p><b>KHIMAR WAR</b> (L Sutherland) - Had to be steadied off heels approaching the 600 metres. Held up over the concluding stages, and was denied a marginal run inside the final 50 metres going to the line not tested by its rider.</p> <p><b>BURGUNDY ROSE</b> (H Kamaruddin) - Unable to obtain clear running passing the 400 metres when shifting out and jostling with OKAY PAL, then shifted in to gain racing room near the 350 metres.</p> <p><b>K Chowdhoo</b> (OKAY PAL) - Admitted a charge in that he struck his mount OKAY PAL 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.</p>	
<b>Race 7</b>	<b>TIM DYER BAYLEYS CANTERBURY 2000m</b>
<p>The start of this race was officially delayed 3 minutes on TAB request.</p> <p><b>AQUATTACK</b> (B Rogerson) - Began awkwardly.</p> <p><b>OUR BOY RITCHIE</b> (K Mudhoo) - Raced wide through the early stages before improving forward to be handy to the leader. Under pressure passing the 500 metres and gave ground over the concluding stages finishing a distant last. A post race veterinary examination showed a slow recovery. Co trainer K Tyler advised he would be reassessing the racing future of the gelding.</p> <p><b>FETTERCAIRN</b> (L Allpress) - Raced wide in the early stages before improving wide to sit outside the leader. Inconvenienced passing the 250 metres. Rider reported that the gelding had felt indifferent in its action. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p><b>BRUNO MAGILE</b> (L Sutherland) - Raced wide without cover throughout.</p> <p><b>NOBLE KNIGHT</b> (K Chowdhoo) - Held up early in the run home and when shifting across heels passing the 250 metres briefly inconvenienced FETTERCAIRN.</p>	
<b>Race 8</b>	<b>C S STEVENS MEMORIAL BANKS PENINSULA CUP 1800m</b>
<p><b>BLUEY'S CHANCE</b> (T Jonker) - Began awkwardly losing ground. Raced keenly in the early to middle stages.</p> <p><b>EL BEE JACK</b> (C Barnes) - Began awkwardly losing ground.</p> <p><b>CAMINO ROCOSO</b> (J Laking) - Raced keenly in the early stages.</p> <p><b>TIMES TICKING</b> (J Lowry) - Shifted inwards over the concluding stages under pressure inconveniencing JEWEL OF PATCH near the 50 metres. J Lowry was advised to exercise greater care and straighten his mount earlier than he had on this occasion.</p>	
<b>Race 9</b>	<b>RURAL LIVESTOCK 1400m</b>

**KEEN TO RUN** (J Laking) - Declared a late scratching at the start at 4.45pm on Veterinary advice after being found to be Grade 2 lame in the left front leg. Connections were advised a veterinary clearance would be required prior to racing again.

**VULTURE STREET** (R Mudhoo) - Began awkwardly shifting out contacting **NAMIBIA MISS** with both runners losing ground. Over raced through the middle stages.

**NAMIBIA MISS** (K Williams) - Contacted at the start losing ground.

**DOC MARTYN** (L Callaway) - Raced four wide without cover through the early to middle stages.

**COME BACK TIGER** (T Jonker) - Raced keenly through the middle stages and wide for the majority of the race.

**WILD ROVER** (B Rogerson) - Raced wide without cover throughout.

**SEVEN TWENTY** (H Kamaruddin) - Crowded and checked passing the 1100 metres. Had some trouble obtaining clear racing early in the run home.

**HARBOURSIDE** (J Kamaruddin) - Lost both front plates during the running.

**J Fawcett** (I AM A ROCK) - Admitted a charge in that she permitted her mount I AM A ROCK to shift inwards when not fully clear of **TREYBON** which was dictated inwards onto **ARCHERFIELD** which was forced into the line of **SEVEN TWENTY** which was checked near the 1100 metres. After considering submissions the Adjudicative Committee imposed a suspension of J Fawcett's licence to ride in races from the conclusion of racing on Saturday 18 February until the conclusion of racing on Thursday 2 March, 7 national riding days.

**H Kamaruddin** (**SEVEN TWENTY**) - Admitted a charge of using the whip in 2 consecutive strides on his mount **SEVEN TWENTY** inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$300.

**H Kamaruddin** (**SEVEN TWENTY**) - Admitted a charge in that he struck his mount **SEVEN TWENTY** 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of H Kamaruddin's licence to ride in races from the conclusion of racing on Saturday 25 February until the conclusion of racing on Thursday 2 March, 2 national riding days and was fined \$500. As this was his 9<sup>th</sup> breach of the whip rule in a short time Stewards also advised H Kamaruddin that he is directed to meet with a NZTR Rider Skills Review Panel as per the provisions of Rule 343.

<b>Race 10</b>	<b>ODT SOUTHERN MILE QUALIFIER 1600m</b>

**ALTA BELLA** – Declared a late scratching at 4.46pm on veterinary advice after being injured at the home stable.

**BLUE SOLITAIRE** (G Saejorhor) - Began awkwardly. Rider advised after getting back in the field he had been unable to make any ground over the concluding stages when the riderless horse had interfered with runners in front of him.

**AWATANE** (L Allpress) - Slow into stride and then raced wide without cover throughout.

**TAIMATE DIVA** (R Mudhoo) - Clipped a heel and blundered dislodging the rider passing the 1400 metres. R Mudhoo was immediately attended to by St John Paramedics and transferred to hospital for further assessment.

**POVERTY BAY** (J Lowry) - Buffeted by **TAIMATE DIVA** after dislodging its rider passing the 1400 metres, with **TAKE THAT** also being hampered. Hampered by the riderless horse passing the 300 metres.

**TAKE THAT** (L Sutherland) - Hampered 1400 metres.

**DEMAND RESPECT** (J Laking) - Hampered when avoiding the fallen runner near the 1400 metres.

**DUSHKU** (J Kamaruddin) - Hampered when avoiding the fallen runner near the 1400 metres.

**JUST MAYBE** (K Williams) - Hampered by riderless horse passing the 1000 metres. Hampered again by the riderless horse passing the 300 metres.

**FLOAT** (A Mudhoo) - Over raced through the middle stages. Hampered when runners were dictated inwards by the riderless horse passing the 300 metres.

Stewards opened and adjourned an inquiry into the reason **TAIMATE DIVA** (R Mudhoo) clipped a heel and dislodged its rider passing the 1400 metres.
